We have performed audits of the accompanying financial statements of The Union League of Philadelphia Employee Savings & Retirement (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(c) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Note 1 – Description of plan

General

The following description of The Union League of Philadelphia Employee Savings & Retirement (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

The Plan is a defined contribution pension plan established on January 1, 1998. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan covers all employees of The Union League of Philadelphia (the “League”) (Plan Sponsor) and the Union League Legacy Foundation (the “Foundation”) referred to collectively as the “Employers,” who have completed one year of service and are age 18 or older. The Plan Administrator is responsible for oversight of the Plan and determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Contributions

Each year, participants may contribute up to 90% of their pre-tax compensation to the Plan, subject to certain limitations set under the Internal Revenue Code. After-tax Roth contributions may be made to the Plan. New employees are automatically enrolled into the Plan at a 3% salary deferral amount once they meet the above eligibility requirements. The automatic deferral amount will increase by 1% of compensation up to a maximum of 10% of compensation beginning each January subsequent to the period of eligibility.

The Employers make a safe harbor contribution of 3% of each eligible participant’s compensation to the Plan. The Employers may also make discretionary matching contributions of up to 4% of the participant’s compensation to the Plan. For 2024 and 2023, the Employers elected to match 3% of the participant’s compensation. In addition, the Employers may also make a discretionary profit-sharing contribution. For 2024 and 2023, the Employers elected not to make any profit-sharing contributions.

The Plan allows for rollover contributions from other qualified plans and catch-up contributions.

Participant accounts

Each participant’s account is credited with the (a) the participant’s contribution, (b) allocations of the Employers’ contributions, and (c) Plan earnings, net of an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment options

Each participant may direct the investment of his/her account into various investment options offered by the Plan and may change their investment options at any time, subject to the terms of the funding vehicles. The Club may choose from various investment options under the terms of the contract as further outlined in Plan document.

Note 1 – Description of plan (continued)

Vesting

Participants are immediately vested in their contributions and any safe harbor contributions plus actual earnings thereon. The Employers' matching contributions and their earnings are 100% vested after three years of service.

Forfeitures

As of December 31, 2024, forfeited non-vested accounts totaled \$14,765. Forfeitures may be used to reduce future employer contributions and/or to pay administrative expenses of the Plan, as determined by the Plan, at its sole discretion. For the year ended December 31, 2024 forfeitures totaling \$58,925 were used to reduce employer contributions.

Participant notes receivable

Under the terms of the Plan, participants are not permitted to borrow from their accounts.

Payment of benefits

On termination of service due to death, disability or retirement, a participant or beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or periodic payments as further outlined in the Plan document. For termination of services due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. If a participant terminates employment and the participant's account balance was less than \$5,000, the Plan Administrator will authorize the benefit payment without the participant's consent. In addition, participants may elect in-service withdrawals of their elective deferral account balances after reaching age 59-1/2. Participants may also elect in-service withdrawals of their elective deferral account balances in their annuity contracts in the case of a hardship. Rollover account balances may be withdrawn at any time, provided the rollover contributions have been properly segregated. Minimum required distributions for participants also apply per Internal Revenue Service ("IRS") regulations.

Plan termination

Although it has not expressed any intent to do so, the Employers have the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their account.

Note 2 – Summary of significant accounting policies

Basis of accounting

The Plan's financial statements are prepared using the accrual basis of accounting, except for benefits that are recorded when paid.

Investment valuation and income recognition

The Plan's investments are stated at fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividends are recorded when earned. Realized gains and losses on the sale of securities are computed on each individual security.

The aggregate of (a) the net unrealized appreciation (depreciation) in the fair value of investments for the year, and (b) the net gains or losses on disposition of investments during the year is reflected as net appreciation in the fair value of investments for the year.

Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Fair value measurements

The Plan reports its investments under the Financial Accounting Standards Board fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy under this standard are as follows:

- Level 1 – Unadjusted quoted prices in active markets for identical assets.
- Level 2 – Quoted prices for identical assets in markets that are not active, quoted prices for similar assets in active markets, inputs other than quoted market prices, and inputs derived principally from observable market data.
- Level 3 – Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The asset’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value as of December 31, 2024:

Registered investment companies (mutual funds)

The Plan’s investments in mutual funds are stated at fair value based on the quoted market prices of the underlying securities within each fund. These funds are required to publish their daily Net Asset Value (“NAV”) and to transact at that price.

Fair value measurements (continued)

Common/collective trusts

The NAV of the common/collective trusts are determined at the close of each business day based on the fair value of the respective investments. The NAV per unit is calculated as of the close of each business day. The NAV per unit is computed by dividing the total contract value of the assets of the fund, less its liabilities, by the total number of units outstanding at the time of such computation (“unit value”). These funds are measured at NAV as a readily determinable fair value. Investment income earned is reinvested in the fund and included in the determination of unit values. The value of each participant’s account on any date is determined by multiplying the number of units held by the “unit value” at the close of the business day. The fund provides for daily redemptions by the Plan at reported fair value with no advance notice requirements. The funds are classified as Level 2 in the fair value hierarchy due to their ability to meet the NAV segregation and tracking requirements of the fair value hierarchy.

Contributions

Contributions from participants are recorded as they are withheld from the participants’ wages. Contributions from the Employers are recorded in the period in which the related participant contributions are due.

Payment of benefits

Benefit payments to participants or their beneficiaries are recorded when paid.

Administrative expenses

Certain expenses for maintaining the Plan are paid by the Plan, unless otherwise paid by the Employers. Expenses that are paid by the Employers are excluded from these financial statements. Fees related to the administration of participants’ accounts are included in administrative expenses. Investment and related expenses are included in net appreciation of fair value of investments.

Certain administrative functions are performed by officers or employees of the League. No such officer or employee receives compensation from the Plan.

Risks and uncertainties

The Plan investments are exposed to various risks such as interest rate, market, credit and liquidity risks. Due to the level of risk associated with investments, it is reasonably possible that changes in the values of these investments will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits as of December 31, 2024. The Plan’s investments are not insured or protected by the Pension Benefit Guaranty Corporation, or any other governmental agency, accordingly, the Plan is subject to the normal investment risks associated with similar types of investments.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements. Actual results could differ from these estimates.

Subsequent events

The Plan has evaluated events and transactions for potential recognition or disclosure through September 29, 2025, which is the date of the financial statements were available to be issued.

Note 3 – Information certified by the Plan’s Custodian

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, the Custodian of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and December 31, 2023, and the Supplemental Schedule H, Part IV, Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2024 and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

Note 4 – Party-in-interest transactions

Plan investments are managed by Reliance Trust Company. Reliance Trust Company is the Custodian as defined by the Plan, and, therefore, transactions with the Custodian qualify as party-in-interest.

Other fees related to the investment advisory services and administrative services of the Plan were paid by the Plan or the Employers. These transactions qualify as party-in-interest transactions.

Note 5 – Tax status

The Plan utilizes a prototype plan document which the Internal Revenue Service (the “IRS”) has opined and informed the prototype plan sponsor that the prototype document is in compliance with Section 401 of the Internal Revenue Code (the “Code”). The prototype plan has obtained its latest determination letter dated October 6, 2020, in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.
