## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Mid-America Transplant Services Savings and Investment Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is accurate and complete to the best of their knowledge and belief.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### Note 1. Plan Description

The following description of the Mid-America Transplant Services Savings and Investment Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions, which is available from the Plan Administrator.

**General:** The Plan was established on July 1, 1986, as a defined contribution plan covering all eligible employees of Mid-America Transplant (the Organization). Under the Plan, all employees are eligible except tissue and eye technician employees, nurse advocates, organ preservationist technicians and employees being represented by a collective bargaining unit that has bargained in good faith the subject of retirement benefits with Mid-America Transplant. Employees become eligible to participate in elective deferrals and the Organization's matching contribution under the Plan when they begin service, and are entered into the Plan the first day of the month on or next following date requirements are met. For the Organization's qualified nonelective contribution and discretionary contribution, employees become eligible to participate when they have completed one year of eligible service. For eligible service, a year of service requires a minimum of 1,000 hours during a one-year period. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Finance Committee is responsible for oversight of the Plan. The Finance Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

**Contributions:** Participants may contribute a percentage of their compensation, on a pretax or Roth basis, not to exceed applicable calendar year limits under section 402(g)(1) of the Internal Revenue Code (IRC), which is \$23,000 for 2024. Participants age 50 and older may elect an additional catch-up deferral of \$7,500 for 2024. Rollover contributions to participants from another qualified plan are permitted as defined in the Plan. The Organization will make a matching contribution equal to 100% of a participant's first 5% of elective deferral contribution, including catch-up deferrals, up to 5% of compensation. Matching contributions are calculated based on the participants' pay and elective deferrals for the payroll period. The Organization's matching contributions were \$935,537 for the year ended December 31, 2024.

The Organization provides a bonus to all eligible participants in an amount equal to 3% of eligible compensation, which participants may defer into the Plan as a participant contribution on a pretax basis or into a 529 plan. The Organization's contribution on behalf of the participant was \$425,238 for the year ended December 31, 2024, which is included in participant contributions on the statement of changes in net assets available for benefits.

The Organization may also make a discretionary contribution each plan year. To be eligible for the discretionary contribution, participants must complete one year of eligible service, work a minimum of 500 hours during the plan year and be employed by the Organization on the last day of the plan year. The discretionary contribution will be allocated to eligible participants based on 6% of the participant's eligible compensation that is not over the Social Security wage base (\$168,600 for 2024) and 11.7% of eligible compensation over the Social Security base up to the compensation limit (\$345,000 for 2024). The discretionary contribution for the year ended December 31, 2024, was \$903,231.

Participants direct the investment of contributions into various investment options offered by the Plan. At December 31, 2024 and 2023, these options include a common/collective trust fund, various mutual funds and certificates of deposit.

#### Note 1. Plan Description (Continued)

**Participant accounts:** Each participant's account is credited with the participant's contribution, the Organization's contributions and Plan earnings and charged with an allocation of administrative expenses. Allocations of Plan earnings are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their voluntary contributions and the Organization's qualified nonelective contributions plus actual earnings thereon. Vesting in the Organization's matching and discretionary contributions in their account plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after five years of credited service. A year of credited service for vesting purposes is any plan year during which a participant works at least 1,000 hours. Upon reaching normal retirement age, disability or death, a participant becomes 100% vested. The nonvested balance is forfeited upon the earlier of a five-year break in service or upon distribution of a participant's vested account balance.

**Payment of benefits:** Retirement benefits are normally payable upon reaching the normal retirement age of 65. Retirement benefits are based on the accumulated value in the participant's account. Upon termination of service due to death, disability, retirement or other termination of employment, the amount the participant is entitled will be paid to the participant or, in the case of death, to the participant's beneficiary, in a cash lump sum or an annuity, at the participant's option. A participant may also elect to receive a distribution upon attaining age 59½ while continuing to work. Hardship withdrawals are also permitted under circumstances provided by the Plan.

**Notes receivable from participants:** Participants may borrow from their fund accounts up to a maximum of 50% of the vested account balance or \$50,000, whichever is less. The minimum note receivable amount is \$1,000, and the note receivable terms range from one to five years, unless the note receivable is for a principal residence. Notes receivable are secured by the balance in the participant's account and bear interest that is commensurate with the prime rate and is paid ratably at least quarterly. The interest rate range for all notes receivable active at year-end was 3.25% to 8.75%. A participant may have only one notes receivable outstanding at any given time. Principal and interest are paid ratably through payroll deductions.

**Forfeited accounts:** At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$109,168 and \$84,840, respectively. Forfeitures may be used to restore participant accounts for prior forfeitures, to pay Plan expenses, or to reduce employer contributions as detailed in the nonstandardized prototype plan. During the year ended December 31, 2024, forfeitures totaling \$85,650 were used to reduce employer contributions.

#### Note 2. Summary of Significant Accounting Policies

A summary of the Plan's significant accounting policies is as follows:

**Basis of accounting:** The Plan prepares its financial statements on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Contributions:** Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which participant compensation is earned.

**Allowance for credit losses:** The measurement of expected credit losses under the current expected credit loss (CECL) methodology is applicable to financial assets measured at amortized cost, which include employer and participant contributions receivable. An allowance for credit losses under the CECL methodology is determined using the loss-rate approach and measured on a collective (pool) basis when similar risk characteristics exist. Where financial instruments do not share risk characteristics, they are evaluated on an individual basis. The CECL allowance is based on relevant available information, from internal and external sources, related to past events, current conditions and reasonable supportable forecasts. Management recorded no allowance for credit losses as of December 31, 2024 and 2023, as all amounts were determined to be fully collectable.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Finance Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Payment of benefits:** Benefit payments to participants are recorded when paid.

**Expenses:** Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

**Notes receivable from participants:** Notes receivable from participants are stated at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Notes receivable from participants are classified as an investment asset for Form 5500 reporting purposes and, accordingly, are included as an investment in supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year).

The trustees also certified to the completeness and accuracy of \$2,910,816 of net appreciation in fair value of investments, \$2,069,751 of dividends and interest related to the aforementioned investments and \$22,869 of interest income on notes receivable from participants for the year ended December 31, 2024.

#### **Note 4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

#### Note 4. Fair Value Measurements (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

**Mutual funds:** Mutual funds are valued at a daily calculated net asset value (NAV) and are traded at a quoted price through the National Securities Clearing Corporation.

**Certificates of deposit:** Certificates of deposit are valued at cost plus accrued interest, which approximates fair value.

**Common/collective trust:** The common/collective trust fund is valued at the NAV of units of the common/collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur immediately. Investments measured following the NAV practical expedient are classified outside of the valuation hierarchy.

#### Note 4. Fair Value Measurements (Continued)

**Changes in fair value levels:** To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

Management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

#### Note 5. Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the IRC. The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 6. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants would become 100% vested in their accounts.

#### Note 7. Party-In-Interest and Related-Party Transactions

The Plan invests in a common/collective trust fund managed by the trustee; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Transamerica Retirement Solutions, Fidelity Investments Institutional, and Marsh McLennan Agency, parties in interest, for investment management and administrative services amounted to \$171,456 for the year ended December 31, 2024, which is included on the statement of changes in net assets available for benefits.

#### **Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.

#### **Note 9. Subsequent Events**

The Plan Administrator has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.
