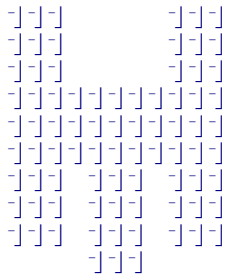

INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator, and Participants of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of BrandStar 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to the bank or similar institution or insurance carrier in accordance with 26 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section:

- the amounts and disclosures in the 2024 financial statements referenced above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the 2024 financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about BrandStar 401(k) Retirement Plan's ability to continue as a going concern for one year after the financial statements are available to be issued.

1. **Description of Plan**

The following description of the BrandStar 401(k) Retirement Plan, (the "Plan") is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

- a) *General* – The Plan is a defined contribution plan covering all employees of O2 Media, Inc and its related controlled companies. (collectively the "Company"), except members of a collective bargaining agreement, leased employees, non-resident aliens, and interns, who have completed sixty days of service and attained the age of eighteen. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was formed on January 1, 2019, and most recently restated effective December 1, 2021, as required by the Internal Revenue Service's (IRS) restatement cycle. It was most recently amended effective December 1, 2024, to add additional controlled companies to the Plan.
- b) *Plan Administration* – The Plan is administered by management of the Company and by Levy and Associates, a third-party administrator (TPA). The Plan's trustees are owners and/or employees of the Company. John Hancock Life Insurance Company (USA) (John Hancock), serves as the Plan's custodian, and servicer as of December 31, 2024 and 2023.
- c) *Contributions* – Each year, participants may contribute up to 75% of pretax annual compensation, as defined in the Plan, subject to the maximum dollar limitations established by the Internal Revenue Code. The Plan provides for automatic enrollment of all newly eligible participants at a deferral of 5% of eligible wages unless the participant specifically elects to defer a different percentage or not contribute at all. Participants may also contribute amounts representing distributions from other qualified plans. The Company makes a discretionary matching contribution of 50% of each participant's salary deferrals that do not exceed 6% of the participants' compensation. In addition, the Company may also make profit sharing contributions. There were no profit sharing contributions made by the Company during the year ended December 31, 2024.
- d) *Participant Accounts* – Each participant's account is credited with participant's contributions, and allocations of the Company's contribution, Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- e) *Vesting* – Participants are immediately vested in their salary deferral contributions, and rollovers, plus actual earnings thereon. Participants' vesting in the Company's matching and discretionary contribution portion of their accounts, plus actual earnings thereon, is based on years of continuous service. A participant becomes 20% vested after one year of credited service and continues to vest in increments of 20% until 100% vested after 5 years of credited service, or immediately upon death or disability.
- f) *Investment Options* – Upon enrollment in the Plan, a participant may direct their contributions to any of the investment options offered in the John Hancock program as determined by the Plan Administrator. Participants may change their investment options via phone or Internet access to John Hancock at any time.

1. **Description of Plan, continued**

- g) *Payment of Benefits* – Upon retirement, disability, death, or termination of service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In-service distributions are permitted anytime from rollover contributions, and for employees attaining age 59½. In-service distributions are also available for a qualifying financial hardship from participant deferral accounts only.
- h) *Forfeitures* – Upon termination of employment, the non-vested portion of a participant's account is forfeited. Forfeitures may be used to reduce employer contributions or pay plan administrative fees. During the year ended December 31, 2024, \$22,141 was forfeited by participants and \$25,758 was used to reduce employer contributions and pay administrative fees. As of December 31, 2024 and 2023, there were \$4,060 and \$7,677, respectively, of forfeitures available at year-end to apply to future employer contributions or plan administrative fees.
- i) *Administrative Expenses* – Individual participants pay for loan and distribution fees, and investment management fees. The Plan sponsor pays for certain other costs of plan administration.
- j) *Participant Notes Receivable* – Participants may borrow from their funds a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their individual vested account balance. Loan terms range from 1 year to 5 years or up to 25 years for the purchase of a primary residence. The loans bear interest at a reasonable rate as determined by the Plan administrator at the time the loan was taken (currently Prime Rate plus 1%). The interest rates on participant notes receivable as December 31, 2024 and 2023 ranged from 4.25% to 9.50%. Principal and interest are scheduled to be paid ratably through payroll deductions. Loans to participants are reported at their unpaid principal balances plus any accrued interest. The loan balances are secured by the participants' investment accounts, therefore, no allowance for uncollectible loans was deemed necessary. For purposes of presentation on the schedule of assets held for investment purposes, the participants notes receivable are presented as part of the investments for the Form 5500 and are referred to as participant loans.

2. **Summary of Significant Accounting Policies**

The following are the significant accounting policies followed by the Plan:

- a) *Basis of Accounting* – The accompanying financial statements are prepared on the accrual basis of accounting.
- b) *Use of Estimates* – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

2. **Summary of Significant Accounting Policies, continued**

- c) *Valuation of Investments and Income Recognition* – Investment in registered investment companies (i.e., mutual funds held in pooled separate accounts) are valued at quoted market prices, if available, of a national securities exchange on the last business day of the year. Investment options that do not have readily available market quotations are valued according to quotations from the custodian. Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date.
- d) *Payment of Benefits* – Benefits are recorded when paid.
- e) *Plan Risk and Uncertainties* – The Plan and the Plan assets are sensitive to economic pressures prevalent in the investment market. The pressures primarily stem from interest rates, market and credit risk and their effect on bond rates, mortgage rates, the value of real estate, stock prices, and the overall stability of the market. Certain Plan investments are shares of pooled separate accounts managed by the custodian. Change in the custodian's management may affect operating results of the funds adversely. Additionally, the financial position of the Plan Sponsor, O2 Media, Inc., may have a significant impact on the Plan. Specifically, the ability of the Plan Sponsor to continue to make contributions under the program and/or the stability of the Plan Sponsor's operations. Other external factors which may affect the Plan, and the Plan assets include legislation or regulations established by the Internal Revenue Service, Employee Retirement Income Security Act of 1974, and/or Department of Labor (DOL).

3. **Fair Value Measurements**

Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) 820-10, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

3. **Fair Value Measurements, continued**

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following descriptions indicate the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024.

- a) *Noninterest-bearing cash* – The carrying amount reported approximates fair value due to the stable \$1 value.
- b) *Mutual funds held in separate pooled accounts* – Investment portfolio of mutual fund shares that are valued at quoted marked prices of a national securities exchange on the last business day of the year of shares held by the Plan at year end.

4. Information Certified by the Plan’s Custodian

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodian, John Hancock, has certified that the data included in the accompanying financial statements and supplemental schedules are complete and accurate. The Plan’s independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

5. Related Party Transactions

Certain Plan investments include shares of pooled separate accounts managed by John Hancock. John Hancock is the investment manager and custodian as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions. However, they are not considered prohibited transactions in accordance with appropriate ERISA exceptions.

6. Tax Status

The Company is utilizing a Non-Standardized Pre-Approved Profit Sharing Plan document offered by CCH Incorporated, dba ftwilliam.com and provided by its Plan administrator, John Hancock. The Plan reflects the implementation of the recent legislative changes in the regulations governing qualified tax-deferred arrangements via the IRS’s Cycle 3 restatement. The restated Plan received an opinion letter from the Internal Revenue Service dated June 30, 2020. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believes that the Plan is qualified and is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan’s financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, and accrued benefits, to the extent funded, or required to be funded, must be distributed to the participants.

8. Delinquent Participant Contributions

For the year ended December 31, 2024, the Company did not appear to remit certain participant contributions to the Plan on a timely basis as defined by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Untimely remittances identified on the schedule of delinquent participant contributions which totaled \$200,320, were corrected outside of the Department of Labor Voluntary Fiduciary Correction Program (VFCP) in 2025. The Company has compensated the participants for the lost earnings resulting from the delay in contributions.

9. Subsequent Events

Plan management has evaluated subsequent events through October 13, 2025, the date on which the financial statements were available to be issued and determined there was one event to disclose in these financial statements. The Plan was amended effective February 1, 2025 to change the vesting schedule for employer matching and non-elective contributions to 100% vested after 1 year of service.
