Opinion

NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF PLAN

The J.F. Allen Company Health & Welfare Plan provides health insurance, life insurance benefits, and supplemental benefits through HRA (Health Reimbursement Account) and FSA (Flexible Spending Account) options to assist employees with increases in premiums and deductibles.

The following description of J. F. Allen Company Health & Welfare Plan (the Plan) provides only general information. Participants should refer to the Plan handbook for a complete description of the Plan's provisions

General

The Plan provides health, life insurance and other benefits for eligible employees of J. F. Allen Company, Alcon Trucking Company, Performance Paving, LLC, and Keystone Stabilization, LLC (Controlled Group of Employers). The Plan pays health benefits directly through a related trust. The Plan covers only active employees and others that qualify for "COBRA" coverage. The Plan is subject to the provisions of the Employment Retirement Income Security Act of 1974, as amended (ERISA).

Benefits

Health benefits (medical, hospital, surgical, major medical) and prescription drug coverage are provided to participants and their beneficiaries and covered dependents. Health claims of participants and their dependents are processed by an independent benefit payment company. Claims are funded by payments made to the Plan trust by the Company. Participants and providers can submit claims for one year from the date of service.

Life insurance coverage of \$25,000 per employee is fully provided through an insurance company. All employees are covered regardless of their election to participate in the medical benefits portion of the plan.

The HRA provides health benefits not covered by the base medical plan.

The FSA is available to pay for expenses not covered by the plans.

Insured Benefits

The Plan fully insures the life insurance benefits (basic and optional supplemental) and accidental death or dismemberment (basic). The Company purchases annual insurance contracts for these insured benefits. Premiums for basic life insurance and basic accidental death and dismemberment insurance programs are paid to the insurance company from the general assets of the Company.

NOTE 1 - DESCRIPTION OF PLAN (continued)

Stop Loss Coverage

The Plan has a “stop loss” insurance policy that provides payments whenever the cost for an individual exceeds \$60,000 with \$123,000 aggregating group specific coverage for the years ended December 31, 2024 and 2023, respectively. For the years ended December 31, 2024 and 2023 there were \$75,583 and \$313,694 “stop loss” claims, respectively. Death claims are processed directly by an insurance company. The responsibility for payment to participants and providers is retained by the Plan.

Self-insured Benefits

All other Plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan’s third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by either the Plan’s VEBA trust or the general assets of the Company. Despite the Plan’s utilization of third party claim’s processors, ultimately responsibility for payments to providers and participants is retained by the Plan. The Plan utilized a pharmacy benefit manager (PBM) which periodically makes refunds to the plan based on the Plan’s actual utilization pattern of specific drugs.

The Plan has a health reimbursement arrangement (HRA) that is funded solely through Company contributions. The HRA allows eligible participants to be reimbursed tax free for qualified medical expenses subject to a specified ceiling. Amounts remaining at the end of the year can generally be carried over to the next year. The employer is not permitted to refund any part of the balance to the employee; the account cannot be used for anything other than reimbursements for qualified medical expenses; and remaining amounts are not portable upon termination once the employee leaves the employer.

The Plan provides a flexible spending account (FSA) option that is funded solely through participant contributions. The FSA allows eligible participants to contribute and be reimbursed on a tax free basis for qualified medical expenses. Contributions are subject to a specified ceiling.

Contributions

The Company pays 75% of the cost of health benefits and 100% of the life insurance premiums. Employees have an option to purchase up to \$100,000 of life insurance on themselves or immediate family at the company's group rate. Employees are responsible for 25% of health benefits. The HRA is funded 100% by the employer. The FSA is entirely funded by employees’ pre-tax dollars.

Captive Insurance

In 2015 the Plan joined a captive insurance group. A deposit of \$19,900 was made by the Plan and is refundable to the Plan if the captive insurance agreement is terminated.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan uses the accrual basis of accounting. Accordingly, receivables, estimated amounts for health claims incurred but not paid, and refunds to participants have been recorded in addition to all cash receipts and cash disbursements of the Plan.

Recently Adopted Accounting Guidance

Effective January 1, 2023, the Plan adopted ASU 2016-13 Financial Instruments – Credit Losses (Topic 326): Measurement of Credit Losses on Financial Instruments (ASC 326). This standard replaced the incurred loss methodology with expected loss methodology that is referred to as the current expected loss (“CECL”) methodology. The adoption of this standard mainly impacts the accounts receivable of the Plan and did not have a material impact on the financial statements and did not result in any prior period adjustment.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein; claims incurred but not reported; eligibility credits; claims payable; and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as claims payable in the accompanying statements of statements of benefit obligations and net assets available for benefits.

Stop Loss

Premiums for stop loss insurance are included in premium payments in the accompanying statement of changes in net assets available for benefits. During December 31, 2024, a total of \$75,583 in stop loss claims were netted with claims paid. \$75,583 of stop loss claims are recognized as Other Receivables as of December 31, 2024. During December 31, 2023, a total of \$313,694 of stop loss claims were netted with claims paid. \$86,120 of stop loss claims were recognized as Other Receivables as of December 31, 2023.

Refunds

Refunds due from the Plan's PBM are recorded when collection is probable and the amount can be reasonably estimated. Because refunds from the Plan's PBM can extend out up to a year from the initial period end, the Plan does not have the ability to reasonably estimate the balance due to the Plan at year end. As such, PBM rebates are recorded when received. Pharmacy rebates totaling \$13,366 and \$13,992 have been netted with claims paid in the accompanying statements of changes in benefit obligations and net assets available for benefits for the years ended December 31, 2024 and 2023, respectively.

Health Reimbursement Arrangement

An individual HRA account is maintained for each HRA participant

At December 31, 2024, a total of \$173,950 was available for future use for eligible medical expenses; this included \$151,882 in individual HRA accounts, and \$22,068 in forfeiture accounts that will be used to reduce employer contributions in 2025. Forfeitures result from unused individual account balances of participants who were no longer employed and had not incurred reimbursable expenses.

At December 31, 2023, a total of \$174,978 was available for future use for eligible medical expenses; this included \$152,834 in individual HRA accounts, and \$22,144 in forfeiture accounts that will be used to reduce employer contributions in 2024. Forfeitures result from unused individual account balances of participants who were no longer employed and had not incurred reimbursable expenses.

Flexible Spending Arrangement

A flexible spending arrangement is available to pay for expenses not covered by the other Plans. Deposits to the FSA account are made completely by employee contributions. During 2024 deposits of \$9,600 were made to the FSA cash account and expenses of \$10,280 were deducted from the FSA cash account. During 2023 deposits of \$12,234 were made and expenses of \$10,997 were deducted from the FSA cash account.

Subsequent Events

Management has evaluated subsequent events for the Plan through October 12, 2025, the date the financial statements were available to be issued and were not aware of any additional events that would need to be recognized.

NOTE 3 – TAX STATUS

The Trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to Section 501(c)9 of the Internal Revenue Code (IRC), and, accordingly, the Trust's net investment income is exempt from income taxes. The Trust has obtained a favorable tax determination letter from the IRS, and the plan sponsor believes that the Trust, as amended, continues to qualify and to operate in accordance with applicable provisions of the IRC.

Generally Accepted Accounting Principles requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

NOTE 4 – TERMINATION OF THE PLAN

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

NOTE 5 – ADMINISTRATIVE EXPENSES

The Plan pays administrative expenses that consist primarily of administrative fees paid to third party claims administrators, the trustee, and actuary. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan.

NOTE 6 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The principal owners of J.F. Allen Company (the plan sponsor) are also the trustees of J.F. Allen Company Health & Welfare Plan. J.F. Allen Company provides certain accounting and administrative services to the Plan for which no fees are charged. These transactions are exempt from party-in-interest transactions.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various cash accounts that are insured up to \$250,000. Management does not maintain cash balances over \$250,000.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statement.
