## INDEPENDENT AUDITOR'S REPORT

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audits of the financial statements of Cope Plastics, Inc. Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Cope Plastics, Inc. Profit Sharing Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### **Opinion**

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Cope Plastics, Inc. Profit Sharing Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1: DESCRIPTION OF THE PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan document for more complete information.

**General** - The Plan is a defined contribution 401(k) plan covering all employees of the Company. An employee becomes eligible to participate after completing three months of service, provided that they worked at least 1 hour during the plan year, and have attained the age of 21. Eligible employees who do not make an election upon becoming eligible to participate in the Plan are automatically enrolled. The Plan is subject to ERISA. The trustees are responsible for oversight of the Plan and the appropriateness of the Plan's investment offerings and the monitoring of investment performance. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

**Contributions** - The Company contributions are discretionary as determined by the Company's Board of Directors. The Company matches 50% of employee salary deferred contributions for each participant up to 6% of eligible compensation. Each participant may elect to contribute up to a maximum of 100% of compensation on a pre-tax basis, an after-tax (Roth) basis or a combination of both, not to exceed the federal statutory limits. Participants may contribute rollovers from other qualified plans.

**Participant Accounts** - Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, the Company's matching contribution, an allocable portion of the Plan's earnings (losses), and charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of employer and participant contributions into various investment options offered by the Plan.

**Vesting** - Employees are immediately vested in their voluntary contributions plus their contributions' earnings. Vesting in the remainder of their accounts is based on years of continuous service. An employee is fully vested after 6 years of continuous service.

**Notes Receivable from Participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at prime rate plus 1%. Principal and interest is paid ratably through payroll deductions.

**Payment of Benefits** - Benefits may be paid to the participant or beneficiary upon termination of service, including death, disability or retirement. The Plan allows in-service distributions for participants who were participating in the Plan for at least 5 years prior to January 1, 2006. For terminated participants, the Plan automatically distributes the vested value of the account balance, as defined, if less than \$5,000 in a lump sum amount.

For coronavirus related distributions made before December 31, 2020 to qualified individuals, as defined in the CARES Act, the maximum distribution was the lesser of the vested portion of the participant's account balance in the Plan or \$100,000. In addition, for active employees, a coronavirus related distribution may be repaid at any time during a three-year period beginning on the day after the date on which the distribution was received.

**Forfeitures** - At December 31, 2024 and 2023, forfeited non-vested account balances totaled \$38,090 and \$26,019, respectively. These account balances will be used to pay administration fees and reduce future employer contributions. Employer contributions were not reduced from forfeited non-vested accounts for the year ended December 31, 2024 and 2023. Plan expenses of \$9,617 and \$10,975 were paid from forfeited non-vested accounts for the year ended December 31, 2024 and 2023, respectively.

**Plan Termination** - Although it has not expressed an intention to do so, the Company has the right to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, employees become 100 percent vested in their accounts.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting.

Subsequent Events

Subsequent events were evaluated through October 7, 2025, which is the date the financial statements were available to be issued.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Allowance for Credit Losses

Effective January 1, 2023, the Plan adopted ASC 326: Financial Instruments-Credit Losses, using a modified-retrospective approach. The standard requires entities to record an estimate of expected losses on financial assets for the remaining estimated life of the asset. The standard applies to the Plan's contribution receivable. The adoption did not have a material impact on these financial statements. The Company has concluded that no allowance for current expected credit losses was necessary at December 31, 2024 and December 31, 2023.

Income Tax Status

The Plan operates under an adoption agreement in connection with a prototype non-standardized pre-approved profit sharing document. The Internal Revenue Service has determined and informed the prototype plan sponsor by letter dated June 30, 2020, that the prototype plan is designed in accordance with applicable sections of the IRC.

Management has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Cash Surrender Value of Life Insurance

The Plan no longer offers plan participants the ability to purchase life insurance; however, the Plan holds previously purchased life insurance for participants. These amounts are recorded at the cash surrender value of the life insurance policy.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES, CONTINUED

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent loans are reclassified as distributions based on the terms of the Plan document.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contracts, which are measured at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan pays expenses including investment management fees, record keeping fees, and other administrative fees. The Plan Sponsor may bear certain costs associated with administering the Plan. These costs are not included in the accompanying financial statements and constitute exempt party-in-interest transactions.

NOTE 3: FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future values. Furthermore, although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

FASB ASC 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in inactive markets, inputs other than quoted prices that are observable and inputs that are derived or corroborated by observable market data.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE 3: FAIR VALUE MEASUREMENTS, CONTINUED

Registered Investment Securities (Mutual Funds)

Shares of registered investment securities are valued at the unit value of shares held by the Plan. The unit values are calculated using the closing NAV as reported on the active market of which the individual securities are traded and adjusted for a per share amount of dividends, capital gain distributions and management fees.

Cash Surrender Value Life Insurance

The life insurance policies with Ameritas Life Insurance Corporation are not actively traded and significant other observable inputs are not available. The fair value of the insurance policies are determined using Ameritas Life Insurance Corporation's valuation models which take into account the passage of time, mortality tables, interest rates, cash value for paid up additions and dividend accumulations.

NOTE 4: GUARANTEED INVESTMENT CONTRACT

In August 2018, the Plan entered into a guaranteed investment contract ("GIC") that is a group annuity contract backed by the Nationwide Life Insurance Company. The company maintains the contributions in general accounts. The GIC issuer is contractually obligated to repay the principal at a specified interest rate that is guaranteed to the Plan. The crediting rate is reviewed on a quarterly basis for resetting. The GIC's crediting rate as of December 31, 2024 was 2.21% with a contract value of \$3,575,560. The GIC's crediting rate as of December 31, 2023 was 2.57% with a contract value of \$3,620,746. The guaranteed investment contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Nationwide represents contributions made under the contracts, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Nationwide is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include a premature termination of the guaranteed interest contract or a termination of the retirement plan. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

NOTE 5: PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. The Plan's investment transactions are executed by Nationwide. Nationwide is the Plan's custodian and all investment transactions are intended to qualify as party-in-interest transactions.

Fees paid by the Plan for investment management and other administrative services are intended to qualify as exempt parties-in-interest transactions and are included in the investment and administrative fees in the accompanying financial statement.

NOTE 6: NON EXEMPT PARTY-IN-INTEREST TRANSACTIONS

There were instances in 2024 when the Plan remitted some participants' contributions to the Plan's custodian later than required under Department of Labor Regulation Sec. 2510.3-102. All late remittances were promptly discovered, funded, and self-corrected, and timely reported on IRS Form 5330, with payment of applicable excise taxes. The impacted participant accounts were credited by an amount representing investment income that would have been earned had the participant contributions been remitted on a timely basis. The aggregate amount of late contributions in 2024 totaled \$438,209, all of which were remediated in 2024. Credits of investment income to participant accounts amounted to \$4,135.
