Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of United Refining Company of Pennsylvania Incentive Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement whether due to fraud or error. Notes to Financial Statements

1. Plan Description

The following brief description of the United Refining Company of Pennsylvania Incentive Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a complete description of the Plan’s provisions. United Refining Company of Pennsylvania is the “Plan sponsor” of the Plan.

General

The Plan is a defined contribution pension plan covering all employees not covered by a collective bargaining agreement, leased or temporary, who have completed at least one year of continuous service and are at least 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Effective July 15, 2024, the plan was amended to add Pump N Pantry, Inc., as an adopting employer in the plan.

Contributions

Participants may elect to contribute a percentage of base salary subject to certain IRS limitations. Newly eligible employees will automatically have 3% of eligible wages deferred and remitted to the Plan unless the employee changes the deferral percentage or elects not to participate in the Plan. Participants are permitted to make rollover contributions from previous plans qualified under Section 401(a) of the Internal Revenue Code (the “Code”) to any investment account.

Employee contributions are matched by the Company for all managers at the rate of 50% of the participant’s contribution, up to the first 6% of the employee’s salary. The Company may also make an elective profit-sharing contribution to all eligible non-managers of 1% of eligible plan compensation.

Effective January 1, 2024, the plan was amended to allow participants to elect after-tax Roth contributions at their discretion.

Employee contributions from the participant’s base salary are excluded from the participant’s current Federal taxable income, in accordance with Section 401(k) of the Code and are subject to certain limitations.

Participant Accounts

Each participant account is credited with the participant’s and the Company’s contributions and an allocation of net plan earnings and are charged with an allocation of certain

Participant Accounts (Continued)

administration expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investment of their account balances into various investment options offered by the Plan and may transfer balances between investment options at any time. Currently, the Plan offers various mutual funds and one Common/Collective Trust fund as investment options for participants.

Vesting

Participants are always vested 100% with respect to the current value of their contributions, as well as Company profit sharing contributions and earnings thereon.

Employees are subject to the Plan's vesting rules with regard to Company matching contributions and become 100% vested after three years of service, or upon attainment of early retirement age.

Notes Receivable From Participants

Participants are not permitted to borrow against their account balances.

Payment of Benefits

Retirement age is 65 with early retirement permitted at age 55. Benefits are paid upon participants' termination of service, retirement, death, disability, attainment of 59-1/2 years of age or hardship. Any benefit payments are made in accordance with the Plan's provisions. All vested account balances less than \$5,000 may be automatically distributed to the participant.

Forfeitures

Company contributions and earnings thereon that have not become vested, and have been forfeited in accordance with the applicable provisions of the Plan, may be applied to reduce the Company's contributions required under the Plan or to pay plan expenses. If a participant returns to employment prior to incurring up to a maximum of five consecutive one-year breaks in service, as defined in the Plan document, any forfeited contributions are restored. As of December 31, 2024 and 2023, \$1,234 and \$8,703 respectively, had been forfeited by participants but not yet applied to reduce the Company's required contributions. The Company's cash contributions were reduced by \$20,151 and \$22,496 for the years ended December 31, 2024 and 2023, respectively, from forfeited nonvested accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value in accordance with ASC 820, *Fair Value Measurements and Disclosures*, as determined by the trustee, Bank of America, N.A. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in dividend income. In accordance with the policy of stating investments at fair value, net appreciation or depreciation for the year, including both realized and unrealized gains and losses, is reflected in the statements of changes in net assets available for benefits.

Contributions

Participant contributions are made through payroll deductions and are recorded as additions to net assets available for benefits when the deduction is made. Employer contributions are recorded as additions to net assets available for benefits when the Company accrues such contribution as a liability. Employee contributions and employer contributions not yet deposited are recorded as contributions receivable.

Payment of Benefits

Benefit payments are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025 the date on which the financial statements were available to be issued.

2. Summary of Significant Accounting Policies (Continued)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of changes in the net assets available for benefits during the reporting period, and disclosure of contingent assets and liabilities. The Plan's financial statements include amounts that are based on the Plan Administrator's best estimates and judgments. Actual results could differ from those estimates.

3. Related Party Transactions and Party-In-Interest Transactions

The Plan pays recordkeeping fees to Bank of America, N.A. Bank of America, N.A. is the trustee of the Plan and, therefore, these transactions qualify as party-in-interest. Fees paid by the Plan amounted to \$8,720 and \$10,651 for the years ended December 31, 2024 and 2023, respectively. Fees paid by the Plan for the investment management services are netted against net appreciation in fair value of investments.

All of these transactions are exempt from the prohibited transaction rules of ERISA.

4. Income Tax Status

The Internal Revenue Service ("IRS") has determined and informed the Plan's third-party administrator by a letter dated June 30, 2020, that the third-party administrator Non-Standardized Pre-Approve Plan on which the Plan is based, is designed in accordance with the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has had subsequent amendments, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and that the Plan is qualified and the related trust is tax exempt. Therefore, no provision for income taxes has been recorded.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

5. Information Certified by the Plan's Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following information summarized in the financial statements and supplemental schedule relating to investment income for the Plan for the years ended December 31, 2024 and 2023, and investments held as of December 31, 2024 and 2023, was certified by Bank of America, N.A. as trustee of the Plan as being complete and accurate.

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing the information with the related information included in the financial statements and supplemental schedule.

6. Plan Termination

The Plan sponsor has not expressed any intent to terminate the Plan but is free to do so at any time, subject to the provisions of ERISA. In the event of termination, each participant automatically becomes fully vested to the extent of the balances in his or her individual account.

7. Fair Value Measurements

Financial Accounting Standards Board ("FASB") ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust - CCTs represent investments with various investment managers. Units held in CCTs are valued at the unit value as reported by the investment managers. The Plan holds units of participation in a CCT that has investments in fully benefit-responsive investment contracts. As provided in ASC 962, an indirect interest in an investment contract is generally required to be reported at fair value, rather than contract value, to the extent it is fully benefit-responsive. The fair value of such investment contracts held by the CCT is determined using the market price of the underlying securities and the value of the investment contract as determined by the trustee.

CCT - Federated Capital Preservation Trust Fund is a collective investment fund for which Federated Investors Trust Company ("Federated"), a wholly-owned subsidiary of Federated Investors, Inc., serves as trustee under a Declaration of Trust dated October 25, 2007, as amended and restated on August 30, 2011, August 23, 2016, June 26, 2020, and July 16, 2021. The Trust Agreement is the governing instrument of the Fund. The trustee is organized as a Pennsylvania state-chartered trust company. The Trustee and the Fund operate in conformity with the rules and regulations of the Pennsylvania Department of Banking as they apply to collective investment of fiduciary funds. The Fund is exempt from income taxes under Sections 401 and 501 of the Internal Revenue Code. The investment objective of the

Fund is stability of principal and high current income. The Fund files its own 5500 giving it the status of a Direct Filing Entity.

In certain circumstances, the amount withdrawn from the Fund would be payable at fair value rather than at contract value. These circumstances may include, but are not limited to, the following: mergers, mass layoffs, plan terminations, implementation of early retirement incentive programs or other events within the control of the Fund or the Plan sponsor resulting in a material and adverse financial impact on the issuer's obligations.

Based on prior experience, Federated believes that it is not probable that such circumstances would be of sufficient magnitude to limit the ability of the Fund to transact at contract value with participants. Of course, there can be no guarantee that this will be the case.

8. Risks and Uncertainties

The Plan invests in various investment instruments including mutual funds and a common collective trust. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
