1. Description of Plan

The following description of the Sterling Pharma Solutions 401(k) Retirement Plan ("the Plan") provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code established on January 12, 2024, covering substantially all employees of Sterling Wisconsin, LLC and participating employers ("the Company"), except for collective bargaining (union) employees, non-resident aliens, as defined by the plan, residents of Puerto Rico, and interns. Part-time, temporary, and seasonal employees will become eligible upon attaining 1,000 hours in the relevant eligibility computation period. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Under the SECURE Act of 2019, any employees who are age 21 and complete 500 to 999 hours in three consecutive twelve-month periods, become eligible to make employee deferrals effective January 1, 2024. SECURE 2.0 Act of 2022 shortens that period to two consecutive 12 month periods effective January 1, 2025.

The Company ended their agreement with Insperity, a professional employer organization ("PEO"), at the end of 2023. As a result, the Company transferred \$12,511,785 to the Plan in January 2024.

Contributions

Each year, participants may contribute up to 80 percent of pretax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4 percent of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant. The Company provides a safe-harbor matching contribution of 100 percent of participant's elective deferrals up to 4 percent of participant's compensation each payroll period. The Company may also make discretionary non-elective contributions as determined by the Company's board of directors on behalf of all qualified participants. Employees must complete 1,000 hours of service and be employed on the last day of the Plan year to be eligible for discretionary non-elective contributions. There were no discretionary non-elective contributions for the year ended December 31, 2024. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company safe harbor matching contributions, as well as allocations of the Company's non-elective contributions and Plan earnings. Allocations are based upon participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and a fixed annuity contract as investment options for participants.

Vesting

Participants are vested immediately in their voluntary contributions, the Company's safe harbor matching contributions, and the discretionary non-elective contributions, plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Principal and interest are paid ratably through regular payroll deductions.

Payment of Benefits

On termination of service due to death, disability or retirement, or due to other reasons, a participant or, when applicable, a designated beneficiary, may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum or installment as provided by the Plan. Hardship distributions are available if a participant satisfies certain conditions. Hardship distributions are permitted from elective deferral and non-elective employer contribution accounts. The Plan also allows for in-service distributions upon attaining age 59 ½.

Forfeited Accounts

At December 31, 2024, forfeited account balances totaled \$13. Forfeited accounts may be used to reduce future employer contributions and plan expenses. No forfeitures were used during 2024.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value other than the fixed annuity contract. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). The Plan's management determines the Plan's valuation policies utilizing information provided by the record keeper. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are recorded as distributions based on the terms of the Plan agreement. Deemed defaulted loans amounted to \$24,753 during 2024.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and other distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/(depreciation) in fair value of investments.

According to the Plan Expense Agreement between the Company and Empower, Empower is required to make monthly contributions to the Plan Expense Account ("PEA") in an amount equal to 0.0208 percent of the Plan's assets (0.25 percent annually). The funds in the PEA may be used to pay Plan administrative expenses during the year. During the year ended December 31, 2024, Empower contributed \$25,821 to the PEA, all of which was used to pay Plan administrative expenses. No balance is available for future use as of December 31, 2024.

3. Unaudited Information

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-5(c) of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America ("EAICA") and Empower Trust Company, LLC ("Empower"), have certified that the following data included in the accompanying financial statements is complete and accurate.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Fixed Annuity Contract

The Plan entered into a fixed annuity contract with EAICA totaling \$516,362 for 2024. EAICA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. EAICA is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with EAICA. Such interest rates are reset on a quarterly basis.

The EI Fixed Account - Series Class I investment meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by EAICA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on EAICA's ability to meet its financial obligations. EAICA's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with EAICA. Such events include but are not limited to the following: (1) premature termination of the contracts by the Plan, (2) Company layoffs, (3) bankruptcy of the Plan Sponsor, (4) Plan termination, (5) mergers, or (6) early retirement incentives. The plan administrator believes that no events are probable of occurring that might limit the ability of the Plan to transact at contract value with EAICA and that would also limit the Plan's ability to transact at contract value with participants.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination any unallocated assets of the Plan should be allocated to participant accounts and distributed in such a manner under the terms of the Plan agreement.

7. Tax Status

The Plan has received an opinion letter dated June 30, 2020, that the Plan document is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan Administrator and the Plan's management believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe the Plan is qualified and the related trust is tax-exempt.

8. Risks and Uncertainties

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit volatility. Market risks include U.S. and global events that could impact the value of Plan investments. Such events may include public health emergencies, as well as international conflicts, cybersecurity attacks, supply chain disruptions, global monetary policy decisions, inflation, significant economic influences, and other adverse credit and market events and conditions. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Non-Exempt Transactions

During the plan year ended December 31, 2024, employee withholdings amounting to \$746 were not remitted to the Plan within the appropriate time frame by the Company. These transactions constitute prohibited transactions as defined by ERISA. The Company remitted these contributions to the Plan during each the Plan year. The lost earnings were remitted in October 2025.

10. Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are managed by EAICA and Empower. EAICA and Empower were the contract holder and record keeper as defined by the Plan. Transactions with these parties qualify as party-in-interest transactions. Investment and recordkeeping fees were paid to EAICA and Empower. Investment advisory fees were paid to Gallagher Benefits Services, Inc. The Company pays directly any other fees related to the Plan's operations. Notes receivable to participants are also considered party-in-interest transactions.

11. Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.
