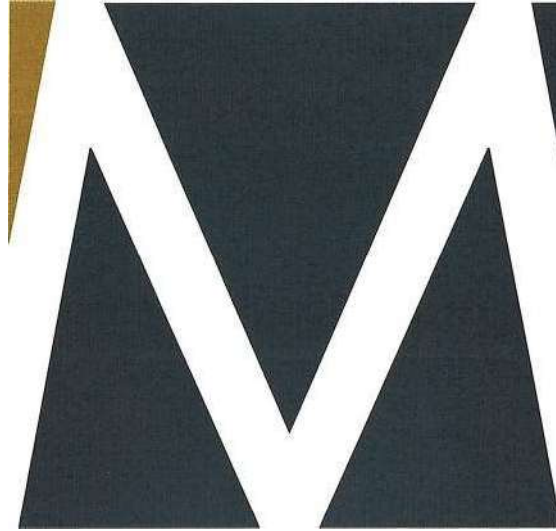

## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Bauer Equity Partners 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements (collectively, the "financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

#### **Note A - Description of Plan**

The following description of the Bauer Equity Partners 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan, which is a prototype defined contribution plan established by Bauer Equity Partners, LLC (the "Plan sponsor"), covers eligible employees of participating employers who are affiliated with the Plan sponsor and are not included in a collective bargaining unit. Covered employees who have been employed for a minimum of 90 days are eligible for pre-tax and/or Roth employee contributions.

Effective May 1, 2023, the Plan amended and restated the adoption agreement related to that prototype defined contribution plan document to add David Container, Inc., as a participating employer. In connection with that amended and restated adoption agreement, the Plan was amended to implement the Setting Every Community Up for Retirement Enhancement Act of 2019 (the "SECURE Act") and other law changes; however, the significant features of the plan remained substantially unchanged.

Effective January 1, 2024, the Plan amended and restated the adoption agreement related to its prototype defined contribution plan document to exclude from the definition of eligible employees interns, temporary and seasonal employees, and part-time employees, as those terms are defined in the plan document.

At December 31, 2024, participating employers include DJM Ecological Services, Inc., R&S Tower Services, Inc., Pure Air Natives, Inc., BDG Contracting, Inc. and David Container, Inc.

The Plan includes a Safe Harbor employer contribution provision requiring the Plan sponsor to make contributions to the Plan in amounts equal to 100% of participant salary deferrals up to the first 3% of participant's compensation and an additional 50% of the next 2% of compensation deferred by the participant. In addition, the Plan allows for discretionary contributions by the Plan sponsor. There have been no discretionary contributions made by the Plan sponsor since the inception of the Plan.

Each year, participants may contribute up to 100% of pre-tax or after-tax annual compensation, as defined in the Plan, subject to limitations prescribed by the Internal Revenue Code (IRC). Participants may also contribute amounts representing rollovers from other qualified defined contribution plans. Additionally, the Plan permits participants who have attained age 50 to make "catch-up" contributions in accordance with, and subject to, the limitations present in the IRC. If an eligible employee does not make an elective deferral election after receiving notice from the Plan sponsor, they will be deemed to have made an automatic deferral election. The automatic deferral election is 3% of compensation paid to those employees.

All employee and Safe Harbor contributions and the earnings/losses thereon are 100% vested. Vesting in discretionary contributions by the Plan sponsor and the related earnings (losses) occurs 20% after the completion of two years of continuous service and 20% per year of completed continuous service thereafter. Participants are automatically fully vested at their normal retirement date, or in the event of the participant's death or disability, regardless of the number of years of participation. Since inception of the Plan, all employer contributions have been Safe Harbor in nature and, as a result, participant balances have always been entirely 100% vested and there have been no forfeitures since the Plan was established. In the event participant balances subject to forfeiture were to arise in the future, any such forfeitures would first be used to pay Plan expenses. Any remaining forfeitures would be used to reduce employer contributions.

Appreciation or depreciation in the value of the assets of the Plan is allocated to the participants on the basis of the daily value of each participant's account. Participant and employer contributions are allocated to the various investment options offered by the Plan based on the direction of the individual participants.

All distributions from the Plan are made in a single lump-sum payment. Upon termination of service for any reason, including due to death, disability, or retirement, a participant may elect to receive the value of the participant's vested interest in his or her account. A participant may elect to receive an amount prior to termination if they have attained age 59½ or have experienced financial hardship and satisfy certain conditions established by the Plan document.

Loans to participants of the Plan are not permitted.

The Plan sponsor has the right to terminate the Plan at any time. In the event of termination, the value of the respective participant accounts, including employer contribution and earnings/losses thereon not previously vested, would become fully vested at the date of termination and distributed to participants.

#### **Note B - Summary of Significant Accounting Policies**

*Basis of accounting* The financial statements of the Plan are presented on the accrual basis of accounting.

*Use of estimates* The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the dates of the financial statements and the reported amounts of additions to and deductions from net assets available during the reporting periods. Actual results could differ from those estimates.

*Investment valuation* Investments of the Plan were held by the respective mutual funds' transfer agents (see Note C). The investments of the Plan in both 2024 and 2023 are substantially all in mutual funds and are stated at fair value as determined and reported to the Plan sponsor by the transfer agents.

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan would measure fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are utilized when there are observable inputs other than quoted market prices for the asset, either directly or indirectly observable, that reflect assumptions market participants would use to price the asset based on market data obtained from sources independent of the Plan. Level 3 inputs would only be used when Level 1 or Level 2 inputs are not available.

*Payment of benefits* Benefits are recorded when paid.

*Expenses* Expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan sponsor, and are included in administrative expenses. Expenses that are paid by the Plan sponsor are excluded from these financial statements.

*Subsequent events* The Plan sponsor has determined that no subsequent events have occurred since December 31, 2024, that would require recognition or disclosure in the financial statements. The Plan sponsor has evaluated all subsequent events as of October 14, 2025, which is the date these financial statements were available to be issued, but have not evaluated any events after that date.

#### **Note C - Certified Investments and Related Fair Value Measurements**

Mutual fund shares are maintained by the investment funds' transfer agent or entities performing sub-transfer agent duties. For T. Rowe Price mutual funds, T. Rowe Price Retirement Plan Services is the transfer agent and maintains records of the mutual fund shares owed by the Plan. Matrix Trust Company is the sub-transfer agent who performs those duties for shares of other mutual funds owned by the Plan. Reliance Trust Company serves as nondiscretionary (directed) trustee over all Plan assets.

Certain information related to investments as presented in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, net investment gain/loss (comprised of net appreciation (depreciation) in fair value of investments and realized gains/losses), as well as investment income (consisting of dividends and capital gains) and contribution and benefit payment activities for the years then, was obtained or derived from information supplied to the Plan sponsor and certified as complete and accurate by Reliance Trust Company.

The fair value of the Plan's investments at December 31, 2024 and 2023, as presented in the statements of net assets available for benefits were determined using quoted prices in active markets for identical assets and, therefore, are classified within Level 1 of the fair value hierarchy.

The Plan's investments at December 31, 2024 and 2023, are invested entirely in mutual funds that are valued at the daily closing price at the Plan's year end as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Gains/losses (realized and unrealized) represent the Plan's allocable portion of the market appreciation/depreciation and actual gain/loss experience on the various investments and are reported as net investment gain/loss in the accompanying statements of changes in net assets available for benefits.

#### Note D - Income Tax Status

The Internal Revenue Service (IRS) has determined and informed the Plan sponsor by a letter dated June 30, 2020, that the prototype plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan sponsor believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

#### Note E - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of those securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### Note F - Transactions with Party-in-Interest

Certain Plan assets are invested in securities established and maintained by T. Rowe Price ("TRP"). As TRP is the third-party administrator for the Plan and is one of the Plan's transfer agents as discussed in Note C, transactions in these accounts and underlying investment securities qualify as party-in-interest transactions. As displayed in the following table, greater than 95% of the Plan's investments at December 31, 2024 and 2023, related to investment securities established and maintained by TRP, as did the vast majority of addition and deductions thereto during the years then ended.
