We have performed audits of the financial statements of Wind Turbine & Energy Cables Corp 401(k) (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Note 1. Description of Plan

The following description of the Wind Turbine & Energy Cables Corp 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan was established on September 1, 2005, and was most recently restated on September 15, 2021. The Plan is a defined contribution plan covering substantially all employees of Wind Turbine & Energy Cables Corp 401(k). (the Plan Sponsor or Company), Cable System Installation, Alternative Energy Development Corporation and Gulf Cable LLC (collectively the Employers). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

An employee is eligible to participate in the Plan on the first day of each calendar month following six consecutive months of service and attaining 21 years of age. Participants become eligible for safe harbor matching contributions, discretionary employer matching, and discretionary non-elective contributions upon meeting the eligibility requirements for participation in the Plan.

Contributions

The Plan provides each participant with an opportunity to make elective deferrals and Roth contributions to the Plan up to 100% of compensation, subject to the limitations of the Internal Revenue Code. Participants who attained age 50 before the end of the plan year are eligible to make additional catch-up contributions.

The Company is required to make a safe harbor matching contribution, calculated on a plan year basis, equal to 100% of a participant's elective deferrals up to 3% of compensation and 50% of participant's elective deferral that exceed 3% of compensation not to exceed 5%. For the years ended December 31, 2024 and 2023, the Company made safe harbor matching contributions in the amount of \$435,970 and \$387,562, respectively.

The Company can also make a discretionary matching and non-elective contribution for each eligible participant in accordance with the provisions contained in the plan document. Discretionary matching contributions will not be made for elective deferrals exceeding 6% of a participant's compensation. There were no discretionary matching or non-elective contributions made for the years ended December 31, 2024 and 2023.

Vesting

Participant contributions, as well as safe harbor matching contributions and earnings thereon are immediately fully vested. Discretionary matching and non-elective contributions are subject to the following vesting schedule:

Forfeitures

Forfeitures are retained in the Plan and used to pay administrative expenses and then used to reduce future employer contributions. Forfeitures for the years ended December 31, 2024 and 2023, totaled \$0 and \$105,344, respectively, and the available balances as of December 31, 2024 and 2023 totaled \$104,365 and \$111,685, respectively. Forfeitures of \$9,729 and \$325 were applied to administrative fees for the years ended December 31, 2024 and 2023, respectively.

Participant Accounts

Each participant's account is credited with their own contributions, employer contributions, and earnings thereon. Contributions to the Plan are invested by the custodian as directed by the participants. Each participant may elect from one or more of the investment vehicles offered pursuant to the provisions of the Plan.

Benefits

On termination of service due to death, disability, or retirement, the benefit is paid as a lump sum to either the participant or designated beneficiary. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan also allows for hardship withdrawals in certain circumstances, as defined in the plan document.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their account balance. A participant may have up to two loans outstanding at a time. The loans are secured by the balance in the participant's account and bear interest at the prime interest rate as of the loan origination date. Repayment of the loan, unless for the purchase of a participant's primary residence, is over a five-year period. Notes receivable from participants are valued at their outstanding balances, which approximate fair value. As of December 31, 2024, the interest rates on the outstanding notes receivable from participants ranged from 3.25% to 8.50%.

Administrative Expenses

All transaction fees for loan and distribution requests are paid from participants' accounts. Substantially all other administrative expenses are to be paid by the Company.

Note 2. Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and liabilities and changes therein, and when applicable, disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value or contract value as determined by plan management (see Note 4 and 5). Purchases and sales of investment securities are recorded on a trade-date basis. Net appreciation includes the Plan's realized and unrealized gains and losses on investments bought and sold as well as held during the year. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Benefits Paid

Benefit payments to participants are recorded upon distribution.

Note 3. Information Certified by the Custodians

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America (EAIC), and Empower Trust Company, LLC (ETC), the trustees of the Plan, qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedules are complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedules.

Note 4. Investment Contract with Insurance Company

The Plan is party to an investment contract with EAIC, whereby allocated contributions are maintained in a Guaranteed Income Account (GIA). The GIA is credited with earnings on the underlying investments and charged for withdrawals and administrative expenses by EAIC. The contract was fully benefit-responsive and is reflected in the financial statements at contract value.

Certain events could limit the ability of the Plan to execute transactions at contract value with EAIC. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsors or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The contract does not permit EACI to terminate the agreement prior to the scheduled maturity date.

Note 5. Fair Value Measurements

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs. Valuation techniques used to measure fair value are defined as follows:

- Level 1** Inputs to the valuation methodology are quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2** Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the assets or liabilities; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Shares held by the Plan at year-end are valued at unadjusted quoted prices in an active market.

Common collective trust: The fair value of the common collective trust is determined by the trustee of the common collective trust based on the underlying assets, which represent the net asset value of units held by the Plan. The common collective trust funds do not have unfunded commitments relating to their respective investments, or any significant restrictions or redemptions. Participant-directed redemptions can be made on any business day and do not have a redemption notice period.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time subject to the provisions of the ERISA. If the Plan is terminated, the amount credited to the account of each participant will be fully vested.

Note 7. Tax Status

The Plan operates under a non-standardized adoption agreement in connection with a prototype 401(k) profit-sharing plan and trust sponsored by Empower Retirement LLC. This prototype plan document has been filed with the appropriate agency and has obtained an opinion letter from the IRS stating that the prototype constitutes a qualified plan under Section 401 of the Internal Revenue Code and that the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan's investments are concentrated in a guaranteed interest account, mutual funds, and a common collective trust that invest in marketable equity, debt, and fixed income securities. Such securities are subject to various risks that determine the value of the funds. Due to the level of risk associated with certain equity, debt, and fixed income securities and the level of uncertainty related to changes in the value of these securities, it is at least reasonably possible that changes in market conditions in the near term could materially affect participants' account balances and the value of investments reported in the financial statements.

Note 9. Party-in-Interest Transactions

Certain plan investments are managed by ETC and EAI and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to ETC and EAI amounted to \$22,202 and \$20,632 for the years ended December 31, 2024 and 2023, respectively. Services rendered by the investment manager and investment advisor also qualify as party-in-interest transactions. Fees paid to the investment manager and investment advisor amounted to \$88,500 and \$49,586 for the years ended December 31, 2024 and 2023, respectively. The Company provides certain administrative services at no cost to the Plan.

Note 10. Nonexempt Transactions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. While the Company remitted all employee contributions to the Plan, contributions of \$42,562 were not remitted within the required time period for the year ended December 31, 2024.

Note 11. Subsequent Events

Management evaluated subsequent events for the Plan through October 14, 2025, the date the financial statements were available to be issued. All subsequent events requiring recognition or disclosure have been incorporated in these financial statements.
