## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Beauchamp Distributing Company 401 (k) Profit sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (2024 Financial Statements).

**NOTE 1: DESCRIPTION OF THE PLAN**

The following description of the Beauchamp Distributing Company 401(K) Profit Sharing Plan, (the Plan) provides only general information. Participants should refer to the Plan document for a more comprehensive description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of the Beauchamp Distributing Company (the Company and the Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participants must have completed one year of service and have attained age 21 to be eligible to participate in the Plan. Eligible participants' entry date will be the first day of the Plan year or the first day of the seventh month of the plan year; coinciding with or next following the date the participant satisfies the eligibility requirements. To receive an allocation of the Company's discretionary profit sharing contributions, the participant must also be employed on the last day of the Plan year or in the event of death, disability, or retirement.

Effective March 27, 2020, the Plan administratively adopted the provisions of the Coronavirus Aid, Relief, and Economic Security (CARES) Act, related to participant loans and distributions. The Organization has until December 31, 2025, to amend the Plan for changes allowed by the CARES Act. The Plan has not been formally amended to adopt these provisions as of December 31, 2024.

Contributions

Each year, participants may contribute up to 100 percent of their eligible, pretax annual compensation, subject to Internal Revenue Code dollar limits for 401(k) deferrals as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions. Participants may also contribute (rollover) amounts representing pretax distributions from other qualified defined benefit or defined contribution plans. All contributions to the plan, including any matching funds by the employers are invested at the direction of the participants. The Employer matching contribution is 25 percent of the participant's pretax contributions, up to 6 percent of the participant's eligible compensation.

Participant Accounts

Each participant's account is credited or charged with his or her contributions and allocations for employers' contributions, investment earnings or losses and trustee administrative fees. Allocations are based on participant earnings, account balances, or account activity, as defined. The benefit to which a participant is entitled is the benefits that can be provided from participant's vested account.

Investment Options

The Plan currently offers diversified investment funds as investment options for participants. The participants may change their investment options at any time.

Vesting

Participants are vested immediately in their contributions adjusted by investment earnings or losses thereon. Company contributions are vested based on years of credited service. There is a graded vesting schedule whereby a participant is 100 percent vested after six years of credited service (20 percent per year from the completion of second year of service). Upon retirement age, death, disablement of the participant, freezing or termination of the Plan by the Employer, a participant becomes fully vested.

Withdrawals

The Internal Revenue Service (IRS) places certain restrictions on withdrawals in order to retain the special tax-savings benefits associated with the Plan. The Plan allows withdrawals at retirement, disability, separation of service, death, or financial hardship, as defined by the Plan.

Payments of Benefits

Upon termination of service due to death, disability or retirement, a participant or beneficiary may elect to receive an amount equal to the participant's vested account balance in a lump-sum payment, installment payments over the participant's or beneficiary's assumed life expectancy, roll the amount to an individual retirement account or other eligible transferee plan, or delay payment until the required beginning date of minimum distributions, depending on the value of the account. In addition, the Plan permits in-service distributions for participants who are age 59 ½ or older.

**NOTE 1: DESCRIPTION OF THE PLAN (continued)**

Distributions paid prior to the participant attaining age 59 ½ and not rolled into another retirement account are subject to federal income tax of 20% and a federal excise tax of 10%.

Vested account balances less than \$5,000, but more than \$1,000 may be distributed as a lump-sum cash payment or in the form of a direct rollover to an individual retirement account or eligible retirement plan at the consent of the participant or beneficiary. Vested account balances of less than \$1,000 are distributed in a single lump-sum cash payment to the participant or beneficiary.

Forfeitures

Forfeitures are used to pay any administrative expenses, reduce current or future employer contributions or employer matching contribution. For the year ended December 31, 2024 and 2023 there were no forfeitures.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to maximum equal to the lesser of \$50,000 or 50% of their vested account balance at the date of the loan application and are generally segregated investments of the participants borrowing the money. The loans are secured by the vested balance in the participant's account and bear interest at local prevailing rates as determined quarterly by the Plan administrator. Borrowers repay principal and interest over five years or less via regular payroll deductions.

Administrative Expenses

The administrator's expenses were paid by the plan. The custodian's fees of basis points of assets invested were paid directly from these assets. Additional fees will also be applicable on benefit disbursements, loans and periodic payments, which are charge on participants' accounts.

Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in the employer contributions.

Administrative Expenses

All reasonable expenses of administration may be paid out of the Plan assets unless paid by the Company. Expenses, to the extent not paid by the Company, are paid by the Plan, and allocated to participants based on their account balances. Expenses that relate solely to a specific participant, such as fees for notes receivable or benefit payments, are assessed to the participant. Certain expenses are included in the transaction prices of investments bought and sold and cannot be separately quantified.

**NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain amounts and disclosures. Accordingly actual results could differ from those estimates.

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP") as set forth by the Financial Accounting Standards Board (the "FASB").

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attributed for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participant would receive if they were to initiate permitted transactions under the terms of the plan. The Statement of Net Assets Available for Benefits presents the fair value of the investment contracts. The Statement of Changes in Net Assets Available for Benefits is prepared on a contract value basis.

Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized depreciation and appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. See Note 3 for discussion on fair value measurements and trustee certification.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis.

Date of Management's Review

Subsequent events were evaluated through October 13, 2025, which is the date the financial statements were available to be issued and determined that there were no subsequent events or transactions that required recognition or disclosure in the financial statements.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2020, and 2019, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Excess Contribution Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS for the years ended December 31, 2024, there were no excess contributions.

Payments of benefits

Benefits are recorded when paid.

**NOTE 3: SUMMARY OF UNAUDITED INFORMATION**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. The following information was certified by the Trustee and was not subjected to any auditing procedures performed by the independent public accountant:

- a. Fair value and net realizable value of investment as reflected in the Statements of Net Assets Available for Plan Benefits as of December 31, 2024, and 2023.
- b. Interest and dividends, net realized and unrealized depreciation in fair value of investments, and interest income on notes receivable from participants as reflected in the Statement of Changes in Net Assets Available for Plan Benefits for the Year Ended December 31, 2024.
- c. Investment information reflected in Schedule H, line 4i – Schedule of Assets (Held At End of Year) as of December 31, 2024.

The classification of the investments into the appropriate levels (1, 2, or 3) as disclosed in Note 5 is not certified by the Trustee and is the responsibility of Plan management.

**NOTE 4: INVESTMENTS**

All Plan investments are participant-directed and held by the Trustee as of December 31, 2024. Participants can direct their accounts among various mutual funds and a money market fund.

**NOTE 5: FAIR VALUE MEASUREMENTS**

ASC 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). All of the Plan's investments were valued at Level One of fair value measurement hierarchy at December 31, 2024. Under Level One, imputed to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 1 Fair Value Measurement:*

The fair value of Registered Investment companies (mutual funds) is valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. The mutual funds are valued at quoted market prices which are available on active markets and, therefore, are classified as Level 1 within the valuation hierarchy. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 6: METLIFE STABLE VALUE FUND SERIES 25053.**

This fund is a bank collective trust fund for which the Reliance Trust Company, the Custodian, serves as trustee and investment manager. The primary investment objective of the Fund is to preserve principal while generating earnings at rates competitive over time with short-time high quality fixed income investments, while maintaining sufficient liquidity to provide Participant Directed Withdrawals at their proportionate share of Contract Value.

The investments are qualified for the practical expedient to measure at net asset value, that is, the fair value of the Fund is estimate using net asset value daily per share. This valuation is consistent with accounting and reporting guidance in Financial Accounting Standard Board Accounting Standards Codification Topic No. 946. The fair value of the investment contract at December 31, 2024 and 2023, was \$2,789,449 and \$2,786,832 respectively. The Fund is not FDIC insured and is not guaranteed by Reliance Trust nor Guaranteed by any governmental agency. **NOTE 7: TAX EXEMPT STATUS**

The Internal Revenue Service has determined and informed the Employer by a letter that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan tax counsel believe the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there is no uncertain position taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020, or prior.

**NOTE 8: PARTY-IN-INTEREST TRANSACTIONS**

A party-in-interest is defined as a fiduciary or employee of the Plan, any person who provides service to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization, or a relative of such persons mentioned. However, there were no transactions with these entities other than the funding of contributions to the Plan.

**NOTE 9: SUBSEQUENT EVENT**

The Plan has evaluated subsequent events through October 13, 2025, the date which the financial statements were available to be issued. Except as disclosed, there were no other subsequent events note that would require adjustments to or disclosure in these financial statements. The effects of the global pandemic COVID-19 in the market have generally been mitigated in U.S. markets, however, the impact of the COVID-19 on foreign markets continues to evolve. The Company is not able at this time to estimate its impact on the Plan's assets in foreign companies.

**NOTE 10: RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Some of the Plan's assets are invested in securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies are their markets may be less liquid and their prices more volatile than securities of comparable U.S. companies.
