## INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of  
District Council 37 Local 95 Head Start  
Employees Welfare Fund

### Opinion

We have audited the accompanying financial statements of District Council 37 Local 95 Head Start Employees Welfare Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and of benefit obligations of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and of changes in its benefit obligations for the years then ended in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### Substantial Doubt About the Plan's Ability to Continue as a Going Concern

The accompanying financial statements have been prepared assuming that the Plan will continue as a going concern. As discussed in Note 14 to the financial statements, the Plan is delinquent in payments to the insurance carrier and the benefit obligations at December 31, 2024 of approximately \$4.7 million are significantly in excess of the net assets available to pay benefits at December 31, 2024 of approximately \$1.5 million which raises substantial doubt about its ability to continue as a going concern. Management's plans in regard to these matters are also described in Note 14. The financial statements do not include any adjustments that might result from the outcome of this uncertainty.





## Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements, including omissions, are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. NOTES TO FINANCIAL STATEMENTS

YEARS ENDED DECEMBER 31, 2024 AND 2023

**NOTE 1. DESCRIPTION OF THE PLAN**

The following brief description of District Council 37 Local 95 Head Start Employees Welfare Fund (the Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for a complete description of the Plan's provisions.

**General** - The Plan is a multiemployer defined benefit welfare plan established under the provisions of an Agreement and Declaration of Trust effective September 13, 1994 between the District Council 1707 Head Start Local 95 Community and Social Agency Employees Union (the Union) and the New York City Head Start Sponsoring Board Council (the Employer) who are parties to a Collective Bargaining Agreement requiring contributions to the Plan. The Union and the Employer agreed to participate in the operation of a trust fund for the purpose of providing health care benefits to employees of Head Start delegate agencies who are represented by the Union. Benefits are also provided to management and other non-union employees of New York City Head Start delegate agencies. The Plan is administered by a joint Board of Trustees (Trustees) consisting of equal Union and Employer representatives and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Effective January 1, 2021, the Plan changed its name from District Council 1707 Local 95 Head Start Employees Welfare Fund to District Council 37 Local 95 Head Start Employees Welfare Fund.

**Benefits** - The Plan provides self-insured health benefits (medical, hospitalization, surgical, and prescription drug) to eligible employees of participating employers and their eligible dependents, who are covered by collective bargaining agreements with the Union. The Plan also provides dental benefits to certain participants through an insured arrangement with Dentcare Delivery Systems, Inc. The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured medical and hospital benefits. Claims over a contractual amount incurred per participant during a one-year period are reimbursed by the insurance company to the Plan.

**Funding Policy** - Funding to provide the benefits is made through monthly contributions by participating employers on behalf of each covered employee as provided for in the applicable prevailing collective bargaining agreement with the Union. The employers contribute eighty-five percent (85%) of the contributions and the employees contribute fifteen percent (15%).



## NOTE 1. DESCRIPTION OF THE PLAN (CONTINUED)

Contributions are also made by the Plan in its capacity as employer, and by participants who have left covered employment and who elect to continue coverage with the Plan through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

## NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The accompanying financial statements have been prepared on the accrual basis of accounting. Under this basis of accounting, revenue is recognized when earned and expenses are recognized when incurred.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recognized on a trade-date-basis. Interest income is reported on the accrual basis. Dividends are recognized on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Employer Contributions Receivable** - Employer contributions due and not paid prior to the year end are accrued based on subsequent period cash collections. Employer contributions due as determined by payroll compliance audits are accrued at year end only when collection in the subsequent period can be observed. An allowance for uncollectible accounts is not considered necessary and is not provided. Based on a review of historical losses, current economic conditions and supportable and reasonable forecast assumptions, the Plan has concluded that any expected credit losses on balances outstanding at year end will be immaterial.

**Depreciation** - Property and equipment is stated at cost less accumulated depreciation. Depreciation is computed on the straight-line method over the estimated useful lives of the assets.

**Payments of Benefits** - Claim payments are recorded when paid to the third-party claims processors. Amounts due to claims processors that have yet to be paid by the Plan are recorded as claims payable in the accompanying statements of net assets available for benefit and of benefit obligations.

**Prescription Drug Rebate** - The Plan utilizes a pharmacy benefit manager (PBM) which periodically provides rebates to the Plan based on the Plan's actual utilization pattern of specific drugs. Rebates due from the Plan's PBM are accrued based on subsequent period cash collections. Rebates due as of the financial statements date have been reported as a receivable, with the offset being netted against health care benefits paid for participants. Pharmacy rebates totaling \$188,076 and \$326,748 have been netted with health care benefits paid to participants on the statements of changes in net assets available for benefits and of benefit obligations for the years ended December 31, 2024 and 2023, respectively.



## NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

**Benefit Obligations** - Benefit obligations at December 31, 2024 and 2023 for health claims incurred by active participants but not reported at those dates are estimated by the Plan's actuary in accordance with accepted actuarial principles and practices that take into consideration prior claims experience and also include analyzing claim lag studies using data provided by the Plan's third-party claims administrator. Such amounts are reported undiscounted as these obligations are typically paid within one year. Any differences in the amounts estimated and actual amounts will be reported in future years.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, including estimated amounts for claims incurred but not reported, and disclosure of contingent assets and liabilities, if any, at the date of financial statements. Actual results could differ from those estimates.

**Administrative Expenses** - Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. The Plan shares certain administrative expenses with related benefit funds in accordance with a time allocation study.

## NOTE 3. TAX STATUS

The Trust established under the Plan to hold the Plan's assets is qualified pursuant to Section 501(c)(9) of the Internal Revenue Code and accordingly, the Trust's net investment income is exempt from income taxes. The Trust has obtained a favorable tax determination letter from the Internal Revenue Service (IRS) and the Plan sponsor and the Plan's counsel believe that the Plan, as amended, continues to qualify and to operate as designed.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS and the Department of Labor.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes that the Plan's income tax returns for the years 2021 through 2023 remain subject to examination, based on the normal statutory periods subject to audit, notwithstanding any events or circumstances that may exist which could expand the open period.



#### **NOTE 4. CONCENTRATION OF CREDIT RISK**

Financial instruments that potentially subject the Plan to concentration of credit risk consist principally of cash and cash equivalent accounts held in a high quality financial institution. The balance at times may exceed federally insured amounts. The Plan has not experienced any losses in such amounts, and believes it is not exposed to any significant credit risk.

#### **NOTE 5. BENEFITS PROVIDED**

The Plan provides its dental benefits through a fully-insured arrangement with Dentcare Delivery Systems, Inc. Premiums paid for the years ended December 31, 2024 and 2023 were \$45,637 and \$66,346, respectively.

The Plan has a stop-loss insurance contract with Siriuspoint America Insurance Company in an effort to limit its exposure for self-insured benefits above \$175,000. The stop-loss policy was previously with Amalgamated Life Insurance Company. Premiums paid for the years ended December 31, 2024 and 2023 were \$374,890 and \$311,040, respectively.

Additionally, the Plan entered a fully insured plan with Empire BlueCross & BlueShield (Empire) to provide medical, surgical and hospitalization benefit effective August 1, 2023 through February 28, 2024. Premiums paid for the years ended December 31, 2024 and 2023 were \$826,084 and \$3,401,706, respectively.

The Plan entered into an amendment to the administrative services agreement with Empire effective April 2022. This agreement essentially allowed the Plan to defer payments of claims incurred prior to December 31, 2021, until full satisfaction of approximately \$2.3 million was completed in August of 2024.

All other benefits are self-insured and paid from the general assets of the Plan. The claims for self-insured benefits are processed by the Plan's third-party claims processor Insurance Design Administrators under administrative services only (ASO) arrangements.

#### **NOTE 6. FAIR VALUE MEASUREMENTS**

Accounting standards provide the framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3).

## NOTE 6. FAIR VALUE MEASUREMENTS (CONTINUED)

The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include other significant observable inputs including:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## NOTE 8. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan shares office space and administration with D.C. 1707 Health and Benefit Fund, a related benefit fund. As part of a cost sharing arrangement, the Plan acts as paying agent for certain common administrative expenses. Consequently, the Plan is reimbursed by the D.C. 1707 Health and Benefit Fund for its estimated allocable share of these common administrative expenses as determined by the Trustees. Allocable administrative expenses include payroll and payroll related costs, office expenses, as well as other administrative expenses. Reimbursable administrative expenses for the years ended December 31, 2024 and 2023 totaled \$-0- and \$68,893, respectively. At December 31, 2024 and 2023, the Plan was owed \$143,091 and \$10,971, respectively, from D.C. 1707 Health and Benefit Fund.

The Plan is also reimbursed by NYC Head Start Management Welfare Fund for its share of allocable expenses. Reimbursable administrative expenses for the years ended December 31, 2024 and 2023 totaled \$18,524 and \$28,291, respectively. At December 31, 2024 and 2023, the Plan (owed) or was owed \$(62,014) and \$(80,538), respectively.



## NOTE 8. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS (CONTINUED)

As disclosed in Note 2, the Plan pays certain administrative, investment, and professional fees to various service providers. These transactions are considered exempt party-in-interest transactions under ERISA.

## NOTE 9. OPERATING LEASE AS LESSEE

The Plan, through the HSEWF, LLC of which the Plan is a sole member, and the HBF, LLC jointly sublease administrative office space from the Community and Social Agency Employees Union District Council 37 (the Council). The fifteen-year lease expires on November 19, 2026. The HSEWF, LLC and the HBF, LLC each pay their proportionate share of the sublease rent expense. The Plan's portion of the rent expense for the years ended December 31, 2024 and 2023 totaled \$127,872 and \$127,873, respectively.

The Plan has elected to use a risk-free rate of 1.04% as the discount rate for determining its right-of-use asset and lease liability which apply to this lease. This rate is based on the U.S. Treasury 5 year daily rate as of January 3, 2022.

## NOTE 10. PARTICIPATION IN MULTIEMPLOYER PLAN

The Plan, on behalf of its office employees, contributes to a multiemployer defined benefit pension plan. The risks of participating in this multiemployer plan are different from single-employer plans in the following aspects:

- Assets contributed to the multiemployer plan by one employer may be used to provide benefits to employees of other participating employers.
- If a participating employer stops contributing to the plan, the unfunded obligations of the plan may be borne by the remaining participating employers.
- If the Plan chooses to stop participating in this multiemployer plan, the Plan may be required to pay an amount, referred to as withdrawal liability, based on the unfunded status of the plan. The Plan currently has no intention of terminating its participation in this multiemployer plan.

The Plan's participation in this plan for the annual period ended December 31, 2024 and 2023 is outlined in the table below. The "EIN and Pension Plan Number" rows provide the Employer Identification Number (EIN) and the three-digit plan number. The most recent Pension Protection Act (PPA) zone status available in 2024 and 2023 are for the Plan's year ends at December 31, 2024 and 2023. The zone status is based on information that the Plan received from the multiemployer plan and is certified by the plan's actuary. Among other factors, plans in the red zone are generally less than 65 percent funded, plans in the yellow zone are less than 80 percent funded, and plans in the green zone are at least 80 percent funded. The FIP/RP Status row indicates plans for which a funding improvement plan (FIP) or a rehabilitation plan (RP) is either pending or has been implemented. There have been no significant changes that affect the comparability of 2024 and 2023 contributions. Contributions reported below represent the Plan's proportionate share of the contributions made to this multiemployer plan.

## NOTE 11. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. These investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the financial status of the Plan and the amounts reported in the statements of net assets available for benefits and benefit obligations.

## NOTE 12. PRIORITIES UPON TERMINATION

Although they have not expressed any intention to do so, the Plan's Trustees, as Plan sponsor, have the right under the Plan to modify the benefits provided to active employees and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan will be used for purposes other than for the exclusive benefit of Plan's participants.

## NOTE 14. SUBSTANTIAL DOUBT ABOUT THE PLAN'S ABILITY TO CONTINUE AS A GOING CONCERN

As mentioned in Note 5, the Plan entered into an amendment to the administrative services agreement with Empire Bluecross Blueshield effective April 2022. This agreement allows the Plan to defer payments of claims incurred prior to December 31, 2021, until full satisfaction of approximately \$2.3 million was completed in August of 2024.

The Plan is delinquent in payments to the insurance carrier and the benefit obligations at December 31, 2024 of approximately \$4.7 million are significantly in excess of the net assets available to pay benefits at December 31, 2024 of approximately \$1.5 million which raises substantial doubt about the Plan's ability to continue as a going concern.

Management believes a restructuring of the above agreement with the insurance carrier along with potential increased contributions and plan benefit changes could allow the Plan to continue.

## NOTE 15. SUBSEQUENT EVENTS REVIEW

Subsequent events have been evaluated through October 11, 2025, which is the date the financial statements were available to be issued. This review and evaluation revealed no additional material event or transaction which would require an adjustment to or disclosure in the accompanying financial statements.
