Opinion

We have audited the financial statements of RENEW Energy, Inc. Employee Stock Ownership Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits (in liquidation) as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits (in liquidation) for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits (in liquidation) of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits (in liquidation) for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter—Plan Termination

As discussed in Note 1 to the financial statements, RENEW Energy, Inc. (the Plan's sponsor) entered into a Stock Purchase Agreement with RENEW Energy Holdings, LLC. As discussed in Note 3 to the financial statements, the Board of Directors of RENEW Energy, Inc. voted on December 10, 2020, to terminate the Plan with a proposed effective date of December 31, 2020, and management determined liquidation was imminent as of December 31, 2020. As a result, the Plan's financial statements have been prepared using the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Notes to Financial Statements

Note 1. Description of Plan

The following description of RENEW Energy, Inc. Employee Stock Ownership Plan (the Plan), established by RENEW Energy, Inc. (the Company), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Company established the Plan effective January 1, 2014. The Plan is a defined contribution plan and was designed as a stock bonus plan for participating employees of the Company and certain wholly owned subsidiaries. Until December 31, 2020, the Plan invested primarily in the Company's common stock, operated as an employee stock ownership plan (ESOP), and was designed to comply with section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986 (the Code). Effective December 31, 2020, the Plan was amended to no longer require investment in the Company's common stock and was converted to a profit sharing plan. The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On December 31, 2020, the Company entered into a Stock Purchase Agreement with RENEW Energy Holdings, LLC (the Buyer), an indirect majority owned subsidiary of Takkion TP&L Holdings LLC, an unrelated third party, whereby the Buyer purchased all of the outstanding company common stock owned by the Plan. Consequently, the Plan was terminated with a proposed effective date of December 31, 2020, immediately prior to the sale.

Eligibility: An employee was eligible to participate in the Plan after they had completed one year of service, as defined by the Plan as 1,000 hours within a 12-month period, and had attained age 21. The Plan excluded leased employees, independent contractors, nonresident aliens, and collective bargaining employees, unless the collective bargaining agreement allows for participation.

In accordance with the Plan termination, no new participants are allowed to enter the Plan.

Voting rights: All Company stock held by the trust was voted by the trustees in accordance with instructions from the Company's Board of Directors, except for major corporate events, such as mergers or liquidations. As defined in the Plan document, typically in the event of a defined major corporate event, each participant is entitled to exercise voting rights attributable to the shares allocated to their account. In conjunction with the sale of the Plan sponsor as of December 31, 2020, a third-party trustee voted on the participants behalf.

Participant accounts: The Plan is a defined contribution plan under which a separate individual account is established for each participant. At the end of each Plan year, each participant's account was credited with an allocation of the Company's discretionary contributions, if any, any stock reallocated, and investment results, net of any administrative expenses paid by the Plan. Allocations were based on participant compensation or account balances, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

Vesting: In accordance with the Plan termination with a proposed effective date of December 31, 2020, all participant accounts became 100% vested.

Payment of benefits: Payments of the remaining vested benefits for all participants will be made following the final distribution of the Plan's beneficial interest in escrow trust. The final distribution of Plan assets is expected to be distributed to participants by the end of 2025, upon receipt of the final indemnification escrow.

Note 2. Significant Accounting Policies

Basis of accounting: Due to the decision to terminate the Plan, as discussed in Note 3, management determined liquidation was imminent and unlikely to be blocked by regulators. Therefore, the financial statements have been prepared using the liquidation basis of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Beneficial interest in escrow trust: For the years ended December 31, 2024 and 2023, the beneficial interest in escrow trust of \$77,963 and \$133,796, respectively, is the Company's estimate of the amount to be received by the Plan from the escrow funds established by the Stock Purchase Agreement. The beneficial interest in escrow trust is carried at remaining escrow release amounts as stated in the Stock Purchase Agreement less an estimate made for potential claims against the escrow funds. As defined in the Stock Purchase Agreement, \$55,833 of the indemnity escrow was released to the Plan in March 2024 and \$51,679 of the indemnity escrow was released to the Plan in March 2023. Subsequent to year-end in September 2025, the remaining \$77,963 of the indemnity escrow was released to the Plan.

Income recognition: The amount of any future earnings on beneficial interest in escrow trust held by the Plan are not able to be reasonably estimated and, therefore, have not been accrued as of December 31, 2024.

Payments of benefits: Benefit payments are recorded when paid.

Administrative expenses: The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. The Company has historically paid the operating expenses for the Plan, which are excluded from these financial statements.

Subsequent events: The Company has evaluated subsequent events through October 14, 2025, the date on which the financial statements were available to be issued.

Note 3. Plan Termination

The Board of Directors of the Company voted on December 10, 2020, to terminate the Plan with a proposed effective date of December 31, 2020, immediately prior to the closing, in connection with the Stock Purchase Agreement between the Company and the Buyer, whereby the Buyer purchased all of the outstanding Company common stock owned by the Plan. Participants became fully vested in their benefits as of December 31, 2020.

In connection with the Stock Purchase Agreement, as of the date of closing, the Plan received cash proceeds and was entitled to payments from a beneficial interest in escrow trust (see Note 2). The liquidation of the Plan will be completed upon the distribution of the remaining Plan assets to participants, which is expected to occur by the end of 2025.

On February 13, 2024, the Plan was amended to revise the proposed Plan termination date to August 28, 2024, and to clarify that the Plan was considered frozen immediately prior to the sale of the Company.

Note 4. Fair Value Measurements

Accounting standards establish the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted, quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024.

Money market: Money market deposit accounts are valued at cost plus accrued income, which approximates fair value.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated September 7, 2017, that the Plan and related trust were designed in accordance with the applicable sections of the Code. The Plan has been amended since receiving the September 7, 2017, determination letter; however, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Code. The IRS issued a final determination letter dated February 7, 2024, stating that the Plan and related trust are designed in accordance with applicable sections of the Code and stating that the termination of the Plan does not adversely affect its qualification for federal tax purposes. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6. Administration of Plan Assets

Certain administrative functions are performed by officers or employees of the Company. No officer or employee receives compensation from the Plan.

Note 7. Related-Party and Party-in-Interest Transactions

The Plan invests in a money market at Alerus Financial, N.A. (Alerus). Alerus is the custodian and recordkeeper of the Plan, therefore, the investment qualifies as party-in-interest transaction.
