INDEPENDENT AUDITOR'S REPORT

To the Retirement Committee of SSM Health Care Corporation:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of SSM Health 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

1. DESCRIPTION OF PLAN

The following description of the SSM Health 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General—The Plan, created on August 1, 2007, is a salary deferral plan for all employees, except for union members, leased employees, and independent contractors, of certain taxable ministries of SSM Health Care Corporation (the “Company”). The ministries in the Plan are SSM Medical Group, Physician Services Corporation of Southern Illinois, S.C., Dean Health Services, Inc., Dean Health Plan, and Dean Retail Services. Employees of SSM Audrain Health Care, Inc. are not eligible to make salary deferral contributions, catch-up contributions, or rollover contributions under this Plan. For purposes of this report, employees of SSM Audrain Health Care, Inc. whose individual balances transferred to the Plan in 2014, shall be referred to as “Audrain legacy employees”. Employees eligible to participate in the Plan through taxable ministries shall be referred to as “SSM employees”. “Participants” shall be used to describe both groups of employees. “Dean Participants” shall be used to describe employees of Dean Health Services, Inc., Dean Health Plan, and Dean Retail Services. “Dean Employer” shall be used to describe Dean Health Services, Inc., Dean Health Plan, and Dean Retail Services.

SSM employees are eligible to begin their salary deferral contributions upon employment. The Company controls and manages the operation and administration of the Plan. Fidelity Management Trust Company (“FMTC”) serves as the trustee of the Plan. Empower Annuity Insurance Company (“EAIC”) (formerly Great-West Life & Annuity Insurance Company) serves as the insurance carrier of the Plan. Fidelity Workplace Services, LLC (“FWS”) serves as recordkeeper of the Plan and manages the self-directed brokerage account for Plan participants. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Contributions—Each year, SSM employees may contribute up to the maximum amount permitted by Internal Revenue Code (“IRC”) from their pre-tax annual compensation, as defined in the Plan Document. SSM employees who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. SSM employees may also be able to rollover contribution amounts from former employer’s retirement plans and pre-tax individual retirement accounts. SSM employees direct the investment of their contributions into various investment options offered by the Plan. In addition to the maximum contribution limitation described above, applicable IRC limitations are also placed on the amount of salary deferral of a highly compensated employee.

Employers’ Contributions and Receivable—As determined by the Company, the Plan allows for employer matching contributions. For all employees, the Plan provides for the employers to match 50% of the participants’ deferred and Roth contributions, limited to 6% of participants’ eligible compensation, up to the IRS limit.

Each participating Employer shall contribute a Basic Contribution annually in the form of a non-elective contribution. This contribution shall equal the greater of 3% of eligible compensation for the Plan Year or \$1,400 and is prorated for those participants with fewer than 2,080 Hours of Service. In addition, a participant shall receive an additional 1%–2% of the Compensation for the Plan Year dependent on reaching a certain number of years of Credited Service as of December 31, 2020.

Effective March 1, 2021, the Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically, enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Additionally for those participants who entered the Plan after March 1, 2021, their deferral rates are automatically increased by 1% at the start of each Plan Year (beginning January 1, 2022) until it reaches 6% or if a participant elects to not participate in the automatic escalation.

The Basic Contribution for the Plan year is calculated as of the last day of the Plan year and subsequently deposited into the Plan during the first quarter of the following Plan year, which is reflected in employer contribution receivable on the statements of net assets available for benefit.

Participant Accounts—Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution (if applicable), employer's contribution (if applicable), and an allocation of investment gains and losses and is charged with distributions and administrative expenses to participate in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments—Participants may direct the investment of their contributions and/or account balances into various investment options offered by the Plan and may change investments and transfer amounts between investments daily.

Vesting—Participants are immediately 100% vested for tax-deferred and Roth contributions, rollover, and safe harbor account balances and earnings thereon. Participants' employer basic and matching contributions account balances become fully vested and non-forfeitable upon normal retirement, disability, or death. If employment terminates for any other reason, a participant's vested percentage of the employer basic and matching contributions account balance is based on the participant's years of credited service, defined as 1,000 or more hours of service in a plan year effective January 1, 2020. Prior to January 1, 2020, participant's year of service was defined as 800 or more hours of service in a plan year. Employer basic contributions and matching contributions are 100% vested once a participant reaches 3 years of credited service.

Forfeited Accounts—Within investments at fair value contains unallocated Plan assets funded by forfeited nonvested participant accounts. Forfeited nonvested participant account balances are credited when certain terminations of participation in the Plan occur as defined by the Plan. The Plan Document permits the use of forfeitures to either reduce future employer contributions or pay plan administrative expenses.

During 2024, employer contributions were reduced by \$1,522,030 from forfeited nonvested accounts, while no amount was used to offset Plan expenses from the expense holding account. The total unallocated forfeitures were \$1,523,848 and \$1,494,875 at December 31, 2024 and 2023, respectively.

Administrative Expenses- Administrative expenses of the Plan are paid by the Plan or the Plan sponsor, as provided in the Plan document. Participants pay administrative costs for loans, distributions, and qualified domestic relation orders.

Notes Receivable from Plan Participants—Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance.

The loans are secured by the balance in the participant’s account and bear interest at prime plus 1%. Principal and interest are paid ratably through payroll deductions through July 17, 2023. Principal and interest after July 17, 2023 are paid directly to FWS through the participant’s bank account. At December 31, 2024, the range of interest rates on these loans was 3.25% to 10.25%, with varying maturity dates through 2037.

Payment of Benefits—On termination of service including but not limited to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account, or in substantially equal monthly, quarterly, semi-annual or annual installments for a specified number of years, or any other form as may be approved by the plan administrator and communicated to participants and former participants. In addition, participants are eligible for in-service withdrawals upon attaining the age of 59 1/2 or by incurring immediate and heavy financial need that satisfies the requirements for a financial hardship withdrawal.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting—The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates—The preparation of financial statements, in conformity with accounting principles generally accepted in the United States of America, requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties—The Plan invests in various types of investment instruments, including mutual funds, collective trust funds, a self-directed brokerage account, and a guaranteed fixed fund. Investment securities in general are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the financial statements. As of December 31, 2024, there was a significant concentration of investments (greater than 10% of investments held) in the SS S&P 500 Index II and the Fidelity Blue Chip Growth Commingled Pool Class C. As of December 31, 2023, there was a significant concentration of investments (greater than 10% of investments held) in the SS S&P 500 Index II.

Investment Valuation and Income Recognition—The Plan’s investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

The Plan’s investment contract with EAIC is the Empower Guaranteed Fixed Fund (“Guaranteed Fixed Fund”), which is fully benefit-responsive and is stated at contract value.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds, collective trust funds, and the self-directed brokerage account are deducted from income earned daily and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants—Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan Document.

Payment of Benefits—Benefit payments to participants are recorded upon distribution. There were no participants, who elected to withdraw from the Plan, but had not yet been paid at December 31, 2024 and 2023.

Administrative Expenses—Administrative expenses of the Plan are paid by the Company, except for annual participant fees, as provided in the Plan Document.

3. INVESTMENT CONTRACTS WITH INSURANCE COMPANY

Guaranteed Fixed Fund – The Guaranteed Fixed Fund is a fully benefit-responsive guaranteed investment contract (GIC) with EAIC and is closed to new participants. EAIC maintains the contributions in general accounts, which are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The GIC is included in the financial statements at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Limitations on Access to Funds of the GIC—The GIC specifies certain conditions under which the withdrawal or transfer from the participant’s GIC fund would be restricted for a period. Such circumstances include contract termination initiated by the Company or the establishment of a maximum amount which may be transferred in a calendar year by EAIC.

Plan management believes that no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

4. FAIR VALUE MEASUREMENTS

ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted

quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available and Level 3, which refers to securities valued based on significant unobservable inputs. Assets (and liabilities) are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Asset Valuation Techniques—Valuation technologies maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds are categorized as Level 1 if the securities trade on national or international exchanges and are valued at their last reported closing price.

Self-directed brokerage accounts are evaluated individually with inputs being based upon the assets held within the individual brokerage accounts. Generally, the assets held within the individual brokerage accounts are categorized as cash and cash equivalents and mutual funds. Cash and cash equivalents held within the individual brokerage accounts consist of cash and investments in highly liquid debt instruments that trade on a regular basis and are valued using the closing price reported on the applicable exchange on which the security is traded. Cash equivalents that trade on a regular basis in active markets are classified as Level 1.

Collective Trust Funds are valued at the net asset value of units of the collective trust. The net asset value as provided by the trustee is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to confirm that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments, or other redemption restrictions or notice periods.

The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2024 and 2023. The amounts presented in the following table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

6. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of a fully-benefit responsive GIC managed by EAIC; therefore these transactions qualify as exempt party-in-interest transactions.

The Plan holds shares of investment funds managed by an affiliate of the Plan trustee and recordkeeper; therefore, these transactions qualify as exempt party-in-interest transactions.

The Plan issues loans to participants, which are secured by the vested balances in the participants' accounts.

7. PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

8. FEDERAL INCOME TAX STATUS

The Internal Revenue Service ("IRS") has determined and informed the Company by a letter dated January 29, 2015, that the Plan and related trust were designed in accordance with the applicable regulations of IRC. The Plan has been amended since receiving the determination letter.

The Company and Plan management believe that the Plan is currently designed and operating in compliance with the applicable requirements of the IRC, and the Plan and related trust continue to be tax-exempt.
