## **Independent Auditors' Report**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audits of the financial statements of Eagle 2 Enterprises, LLC 401(k) Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). **Note 1 - DESCRIPTION OF PLAN**

The following description of the Eagle 2 Enterprises, LLC 401(k) Plan (the "plan") provides only general information. Participants should refer to the plan document or Summary Plan Description for a more complete description of the plan's provisions, which are available from the plan administrator.

**GENERAL**

The plan is a defined contribution plan sponsored by Eagle 2 Enterprises, LLC (the "company") for the benefit of its full-time employees who are age 18 or older, except for those who are covered under a collective bargaining agreement. During the year ended December 31, 2024, the plan sponsor was reorganized and the plan was renamed Eagle 2 Enterprises, LLC 401(k) plan from Hermanson Company, LLP 401(k) Plan. Affiliates who have adopted the plan include Hermanson Company, LLC, Federal Solutions Company, LLC and Velocity Building Technical Services, LLC. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**CONTRIBUTIONS**

Each year, participants may contribute a fixed dollar amount or a percentage of eligible annual compensation, as pre-tax or Roth contributions, as defined in the plan agreement. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older, who are making contributions to the plan, are allowed to make catch-up contributions as defined in the plan. Participants direct the investment of all contributions into various investment options offered by the plan. The plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the plan unless they affirmatively elect not to participate in the plan. Automatically enrolled participants had their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The plan was amended effective July 1, 2024 to increase the automatic deferral rate to 4% of eligible compensation for new participants.

The company contributes 75% of the first 5% base compensation that a participant contributes to the plan. The company made contributions of approximately \$842,000 and \$780,000 for the years ended December 31, 2024 and 2023, respectively.

The company may also make discretionary profit sharing contributions to the plan. To be eligible for discretionary profit sharing contributions, the participant must have completed 1,000 hours of service and be employed on the last day of the plan year. There were no profit sharing contributions for the years ended December 31, 2024 and 2023.

Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

**PARTICIPANT INVESTMENT ACCOUNT OPTIONS**

The plan currently offers various pooled separate accounts, a common collective trust and guaranteed interest accounts as investment options for participants. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time. There are no nonparticipant directed investments.

Contributions may be held as cash balances prior to the execution of the investment according to the participant's direction.

#### **PARTICIPANT ACCOUNTS**

Each participant's account is credited with the participant's contribution and allocations of (a) the company's contributions, as well as profit sharing contributions and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **VESTING**

Participants are immediately vested in their contributions as well any employer contributions, plus actual earnings thereon.

#### **NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator and is fixed over the life of the loan. Principal and interest are paid ratably through payroll deductions, and can be repaid at any time.

#### **PAYMENT OF BENEFITS**

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a period of not more than the participant's or designated beneficiary's assumed life expectancy. For termination of service due to other reasons, a participant with a balance in excess of \$1,000 but less than \$5,000, the account balance will be automatically distributed to an individual retirement account unless the participant or beneficiary makes a timely election to receive the distribution directly or to have the distribution paid directly to another eligible retirement plan. Participants with a balance under \$1,000 must receive the distribution in a lump sum upon termination.

#### **HARDSHIP AND IN-SERVICE WITHDRAWALS**

Participants are permitted to withdraw, in a single lump sum, the vested portion of their account balance under certain conditions. These conditions include unreimbursed medical expenses, the purchase of the participant's principal residence, the payment of post-secondary education tuition, the payment of funeral expenses or casualty losses or to prevent eviction or foreclosure from the participant's principal residence.

Participants that have reached normal retirement age may elect to withdraw all or a portion of their entire vested account balance while they are still employed by the company.

#### **FORFEITED ACCOUNTS**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$20,469 and \$15,524, respectively. These accounts may be used to pay any plan administrative expenses or reduce future employer contributions. For the years ended December 31, 2024 and 2023, employer matching contributions were reduced by \$0 and \$724, respectively, from forfeited accounts. No forfeitures were used during the years ended December 31, 2024 and 2023, to offset plan expenses.

**Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES****BASIS OF ACCOUNTING**

The financial statements of the plan are prepared on the accrual method of accounting.

**USE OF ESTIMATES**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**INVESTMENT VALUATION AND INCOME RECOGNITION**

Investments are reported at fair value (except for the fully benefit-responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan's 401(k) Committee determines the plan's valuation policies utilizing information provided by the investment trustee and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold, as well as held during the year.

**GUARANTEED INTEREST ACCOUNT**

The plan's guaranteed interest account is valued at contract value as contract value is the relevant measurement attributable to fully benefit-responsive contracts. Contract value represents the amount the participants would receive if they were to initiate permitted transaction under the terms of the plan. See Note 5 for discussion of the guaranteed interest account.

**CONTRIBUTIONS**

Contributions from plan participants and company matching contributions are recorded in the year which the participant contributions are withheld from compensation.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**PAYMENT OF BENEFITS**

Benefits are recorded when paid.

**ADMINISTRATIVE EXPENSES**

Certain expenses of the plan are paid by the company and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

**SUBSEQUENT EVENTS**

The plan has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued. No other significant matters were identified for disclosure during this evaluation.

**Note 3 - INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEES AND CUSTODIAN**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company and Empower Annuity Insurance Company of America, trustee and custodian of the plan, held the plan's investment assets and executed investment transactions from January 1, 2023 through May 14, 2023 and Voya Institutional Trust Company, trustee of the plan, held the plan's investment assets and executed investment transactions from May 15, 2023 to December 31, 2024. The custodian and trustees of the plan has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments:

- Investments at fair value
- Investments at contract value
- Notes receivable from participants
- Net appreciation (depreciation) in fair value of investments
- Interest and dividends
- Interest income on notes receivable from participants
- Investments, as reflected in Schedule H, Line 4(i) - Schedule of assets (Held at End of Year)

The plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

**Note 4 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual)

term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* The fair value of the pooled separate accounts is based on inputs other than quoted market prices included within level 1 that are observable for valuing the asset or liability, either directly or indirectly. Observable inputs include quoted market price for similar assets or liabilities in active or non-active markets. The pooled separate accounts are deemed to be actively traded.

*Common collective trusts:* Valued at the Net Asset Value (NAV) of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### Note 5 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The plan has a fully benefit-responsive guaranteed investment contract with Voya Institutional Trust Company (Voya). The Voya Fixed Account maintains the contributions in a general account of Voya. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting interest rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Each contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the plan. Contract value, as reported to the plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the plan to transact at contract value with the issuer. Such events include the following: (1) amendment to the plan document (including complete or partial termination or merger with another plan.), (2) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the plan to transact at contract value with the contract issuers and that would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the plan and settle at an amount different from contract value. Such events include the following: (1) an uncured violation of the plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreements without the consent of the issuer.

#### **Note 6 - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are shares of mutual funds, common collective trust and guaranteed investment contract managed by Voya Institutional Trust Company and related entities. Voya also provides certain administrative services to the plan, therefore these transactions qualify as party-in-interest transactions. From January 1, 2023 through May 14, 2023, certain plan investments are shares of mutual funds and a guaranteed investment contract managed by Empower Annuity Insurance Company of America and its subsidiaries. These entities also performed third party administration for the plan during the year. SCS Retirement provides investment advising to the plan. Fees charged by these companies are included in administrative expenses in the accompanying financial statements and qualify as party-in-interest transactions.

#### **Note 7 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA.

#### **Note 8 - TAX STATUS**

The company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020 stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain tax position that more likely than not would be sustained upon examination by the IRS. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 9 - RISKS AND UNCERTAINTIES**

The plan invests in various investment securities. Investment securities are exposed to risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as tariff impositions or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in

the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

At December 31, 2024 and 2023, approximately 18% and 15% of the plan's investment were invested in Fidelity 500 Index Fund, respectively. Additionally, at December 31, 2024, approximately 16% of the plan's investments were invested in the State Street NASDAQ-100 Index.

#### Note 10 - DELINQUENT PARTICIPANT CONTRIBUTIONS

Defined contribution plans are required to remit employee contributions to the plan as soon as they can be reasonably segregated from the employer's general assets. While the company has remitted all employee contributions to the plan, contributions of \$41,863 were not remitted within the required time period for the year ended December 31, 2023. The delinquent participant contributions totaling \$205 and \$41,658 were corrected, including any lost earnings, during the years ended December 31, 2024 and 2023, respectively. There were no delinquent participant contributions for the year ended December 31, 2024.
