INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Participants of the
Trianz Retirement Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Trianz Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Trianz Retirement Savings Plan's financial statements, performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024, and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' responsibilities for the audit of financial statements section—

- the amounts and disclosures in the accompanying financial statements other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements, related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Trianz Retirement Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt on Trianz Retirement Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. 1. Description of the Plan

The following brief description of the Trianz Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan that was established on January 1, 2002, covering all eligible employees of Trianz Digital Consulting, Inc., Trianz Consulting, Inc., Trianz Consulting & Tech Services, Inc. and Trianz, Inc. (collectively, the “Company”) and participating employers as defined in the Plan agreement. Certain classes of employees, as defined in the Plan agreement, are excluded from Plan participation.

The company has contracted Fidelity Investments Institutional as recordkeeper and Fidelity Management Trust Company to serve as the Trustee and is responsible for administration and management of the Plan. The Plan is subject to the provisions of The Employment Retirement Income Security Act of 1974 (ERISA) and is intended to satisfy all the requirements for a qualified retirement Plan under the appropriate provisions of the Internal Revenue Code (IRC).

Eligibility

Employees who are full-time, have attained the age of 21, and are employed with the Company are eligible to participate in the Plan. An eligible employee may opt to become a participant on the Entry Date i.e., the first day of each month, coinciding with or immediately following the date the employee completes the age requirement.

Employees excluded from the Plan are as follows:

- Residents of Puerto Rico
- Leased Employees
- Employees paid on Trianz Bangalore payroll

Contributions

Each year, participants may contribute an amount of eligible pretax annual compensation as defined in the Plan agreement, not to exceed the maximum statutory amount. Participants who are age 50 or older before the end of the Plan year can elect to make catch-up contributions to the Plan, not to exceed the maximum statutory amount. The annual elective deferral limit is \$23,000 for 2024 and the catch-up dollar limit for 2024 is \$7,500. The Plan allows for Roth deferral contributions and Roth rollovers.

The Plan allows for an employer discretionary matching contribution and an employer discretionary nonelective contribution subject to certain eligibility requirements. Although the Plan permits such contributions, the Company did not make any employer contribution match during the year December 31, 2024.

Rollovers

Employees may roll over eligible amounts from other qualified Plans to the Plan or certain Individual Retirement Account (IRA) to the Plan. Employees can also rollover after tax employee contributions, but it needs to be a direct rollover to this Plan from another eligible retirement Plan.

Investments

The Plan provides for investments to be directed by participants into several investment options held by the Trustee. Upon enrollment in the Plan, a participant may direct employee contributions in any of the investment options and may change their investment options at any time.

Participant Accounts

Each participant's account is credited with the participant's contribution, Plan earnings and losses, and Plan expenses as applicable to the Plan. Allocations of Plan earnings and losses are based on individual participant investment choices. All contributions/investments are participant directed. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are 100% vested in their contributions and rollover amounts plus actual earnings thereon. Vesting in the Company's discretionary matching and discretionary nonelective contributions and earnings is based on years of credited service.

Vesting in Company's discretionary nonelective contributions is at the rate of 20% after two years of service and an additional 20% each year thereafter and is 100% vested after six years of credited service. Vesting in Company's discretionary matching contributions is at the rate of 25% after a year of service and an additional 25% each year thereafter and is 100% vested after four years of credited service.

Payment of Benefits

Upon the satisfaction of certain distributable events, participants or their beneficiaries may elect to receive their vested account balance and are paid in accordance with Plan provisions.

Forfeitures

Forfeitures are the non-vested portion of participants' accounts that are lost upon termination of employment. Forfeitures may be used to pay Plan administrative expenses or reduce future

employer contributions. The forfeiture account had a balance of \$88,530 as of December 31, 2024, and \$15,351 as of December 31, 2023.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. Only one outstanding note per participant is permitted at any given time. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with prevailing rates as determined by the Plan Administrator. Notes Receivable as of December 31, 2024, and 2023 carry an interest rate of 4.50%. The total outstanding notes receivable from participants as of December 31, 2024, and 2023 amount to \$271,639 and \$307,843 respectively. Principal and interest are paid ratably through payroll deductions. The notes must be repaid within a five-year period unless it is used for the purchase of principal residence, in which case the maximum repayment period may extend beyond five years. The Plan Administrator establishes the specific terms and conditions of such notes.

Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

2. Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan have been prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits, changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment valuation and income recognition

The Plan's investments were stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determines the Plan's valuation policies utilizing information provided by Fidelity. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes Plan's gain and losses on investments bought or sold as well as held during the year.

Contributions

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes are recorded as distributions on the basis of the terms of the Plan agreement. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Plan expenses

In 2024, some fees related to the administration of the Plan were paid by the Company and these amounts are excluded from the Plan's financial statements. Investment/fund fees, certain participant transaction fees, Investment advisory fees and record-keeping fees are paid through the Plan and charged to participant accounts as applicable. Some of the TPA fees may be paid by the Plan through the forfeiture account.

Benefits paid to participants

Benefits are recorded when paid.

3. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, overall market volatility, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

4. Certified Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company.

5. Fair value measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification No.820, Fair value measurements establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the standard are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on December 31, 2024, and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. The funds are valued at daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Markets: Valued at quoted market prices (NAV) in active markets, which represent Level 1 inputs.

6. Party -in-interest and related party transactions

Plan investments are held by Fidelity Investments Institution. Any purchases and sales of these investments are performed in the open market at fair value. Plan-related fees are paid to Fidelity Management Trust Company and the TPA. The Plan has other service providers. All these transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

7. Income Tax Status

The Plan adopted a non-standardized pre-approved Plan which received an opinion letter dated June 30, 2020, from the IRS stating that the form of the Plan is qualified under Section 401 of the Code and, therefore, the related trust is tax-exempt. Although the Plan has been amended since receiving the determination letter, The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore believes that the Plan is qualified, and the related trust is tax- exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by various taxing authorities and government agencies. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
