SCOPE AND NATURE OF THE ERISA SECTION 103(A)(3)(C) AUDIT

We have performed audits of the accompanying financial statements of Integrity Cabinets 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Integrity Cabinets 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Integrity Cabinets (the Company) 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, adopted January 1, 2018, is a defined contribution plan established by the Company under the provisions of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. All employees of the Company who are twenty-one years of age and have completed one year of service are eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan administration

The administration of the Plan is the responsibility of an administrator appointed by the Plan sponsor, Integrity Cabinets. The trustee responsibilities of the Plan are that of the ownership of the Plan sponsor. No officer or employee receives compensation from the Plan for their administrative roles.

Participant accounts

Individual accounts are maintained for each of the Plan's participants to reflect participant's contributions and their share of employer contributions, as well as the participant's allocated share of the Plan's earnings and losses. Allocations of the Plan's earnings and losses are based on the participant's account balance. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All accounts within the Plan are participant-directed asset accounts.

Contributions

Each year, participants may elect to defer up to 100% of pre-tax annual compensation, as defined in the Plan agreement, subject to limitations under the IRC. Additionally, participants may elect to defer after-tax compensation, as defined, as a Roth elective deferral. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company makes non-elective contributions through a safe harbor match equal to each participant's deferral contributions, subject to a maximum of 4% of eligible compensation for the plan year. The Plan also allows for additional matching contributions and profit-sharing contributions to be made by the Company at its discretion. No such discretionary contributions were made by the Company for the year ended December 31, 2024.

Investment options

Participants direct contributions, including Company contributions, into various investment options and may change their investment elections daily. A variety of mutual funds are offered by the Plan with different investment goals made up of debt and equity securities of U.S. and foreign companies. Investment in common/collective trusts are offered in the form of a stable value fund and collective investment trust funds based on target retirement dates. Pooled separate accounts, with underlying assets including mutual funds, equities and fixed income securities, are also available investment options. Participants may also elect to participate in self-directed brokerage investment options through a broker of their choice.

NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

Payment of benefits

Upon termination of service due to retirement, death, disability, or other qualified services as described in section 401(k)(10) of the code, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account as a lump-sum distribution. Additionally, distributions are permitted for qualified hardship circumstances.

Vesting

Participants are immediately fully vested in their contributions and the actual earnings thereon as well as the Company's safe-harbor matching contributions and actual earnings thereon. A participant vests in any discretionary Company contributions and the earnings thereon based on years of continuous service as follows:

Less than 2 years of service:	0% vested
2 years of service:	20% vested
3 years of service:	40% vested
4 years of service:	60% vested
5 years of service:	80% vested
6 years of service:	100% vested

Unvested amounts forfeited from participant accounts can be used to reduce future Company contributions or applied toward administration fees at the direction of the Plan administrator. During the year ended December 31, 2024 no amounts were forfeited and no previous forfeitures were applied, and as of December 31, 2024, there was no balance of forfeitures for future application.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of income and expenses during the reporting period. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for fair value measurements of the Plan's investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes capital gain distributions reinvested into the plan, realized gains or losses on investments bought and sold during the year, and unrealized gains or losses on investments held at the end of the year.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Certain expenses of maintaining the Plan are absorbed by the Plan sponsor and are therefore excluded from the accompanying financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of certain benefit payments are included in administrative expenses and charged directly to the related participant's account.

NOTE 3 - UNAUDITED INFORMATION PREPARED AND CERTIFIED BY QUALIFIED INSTITUTION

The Plan's investments are held by Principal Trust Company, the custodian of the Plan. The following information included in the accompanying financial statements and supplementary schedule has been prepared from information certified as complete and accurate by the custodian, a qualified institution in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974:

NOTE 5 - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure fair value of certain financial instruments could result in a different fair value at the reporting date.

FASB ASC 820, Fair Value Measurements and Disclosures, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of quoted market prices for similar or identical assets in a market that is not active, or other significant observable inputs, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available.

NOTE 5 - FAIR VALUE MEASUREMENTS (CONTINUED)

There have been no changes to the Plan's investment valuation methodologies for the year ended December 31, 2024, which are as follows:

Mutual funds

Mutual funds are shares of registered investment companies with fair values published daily by the funds, which are quoted prices in active markets and are classified as level 1 of the fair value hierarchy.

Pooled separate accounts

Pooled separate accounts are maintained by Principal Life Insurance Company as sub-accounts of the Plan's group annuity contract and are valued using net asset value as a practical expedient for estimating fair value. Accordingly, these investments have been excluded from the fair value hierarchy. Net asset values are based on the fair values of the underlying investments within the accounts, which are primarily mutual funds and other publicly traded securities. Although the pooled separate accounts do not have publicly quoted prices, the Plan believes the net asset values reported by Principal Life Insurance Company for these investments approximates fair value. There are no redemption restrictions or unfunded commitments on these investments as of December 31, 2024.

Common/collective trusts

The investments held in collective trusts are valued using net asset value as a practical expedient for estimating fair value. Accordingly, these investments have been excluded from the fair value hierarchy. Net asset values are based on the fair values of the underlying investment assets held in the trusts, minus their liabilities. The stable value fund invests in conventional and synthetic guaranteed investment contracts issued by life insurance companies, banks and other financial institutions designed to provide a stable rate of return. Target retirement date collective trust investments are comprised of various types of investment assets based on different levels of risk, including mutual funds and other publicly traded securities. Participants may transact with the investments held in collective trusts daily, and there are no redemption restrictions or unfunded commitments on these investments as of December 31, 2024.

NOTE 6 - RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS

Certain administrative functions are performed by Principal Trust Company, the custodian of the Plan. Fees paid by the Plan for contract administration qualify as party-in-interest transactions and total \$2,538 for the year ended December 31, 2024. Certain investments, identified in the supplementary schedule of assets held, are managed by affiliates of Principal Trust Company. Fees for managing these investments are charged as a reduction to their investment income. Transactions related to these investments qualify as party-in-interest transactions. The Plan is serviced by Principal Life as its record keeper and third-party administrator.

NOTE 8 - TAX STATUS

The Internal Revenue Service issued a determination letter, dated March 31, 2014, stating that the prototype plan document that was adopted by the Plan was designed in accordance with applicable Internal Revenue Code requirements as of that date. The plan has been amended since receiving the determination letter; however, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the Plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement dates.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 9 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested.

NOTE 10 - AMOUNTS ALLOCATED TO WITHDRAWING PARTICIPANTS

At December 31, 2024, there was \$28,757 allocated to accounts of persons who as of and prior to that date had elected to withdraw from the Plan but had not yet been paid.

NOTE 11 - SUBSEQUENT EVENTS

The date to which events occurring after December 31, 2024, the date of the most recent balance sheet, have been evaluated for possible adjustment to the financial statements or disclosure is October 15, 2025, which is the date on which the financial statements were available to be issued.
