## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of  
Contractors Plan Trust Health Reimbursement Arrangement

### **Opinion**

We have audited the accompanying financial statements of Contractors Plan Trust Health Reimbursement Arrangement (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Contractors Plan Trust Health Reimbursement Arrangement as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

1. DESCRIPTION OF THE PLAN

The following description of Contractors Plan Trust Health Reimbursement Arrangement (the "Plan") provides only general information. Participants should refer to the plan document for a complete description of the Plan's provisions.

The Plan has been established as a health reimbursement arrangement, as defined in the Internal Revenue Code (the "Code") and the Plan is subject to the provisions of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

The Plan is part of The Contractors Plan Trust II ("Trust"). The Plan's custodian is American Bank of Commerce (the "Custodian"). Fringe Benefit Group, Inc. ("FBG") serves as the third party administrator and recordkeeper to the Plan. FBG is responsible for determining whether claimed benefits are provided for by the Plan, processing claim payments, ensuring the claim payments are correct and within the payment limits stipulated by the Plan, and maintaining all documentation in support of claim payments. Hanford Applied Restoration and Conservation (the "Sponsor" or "Employer") serves as Plan sponsor.

Eligibility

The Plan is offered to two categories of employees: hourly and monthly. For both categories, eligibility for participation in the Health Reimbursement Arrangement ("HRA") requires employees to enroll in a Bronze Medical Plan for both 2024 and 2023. Both hourly employees performing services subject to prevailing wage laws and administrative monthly employees become eligible on the first day of the month following 60 days of employment. They will become a participant in the Plan on that date. Former employees are eligible to use up their remaining Plan funds until their account has been depleted. Exclusions apply to employees covered by a collective bargaining agreement, nonresident aliens with no U.S. source income, leased employees, shareholders, and those enrolled in the Kaiser Northern California Low Major Medical Plan.

Benefits

Participants may submit claims for eligible expenses incurred while covered under the plan. Reimbursements are made from the participant's individual HRA account, which is funded by employer contributions based on employment classification and eligibility criteria. The plan allows continued access to account balances for reimbursement of qualifying medical expenses after termination of employment, in accordance with plan provisions. All reimbursements are subject to substantiation requirements and must comply with the Internal Revenue Service ("IRS") guidelines for qualified medical expenses.

1. DESCRIPTION OF THE PLAN (continued)

Employer contributions

Employer contributions to the Health Reimbursement Arrangement (HRA) are made on behalf of eligible employees in accordance with plan provisions. Contributions are provided for both hourly and monthly employees. For hourly employees, contributions are based on hours worked and a set rate as agreed upon by the Sponsor. For monthly employees, contributions are made at a set monthly rate as agreed upon by the Plan Sponsor.

Plan termination

In the event the Plan terminates, any and all assets remaining in the Plan (after the payment of all expenses) shall be used for the continuance of one or more benefits of the type provided by the Plan until all assets have been expended.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting and financial statement presentation

The accompanying financial statements have been prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America ("US GAAP").

Use of estimates

The preparation of the financial statements in conformity with US GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Actual results could differ from these estimates.

Employer contributions

The Plan is funded exclusively through Employer contributions. Employer contributions are recognized when received and allocated to participant accounts based on eligibility and plan provisions. Unused balances may be carried forward.

Payment of benefits

Claim payments are recorded when paid by FBG.

Expenses

Administrative expenses are recorded to the Plan up to \$6.50 per month per participant or the remaining funds within the participant's account.

Subsequent events

The Plan has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.

3. INTEREST TRUST

The Plan utilizes The Contractors Trust Plan II (the Trust), which is a trust arrangement maintained by FBG for the benefit of multiple employee benefit plans. The Trust holds all Employer contributions made to the Plan. As of the date of this financial statement, the Trust assets solely consisted of non-interest bearing cash, which represents readily available funds to reimburse participants for qualified medical expenses incurred under the Plan.

The value of the Plan's interest in the Trust is based on the beginning of year value of the Plan's interest in the Trust plus actual contributions less payments and administrative expenses. As of December 31, 2024 and 2023, the Plan's interest in the net assets of the Trust was approximately 3.0% and 1.6%, respectively.

5. TAX STATUS

The trust established under the Plan to hold the Plan's net assets is a welfare benefit fund as defined in Section 419 of the Internal Revenue Code. As such, contributions to this welfare benefit fund by the Sponsor is subjected to certain limitations. The Trust is subject to federal income tax on unrelated income. For the years ended December 31, 2024 and 2023, the Trust paid no income taxes because there was no unrelated income earned by the Trust.

In accordance with guidance on accounting for uncertainty in income taxes, management has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. RISKS AND UNCERTAINTIES

The Trust includes cash held within a financial institution. At times, such deposits may be in excess of the Federal Deposit Insurance Corporation ("FDIC") insurance limit. Plan management does not believe the Plan is exposed to any significant credit risk.
