### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of The Woodbridge Group Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report:

### 1. Description of the Plan

The Woodbridge Group Retirement Savings Plan (the Plan) is a defined contribution plan. The Plan covers eligible salaried employees and hourly employees not covered by a collective bargaining agreement unless such agreements specifically provide for participation in the Plan, as defined in the Plan documents. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The following description of the Plan provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions, copies of which are available from the Plan administrator.

Effective July 31, 2023, Woodbridge Englewood, Inc. was removed as a participating employer as a result of the divestiture of that business operation. Impacted participants were given the opportunity to roll their balance into a new plan or take their balance within this plan as a benefit payment.

#### *Trustee and Administration of the Plan*

The trustee and recordkeeper of the Plan is Principal Trust Company (Principal or the Trustee). The administrator and sponsor of the Plan is the Woodbridge Holdings, Inc. and Participating Employers (collectively, the Company or Employer). The Trustee holds all assets of the Plan in accordance with the service provider contract with the Company. The US Pension Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### *Eligibility*

Only employees of an adopting employer will be eligible to participate in the Plan except for: (1) employees in a unit of employees covered by a collective bargaining agreement which does not provide that employees in the unit shall be covered by the Plan; (2) leased employees; (3) contract service providers; and (4) employees who are hired part-time or are full-time or part-time students in an educational program and who are not scheduled to perform more than four months of service during any Plan year.

Each non-union employee who is classified by the employer as a salaried or an hourly employee shall become eligible to participate in the Plan regardless of attained age or completed service. Each non-union employee who is classified by the employer as an hourly employee shall become eligible to participate in the Plan as of the 91<sup>st</sup> calendar day following such employee's employment commencement date. Each union employee covered by a collective bargaining agreement shall become eligible to participate in the Plan upon satisfying the age and service requirements required for their respective location and union.

#### *Contributions*

Each participant enters into a salary reduction agreement with the Company whereby contributions are made to the Plan under Section 401(k) of the Internal Revenue Code (IRC) in an amount equal to the participant's salary reduction. The voluntary salary reduction is a specified percentage of not less than 1% and not greater than 100% of the participant's annual earnings, up to a maximum as defined in the IRC.

In the year a participant attains age 50, and all years thereafter, the Plan allows for a participant to make additional catch-up 401(k) contributions. These 401(k) catch-up contributions can be made as pre-tax deferrals or Roth contributions.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a default fund until changed by the participant. Automatic enrollment deferral contributions are increased by 1% each year subsequent to enrollment up to 6%.

For all eligible salaried employees and all hourly employees not covered by a collective bargaining agreement, the employer's contribution to the Plan is non-discretionary. The Company provides an employer matching contribution in an amount specified in the Plan documents.

The participants direct their contributions and the employer contributions to their investment choices.

The Plan also allows for Roth 401(k) contributions. A participant may designate 100% of the employee deferral contribution as either a pre-tax 401(k) contribution or a Roth 401(k) contribution, or the participant may choose to allocate a portion of the contribution to both types of 401(k) contributions.

The Plan also allows for a pension alternative contribution made by the Employer. Effective January 1, 2024, the Plan was amended to extend the pension alternative contribution of 5% for those salaried employees who previously were accruing benefits in The Woodbridge Group United States Salaried Pension Plan (Pension Plan). During the year ended December 31, 2024, the total amount contributed is \$2,247,019 which is presented in employer contributions on the statement of changes in net assets available for benefits.

Effective January 1, 2024, the Plan was amended to add an enhanced contribution to provide an age and service-related benefit to certain participants specified below and grouped as provided herein. Eligible salaried employees who were hired before July 1, 2017, and who were also actively participating in the Pension Plan on December 31, 2023 (the date all participation in that plan was frozen) will share in a fully vested enhanced contribution of either 1%, 2%, or 3% of the participant's base compensation based upon combinations of age and service. For the year ended December 31, 2024, the total amount contributed is \$370,635 which is presented in employer contributions on the statement of changes in net assets available for benefits.

### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings, and is charged with an allocation of administrative expenses and investment losses. Allocations are based on the participant's earnings or account balances, as defined in the Plan documents. Forfeited employer contributions of terminated participants' non-vested accounts are used to reduce future Company contributions.

### ***Notes Receivable from Participants***

Participants are permitted to borrow a minimum of \$1,000 of their vested benefits under the Plan. Participants may borrow up to a maximum equal to the lesser of 50% of their vested account balance

or \$50,000, reduced by the highest outstanding loan balance in their account during the prior 12-month period. Loans are secured by the participant's account and bear an interest rate at the prime rate plus 1% or at local prevailing rates as determined by the Plan administrator. Principal and interest are paid through payroll deductions.

Any loan shall by its terms require that repayment (principal and interest) be in level monthly payments, over a period not extending beyond 5 years from the date of the loan, unless the purpose of the loan is to acquire, within a reasonable time, a principal residence of the participant, in which case the repayment period shall not exceed 15 years from the date of approval of the loan; otherwise, the loan is deemed distributed and written off from notes receivable from participants.

Each participant may not have more than one loan outstanding at any time.

### ***Payment of Benefits***

The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Distributions from the Plan are made in the form of lump-sum payments. Benefits become payable at normal retirement age. Benefits are also payable on disability, death, or termination of employment with the Company.

Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan documents.

Participants may also withdrawal an amount at age 59½ if certain criteria are met.

### ***Vesting***

Participants are 100% vested in all amounts at the time of contribution, except employer match contributions allocated to their accounts under the terms of the Plan documents. A participant receiving employer match contributions is vested as follows:

### ***Forfeitures***

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$34,000 and \$123,000, respectively. These accounts may be used to pay administrative expenses and reduce future employer contributions. Approximately \$490,000 of the forfeited funds were used to pay administrative expenses and/or fund employer contributions in 2024.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

### *Use of Estimates*

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and the changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on an accrual basis. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year. Dividends are recorded on the effective date.

### *Notes Receivable from Participants*

Notes receivable from participants are valued at the carrying value of the notes receivable from participants, together with accrued interest, under the amortized cost method. The fair value of the notes receivable from participants closely approximates the carrying value. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### *Contributions Receivables*

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

### *Payment of Benefits*

Benefits are recorded when paid.

### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

### *Revenue Credits*

The Plan's trust agreement with Principal provides for a participant revenue credit arrangement, whereby the trustee allocates quarterly deposits into the accounts of eligible participants who are invested in certain funds. There are no unallocated revenue credits at December 31, 2024 and 2023. During 2024, the Plan received credits of approximately \$37,000, which was used to pay

administrative expenses. Revenue credits are presented in other income in the statement of changes in net assets available for benefits.

### 3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedules, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, other income, interest and dividend income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal, a qualified institution.

### 4. Fair Value Measurements

Accounting Standard Codification (ASC) 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority on unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority on unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used as of December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual Funds* - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange

Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/Collective Funds* - The Galliard Stable Return Fund is a collective investment trust composed primarily of fully benefit-responsive investment contracts. The stable value fund is valued at the NAV, which is based on the fair value of the underlying investments less its liabilities. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. There are no unfunded commitments related to these investments. If the Plan initiates a full redemption of the stable value fund, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner. This is a direct filing entity.

The remaining common/collective funds held by the Plan are valued at the NAV of units held. The NAV is based on the fair value of the underlying investments held by the common/collective fund less its liabilities. The fair value of the underlying investments is determined using market quotations or prices obtained from independent pricing sources that may employ various pricing methods to value the investments, including matrix pricing. These common/collective funds provide for daily redemptions by the Plan at reported NAV with no advance notice. There are no unfunded commitments related to these investments. Units of these common/collective funds are classified as Level 2.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Related Party and Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by Principal or its subsidiaries and affiliates. Participant loan and distribution processing fees are paid to Principal by participants. The Plan also receives revenue credits from specific investments. The Plan also issues loans to participants, which are secured by the vested balance of the participants' accounts. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

### 6. Risks and Uncertainties

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, overall market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

### 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their participant accounts.

### 8. Tax Status

The Plan has received a determination letter from the Internal Revenue Service, dated November 12, 2013, stating the Plan is qualified under Section 401(a) of the IRC and, therefore, the related trust is exempt from taxation. Although the Plan has been amended since the date of the determination letter, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not

be sustained on examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 9. Delinquent Participant Contributions

During the Plan years ended December 31, 2024, 2023, and 2021, participant contributions and loan repayments totaling \$1,458,855, \$1,049,959, and \$893, respectively, were not remitted to the Plan within the period prescribed by Department of Labor regulations. These transactions constitute non-exempt party-in-interest transactions or prohibited transactions as defined by ERISA. The Company is in the process of correcting these transactions. The related lost earnings for certain delinquent contributions were remitted to the Plan during the years 2024 and 2025.

Automatic enrollment deferral contributions are increased by 1% each year subsequent to enrollment up to 10%.
