INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the Thomas Foods International, USA 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Thomas Foods International, USA 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Plan management, having determined it is permissible in the circumstances, has elected to have the audits of the Thomas Foods International, USA 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1. Description of Plan

The following description of the Thomas Foods International, USA 401(k) Plan (the “Plan”), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

General

The Plan is a defined contribution plan with a cash or deferred arrangement covering substantially all employees of Thomas Foods International, USA (the “Company”), except those employees who are members of a collective bargaining agreement and leased employees. Effective May 1, 2024, TFI Culinary, LLC adopted the provisions of the Plan (see Note 10). The Plan provides for salary deferral contributions, including Roth elective deferrals, safe harbor matching contributions, discretionary employer matching contributions and discretionary nonelective profit-sharing contributions, based on meeting the Plan’s eligibility requirements. Employees are eligible to immediately participate in the Plan upon completing three months of service. Participants are eligible to participate in employer safe harbor matching contributions, discretionary employer matching contributions and discretionary non-elective profit-sharing contributions upon completing one year of service.

Voya Retirement Insurance and Annuity Company, an insurance company, controls Voya Institutional Trust Company, the trustee of the Plan, (collectively “Voya”).

Contributions

Each year, participants may contribute a percentage of pretax compensation, as defined in the Plan document. Contributions may also be designated as Roth elective deferrals. For participants who do not complete a salary deferral agreement by their Plan entry date, and provided that no contrary election is made, the participant will automatically defer 3% of eligible compensation for each payroll period into the Plan. Participants who have automatic enrollment contributions made on his or her behalf will be increased annually following the initial period, as defined in the Plan document, by 1% and limited to 6% of eligible compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Plan provides for employer safe harbor matching contributions. Safe harbor matching contributions are 100% of the amount deferred that does not exceed 3% of eligible compensation, plus 50% of the amount deferred that exceeds 3% of eligible compensation but does not exceed 5% of eligible compensation.

The Company may make discretionary matching contributions. There were no discretionary employer matching contributions made for the year ended December 31, 2024.

The Company may make a discretionary non-elective profit-sharing contribution as a percentage of the participant’s gross annual compensation subject to continuing eligibility requirements. There were no discretionary non-elective profit-sharing contributions made for the year ended December 31, 2024.

Participants direct the investment of their contributions into various investment options offered by the Plan.

Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's safe harbor matching and discretionary matching contributions, if any, as well as allocations of discretionary non-elective profit-sharing contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are vested immediately in their salary deferral contributions and Company safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary matching and nonelective profit-sharing contributions is based on years of service, as defined in accordance with the following table:

Four years	60%
Five years	80%

Participants also become fully vested upon attainment of normal retirement age (55) while an employee, death while an employee or becoming disabled while an employee.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$7,729 and \$1,529, respectively. These accounts will be used to reduce administrative expenses of the Plan or future employer contributions. During the year ended December 31, 2024, \$0 was used to pay administrative expenses and \$0 was used to offset employer contributions.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in their account. In addition, the Plan allows for hardship distributions if certain criteria are met. The Plan allows for the automatic distribution of participant account balances that do not exceed \$7,000 (\$5,000 prior to modification allowed by the Setting Every Community Up for Retirement Enhancement 2.0 Act of 2022, "SECURE Act 2.0"). All vested accounts can be distributed in-service after attainment of age 59½. In addition, minimum payments must begin subject to IRS guidelines.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Borrowings are secured by the balance in the participant's account. Notes must be repaid within 5 years unless the note is for the purchase of a primary residence, which can be repaid over a reasonable period of time not to exceed 30 years. Principal and interest is paid ratably through bi-weekly payroll deductions or the participant may make a full or partial prepayment. The maximum number of loans outstanding at any time is one. Interest rates are commensurate with the prime rate plus a fixed 1.50% at the time of loan issuance. As of December 31, 2024, interest rates on loans ranged from 4.75% to 10.00%.

2. Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the Plan:

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for the fully benefit-responsive investment contract. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The financial statements include the fully benefit-responsive investment contract and its related activity on a contract value basis (see Note 5).

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by trustees, custodians and investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants (participant loans for Form 5500 reporting purposes) are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income is recorded on the accrual basis.

Contributions

Contributions from Plan participants, safe harbor matching contributions and discretionary employer matching contributions, if any, from the Company are recorded in the year in which the employee contributions are withheld from compensation. Discretionary nonelective profit-sharing contributions from the Company, if any, are recorded in the year earned.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

All reasonable administrative expenses and fees necessary to operate and administer the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses of maintaining the Plan that are paid directly by the Company are excluded from these financial statements. A participant's account may be charged for expenses associated with a specific optional feature, including administration of participant loans, elected by that participant, and are included in administrative expenses. Certain investment-related expenses are included in the net appreciation or depreciation in fair value of investments.

3. Information Certified by a Qualified Institution

The Plan administrator having determined that it is permissible in the circumstances elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) was obtained or derived from information obtained by the Plan administrator and certified as complete and accurate by Voya Retirement Insurance and Annuity Company, a qualified institution and an insurance company which controls Voya Institutional Trust Company, a qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- Investments, at fair value, fully benefit-responsive investment contract, at contract value and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.

- Investment activity, including net appreciation in fair value of investments, interest income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- The information for the pooled separate accounts, the fully benefit-responsive investment contract and the participant loans listed in the schedule of assets (held at end of year) as of December 31, 2024, as shown in the ERISA-required supplemental schedules.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

Pooled separate accounts: Valued at the net asset value ("NAV") or equivalent based on units of the pooled separate accounts. The NAV, as provided by the insurance company, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the pooled separate account less its liabilities. This practical expedient is not used when it is determined to be probable that the pooled separate account will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date. All investments of the Plan are valued using the net asset value per share practical expedient.

The Plan's pooled separate accounts are invested in a variety of funds designed to mirror the investment strategies of similar registered investment companies (mutual funds), including equity style funds, fixed income style funds, and target date funds. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of a pooled separate account, the insurance company or trustee reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.

5. Fully Benefit-Responsive Investment Contract

The Plan holds the Voya Fixed Plus Account III (the "Fixed Account"), a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. As of December 31, 2024 and 2023, the contract value amount of the fully-benefit responsive investment contract was \$300,595 and \$278,252, respectively. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings less participant withdrawals, and administrative expenses.

The Fixed Account is a group fixed annuity contract and is backed by the general account of Voya. The contract issuer is contractually obligated to repay the principal and interest at a specified rate that is guaranteed to the Plan. The Plan owns a promise to pay interest at crediting rates which are announced in advance and guaranteed for a specific period of time as outlined in the group annuity contract. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on an annual basis for resetting.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Certain events (including but not limited to: transfers from the Fixed Account may not be made directly to a competing fund; transfers from the Fixed Account will prevent transfers to a competing fund for 90 days) might limit the ability of the Plan to transact at contract value with the contract issuer. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with participants.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against the group fixed annuity contract values for credit risk of the contract issuer or otherwise.

6. Risks and Uncertainties

The Plan provides for various investment options to its participants. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. Related-Party and Party-In-Interest Transactions

Plan investments include pooled separate accounts and a fully benefit-responsive investment contract managed by Voya. Certain expenses were paid to Voya. Voya is the recordkeeper and trustee of the Plan. The Plan also issues notes to its participants, which are secured by the participants' account balance. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

During 2024, the Company failed to remit to the Plan's trustee certain employee contributions and loan repayments totaling \$236,173 within the period prescribed by the Department of Labor regulations. During 2025, the Company plans to make contributions to the affected participants' accounts to compensate those participants for potential lost income due to the 2024 processing delays. The Company believes that these transactions do not affect the tax status of the Plan and is taking action prescribed by the regulations to remedy such errors.

8. Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated or upon complete discontinuance of contributions, the rights of the participants in the Plan at the date of termination or discontinuance shall be nonforfeitable.

9. Tax Status

Effective January 1, 2021, through the adoption of a pre-approved profit sharing plan, sponsored by PA Retirement Solutions, Inc., the Plan was amended and restated. The pre-approved profit sharing plan received a favorable opinion letter from the IRS dated June 30, 2020, stating that the Plan is qualified under Section 401 of the Internal Revenue Code ("IRC") and, therefore, the related trust is exempt from taxation. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is currently designed and is operating in compliance with the applicable requirements of the IRC and the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

10. Plan Amendments

Effective May 1, 2024, TFI Culinary, LLC adopted the provisions of the Plan.

11. Subsequent Events

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.
