### **Opinion**

Self-Insured Short-Term Disability Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of benefit obligations and net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in benefit obligations and net assets available for benefits for the years then ended, and the related notes to the financial statements.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Canon Medical Systems USA, Inc. Self-Insured Short-Term Disability Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan’s provisions.

The Plan was adopted effective January 1, 1994 as a short-term disability plan to cover all eligible employees of Canon Medical Systems USA, Inc. (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**A. Eligibility**

All employees of the Company who work in the United States of America (except for California) and who regularly work at least 20 hours per week are eligible to participate in the Plan. Eligible employees are automatically covered by the Plan as of the first day of employment unless they reject coverage in writing.

**B. Contributions**

The Plan is funded by participant contributions in amounts determined by the Plan administrator annually.

In 2024, the contribution rate was 1.1% of gross wages, less Section 125 deductions, subject to an annual maximum contribution of \$1,684.80. In 2023, the rate was 0.9%, subject to an annual maximum contribution of \$1,378.48.

**C. Payments of Benefits**

Benefits commence on the first compensable day of disability, as defined in the Plan, and benefits will be paid until disability ends, up to a maximum of 52 weeks.

In 2024 and 2023, benefits were 65% of gross weekly pay, with a minimum weekly benefit of \$50 and a maximum weekly benefit of \$4,312.50.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**B. Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**C. Benefit Obligations**

Benefit obligations include the estimated cost of claims incurred prior to year-end expected to be paid subsequent to year-end.

**NOTE 3 - FUNDING POLICY**

The Plan is funded by participant contributions. Eligible employees make contributions through payroll deductions, which are deposited in a checking account. The Company has agreed to advance any monies required to pay current benefits. These funds will be repaid from future participant contributions.

**NOTE 4 - TAX STATUS**

In September 1995, the Internal Revenue Service informed the Company that, as of January 1, 1994, the Plan's trust was designed to be qualified under Section 501(c)(9) of the Internal Revenue Code. The Company believes the Plan is being operated in accordance with applicable regulations and therefore is exempt from federal income taxes and is exempt from state taxes under similar statutes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 5 - ADMINISTRATION OF THE PLAN**

The Company is the plan sponsor and administrator, and absorbs most expenses of the Plan. In 2024 and 2023, the Plan paid professional fees of \$13,650 and \$13,125, respectively.

**NOTE 6 - PLAN TERMINATION**

The Company has no present intent to terminate the Plan but reserves the right to terminate the Plan or change the funding method at any time. In the event of Plan termination, all remaining assets shall be used to provide allowable welfare benefits to the Plan's participants.

**NOTE 7 - CONCENTRATION OF CREDIT RISK**

The Plan maintains cash on deposit at Bank of America, which is insured by the Federal Deposit Insurance Corporation ("FDIC") up to \$250,000. As of December 31, 2024, the Plan's bank account balance exceeded the FDIC limit by approximately \$2,188,000.

**NOTE 8 - SUBSEQUENT EVENTS**

Management has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.


