### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of EviDent Alliance 401(k) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of EviDent Alliance 401(k) Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of EviDent Alliance 401(k) Retirement Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. **NOTE A.--DESCRIPTION OF PLAN**

The following description of the EviDent Alliance 401(k) Retirement Savings Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General:* The Plan is a defined contribution 401(k) and profit sharing plan originally established by Dkeidek, Fernyhough, Gile, Hagel, Nov & Quickstad, PLLC dba Evident Alliance effective January 1, 2019. The Plan was most recently restated and amended effective January 1, 2022 for the cycle 3 restatement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). An eligible employee is any person employed by Dkeidek, Fernyhough, Gile, Hagel, Nov & Quickstad, PLLC dba Evident Alliance or their subsidiary entities (Companies) excluding employees covered by a collective bargaining agreement, leased employees, and non-resident aliens with no U.S. income. The plan allows other employers to adopt its provisions, such as individual doctors and related entities, which are treated as affiliated service groups and therefore, as a controlled group collectively. An employee becomes eligible to participate in the plan on the first day of the month following completion of one year of service and upon reaching age 21. For eligibility purposes, an employee's years of service with previous employers may be counted. The entry date is the first day of the first month and seventh month of the Plan year following completion of eligibility requirements.

*Contributions:* The Plan is funded by eligible participant elective deferrals which may range from 1% to 100% of eligible compensation up to federal limits, employer safe harbor nonelective contributions, and discretionary additional matching contributions. The Plan is a safe harbor plan. The safe harbor nonelective formula is calculated as 3% of compensation for non-highly compensated employees. Highly compensated employees are also excluded from receiving an allocation of the safe harbor nonelective contributions but can make an election to receive a discretionary matching contribution up to 9% of compensation. Participants are automatically enrolled at 6% of eligible compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. All participants who are eligible to make elective deferral contributions may elect to designate all or any portion of their future deferrals as Roth elective deferral contributions. Participants may also contribute amounts representing distributions from other qualified retirements plans. Contributions are subject to certain limitations.

**NOTE A.--DESCRIPTION OF PLAN (Continued)**

*Participant Accounts:* Each participant's account is credited with the participant's contribution, an allocation of the Company's contributions and an allocation of plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant compensation, account balances, or specific participant transactions as applicable, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

*Vesting:* Participants are immediately vested in their rollover contributions, elective deferrals, and employer safe harbor contributions, plus actual earnings thereon. Vesting in discretionary additional matching contributions is based on a six year vesting schedule that vests 20% per year following two years of service. A participant is 100% vested after six years of credited service, upon death or disability, and if a participant is employed upon achieving early retirement age or normal retirement age.

*Retirement:* The normal retirement date is the date the participant turns 65. Early retirement is permitted at age 55.

*Payment of Benefits:* On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or other amount.

For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or may continue to participate in the plan investments and benefits will be provided upon retirement or death. For terminated participants if the balance of the vested accounts is \$200 or less, payment will be made in a lump-sum without the participant's consent. If such balance is less than \$5,000, but greater than \$200, without other election, it will automatically be rolled over into an IRA established by the Company. In-service distributions are permitted upon achieving age 59 ½. Hardship distributions are allowed in accordance with the provisions of the Plan.

*Notes Receivable from Participants:* Participants who are deemed creditworthy may borrow from all vested balances a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balances in the participant's account. Loan transactions are treated as a transfer to (from) the investment fund from (to) the loan fund. All loans must be repaid within a period of five years unless it is for a principal residence in which the term for the loan will be established by the plan administrator at the time of the loan. The loans are to bear a rate of interest that is 2% over the USA Today prime rate. The number of loans outstanding for a participant at any time is one. Principal and interest are paid through payroll deductions.

**NOTE A.--DESCRIPTION OF PLAN (Continued)**

*Forfeited Accounts:* Forfeitures are the non-vested portion of a participant's account that are lost upon termination of employment. Forfeitures are retained in the Plan and at the discretion of the Company, may be used pay the Plan's administrative expenses and/or restoration of Participant's individual account, or to reduce future Company contributions. During the year ended December 31, 2024, \$3,884 was forfeited from non-vested accounts. In 2024, \$1,737 of employer contributions were paid from forfeited non-vested accounts. As of December 31, 2024 and 2023, the balance of forfeited non-vested accounts was \$3,914 and \$1,737, respectively.

*Investment Options:* Participants are allowed to direct their contributions and account balances in a variety of investment options including mutual funds and collective trust funds. The Plan Sponsor periodically reviews the investment fund options available to participants and changes them as warranted. Participants may change their investments at any time.

*Plan Expenses:* Expenses of maintaining the Plan may be paid by the Company or the Plan. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain fees such as for distributions and administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are deducted from each funds' earnings and are included in net appreciation (depreciation) in fair value of investments.

**NOTE B.--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Accounting:* The financial statements of the Plan are prepared on the accrual basis of accounting.

*Use of Estimates:* The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the financial statements and disclosures. Accordingly, actual results may differ from those estimates.

*Investment Valuation and Income Recognition:* Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's committee determines the Plan's valuation utilizing information provided by investment advisors and the trustee and custodian. See Note D for discussion of fair value measurements.

*Investment Valuation and Income Recognition (Continued):* Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Notes Receivable from Participants:* Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

*Payment of Benefits:* Benefits are recorded when paid.

**NOTE C.--CERTIFIED INFORMATION**

Certain information related to investments disclosed in the accompanying financial statements and ERISA required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments and interest and dividend income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information and certified as complete and accurate by Charles Schwab Trust Bank (the custodian and trustee of the Plan).

**NOTE D.--FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust funds:* Valued at NAV of units held by the Plan at year end. The NAV, as provided by the trustee and custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. The net asset value of a collective trust is calculated based on a compilation of primarily observable market information. The number of units of the trust that are outstanding on the calculation date is derived from observable purchase and redemption activity in the trust. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE E.--RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are in funds managed by the custodian and trustee, Charles Schwab Trust Bank; therefore, these transactions qualify as party-in-interest transactions. Certain administrative functions of the Plan are performed by officers or employees of the Company. Certain employees of the Companies serve as trustees of the Plan. No such officer or employee receives compensation from the Plan.

**NOTE F.--TAX STATUS**

The Plan was amended and restated effective January 1, 2022 and adopted a non-standardized pre-approved profit sharing/money purchase plan with cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the Plan is designed in accordance with applicable sections of the Internal Revenue Code.

The Plan has been amended since the date of this determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination.

The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE G.--PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of Plan termination, the respective accounts of the participants under the Plan, including employer contributions, shall become fully vested and non-forfeitable.

**NOTE H.--RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as foreign currency exchange rate, interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

**NOTE I.--NONEXEMPT TRANSACTION**

*Late Remittances:*

As reported on the supplemental schedule of delinquent participant contributions (Schedule H, Line 4a), certain Plan contributions of \$57,779 for plan year December 31, 2024 and \$77,733 for December 31, 2023 and \$2,000 for December 31, 2022 were not remitted to the trust within the time frame specified by the Department of Labor's Regulation 29 CFR 2510.3-102, thus constituting nonexempt transactions between the Plan and the Company during 2025. The Company will make contributions to the affected participants' accounts subsequent to year end to compensate for potential lost earnings resulting from the delay in the contributions for the nonexempt transactions that occurred during the years ended December 31, 2022 through 2024.

**NOTE J.--SUBSEQUENT EVENTS**

Effective January 1, 2025, the Plan changed providers from Spectrum and Charles Schwab Trust Bank to ADP and Reliance Trust Company. A new adoption agreement was signed effective January 1, 2025.

Effective January 1, 2025, the Plan was restated. As part of that restatement, the Plan changed the definition of eligible employees and changed the entry dates.

Plan management has evaluated subsequent events through October 14, 2025 the date the financial statements were available to be issued.
