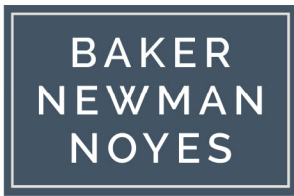

## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator, Trustees and Participants  
The RMR Group LLC 401(k) Retirement Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The RMR Group LLC 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## **Basis for Opinion**

We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Emphasis of Matter – Plan Transfer**

As discussed in Note 1 to the financial statements, on July 1, 2024, the Plan entered into a transfer agreement (the Agreement) with Carroll Management Group, LLC, previously a participating employer in the Carroll Management Group, LLC 401(k) Retirement Plan (the Carroll Plan). The Agreement specifies that all participants employed by Carroll Management Group, LLC become a participating employee in The RMR Group LLC 401(k) Retirement Plan as of the effective date. All participants employed by the Carroll Management Group LLC had their entire account balance in the Carroll Plan transferred into the Plan. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter – Supplemental Schedule Required by ERISA**

The supplemental schedule of assets (held at year end) and schedule of delinquent participant contributions as of December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1. Description of Plan

#### General

The following description of The RMR Group LLC 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan was established, effective January 1, 2000, and most recently amended as of July 1, 2024. There were no significant changes to the Plan's provisions as a result of the amendment. The Plan is a defined contribution plan covering substantially all employees of The RMR Group LLC and its related entity, RMR Advisors LLC, (collectively, the Company or the Employer) who are age 21 and over, except for union employees, nonresident aliens, leased employees and independent contractors reclassified as employees. Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (the Trustee) serves as the trustee for the Plan and Principal Life Insurance Company (PLIC) serves as the recordkeeper for the Plan. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). All investments are participant directed.

On December 29, 2022, the *Setting Every Community Up for Retirement Enhancement Act of 2022* (SECURE 2.0 Act) was signed into law. It includes mandatory and optional provisions impacting defined contribution plans. Applicable provisions outlined in the SECURE 2.0 Act have been or will be adopted if elected and/or required.

#### Eligibility

Employees become eligible to make pre-tax and/or after-tax (Roth) contributions, and to receive Company matching contributions, as of the date they reach age 21.

Employees are eligible to receive Company discretionary contributions if they are an active participant on the last day of the Plan year.

#### Contributions

Participants may defer up to 100% of eligible compensation, as defined by the Plan, on a pre-tax basis up to a dollar limit established under the Internal Revenue Code (the Code). Participants are also permitted to make Roth elective 401(k) contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company provides safe harbor matching contributions in an amount equal to 100% of participants' elective deferrals up to the first 3% of eligible compensation, plus 50% of the participant's elective deferral contributions that exceed 3% of eligible compensation, but do not exceed 5% of eligible compensation. For the years ended December 31, 2024 and 2023, employer safe harbor matching contributions amounted to \$3,233,991 and \$2,989,731, respectively.

### 1. Description of Plan (Continued)

At the discretion of the Company's Board of Directors, the Company may make a discretionary contribution to the Plan. Any discretionary contributions are allocated to participants in the same ratio as each eligible participant's compensation bears to the total of such compensation to all eligible participants. For the years ended December 31, 2024 and 2023, there were no discretionary contributions made to the Plan.

Participants may select the investments in which their accounts are invested from among a variety of available investment options.

#### Vesting

Participants are immediately vested in their voluntary contributions and any employer contributions, plus actual earnings thereon.

#### Participant Accounts

Each participant's account is credited with the participant's contributions and a proportionate allocation of any Company contributions and Plan earnings or losses, and charged with an allocation of administrative expenses, as applicable. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Notes Receivable From Participants

The Plan allows loans to employees participating in the Plan. The amount of any loan shall be at least \$1,000 and shall not exceed the lesser of (a) \$50,000 reduced by the individual's highest outstanding loan balance during the twelve-month period ending on the day before the date the new loan is made; or (b) 50% of the individual's account balance. Notes must be repaid within five years, unless the proceeds are used to buy a principal residence. The interest rate will be based on the rates available for similar loans from commercial lending institutions, as determined by the Plan Administrator. Interest rates ranged from 4.25% to 9.50% as of December 31, 2024 with various maturities through November 2053.

Each loan is collateralized by the borrower's interest in the Plan and is evidenced by a promissory note. Loan repayment and interest is made through payroll deduction. Loan fees are assessed against an individual participant's account.

#### Participant Withdrawals

On termination of service, death, disability, or retirement, a participant may receive a lump-sum or installment payments in an amount equal to the vested value of their account. The Plan permits hardship withdrawals due to financial hardship as defined in the Plan document, from participants' pre-tax elective deferral account and employer discretionary account. In-service distributions are allowed once a participant reaches the age of 59½ from all the participant's vested accounts. In-service distributions are also allowed anytime from a participant's rollover account. Distribution payments can either be cash distributions to the participant or a tax-free rollover to an individual retirement account or another qualified plan. If a participant's vested account balance is less than \$1,000, the Plan Administrator, after notification, may distribute the account balance to the participant.

### 1. **Description of Plan (Continued)**

Included in the SECURE 2.0 Act provisions was a required change to the age at which required minimum distributions must commence from 72 to 73 for individuals who attain age 72 on or after January 1, 2023 and from age 73 to 75 for individuals who attain age 73 on or after January 1, 2033.

#### Administrative Expenses

Expenses resulting from participant loans, certain investment fees, certain general administration and recordkeeping fees, and fees related to lump-sum distributions are deducted directly from participant accounts. All other administrative expenses are paid by the Company.

#### Transfers

Effective May 1, 2023, the Plan entered into a transfer agreement (the Agreement) with ABP Trust, previously a participating employer in the Sonesta Plan. The Agreement specifies that all participants employed by ABP Trust become a participating employee in The RMR Group LLC 401(k) Retirement Plan as of the effective date. All participants employed by the ABP Trust had their entire account balance in the Sonesta Plan transferred to the Plan.

Effective July 1, 2024, the Plan entered into a transfer agreement (the Agreement) with Carroll Management Group, LLC, previously a participating employer in the Carroll Management Group, LLC 401(k) Retirement Plan (the Carroll Plan). The Agreement specifies that all participants employed by Carroll Management Group, LLC become a participating employee in The RMR Group LLC 401(k) Retirement Plan as of the effective date. All participants employed by the Carroll Management Group LLC had their entire account balance in the Carroll Plan transferred to the Plan.

### 2. **Summary of Significant Accounting Policies**

#### Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

#### Risks and Uncertainties

The Plan provides for various investment options which are exposed to various risks such as interest rate, market volatility, liquidity and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the value of investment securities in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

#### Investment Valuation and Income Recognition

Investments in mutual funds and pooled separate accounts are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

The guaranteed investment contract is reported at contract value, as determined by Principal Life Insurance Company, as it is considered fully benefit-responsive. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 5.

Purchases and sales of investment securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes realized gains and losses on investments that were both bought and sold during the year as well as net unrealized appreciation on investments held at year end.

#### Contributions

Participant contributions are reported in the period in which payroll deductions are made; employer matching contributions are recorded in the same period as corresponding participant contributions. Employer discretionary contributions are recorded in the year the Company commits to make the contribution.

#### Payment of Benefits

Benefits are recorded when paid.

#### Notes Receivable From Participants

Notes receivable from participants are carried at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

#### Subsequent Events

Events occurring after the statement of net assets available for benefits date are evaluated by management to determine whether such events should be recognized or disclosed in the financial statements. Management has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

### 3. Tax Status

A qualifying plan is one for which the employer may currently deduct contributions on its income tax return, the employee is not currently taxed on the contribution, and the plan income is not taxable.

The underlying prototype nonstandardized profit sharing plan has received a letter dated June 30, 2020 from the Internal Revenue Service (IRS) that the form of the Plan was acceptable under section 401(a) of the Code. Although the Plan has been amended since receiving the determination letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. Management has evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there currently are no audits for any tax periods in progress.

### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. Assets that are measured at fair value using the net asset value (NAV) per share practical expedient have not been classified in the fair value hierarchy.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled Separate Accounts:* Valued at the NAV of units of the separate account. The NAV, as provided by PLIC, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the account less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. These units are not traded on a securities exchange but are redeemable only by the issuer. The rate of return varies based upon each fund's experience. These accounts do not distribute dividends or interest to the Plan; rather, investment performance is reflected in the change in the unit value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the separate account, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Contract With Insurance Company

The Plan has a fully benefit-responsive group annuity contract issued by Principal Life Insurance Company (Principal). Principal maintains the contributions in a general account. The account is credited with the earnings on the underlying investments and is charged for participant withdrawals and certain administrative expenses charged by Principal. The contract is included in the financial statements at contract value, as reported to the Plan by Principal. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and certain administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The contract is backed by Principal's general account, which is invested in a diversified portfolio, consisting predominately of fixed-income investments. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a semiannual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the insurance company under the group annuity contract. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures, or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such events that would limit the Plan's ability to transact at contract value with participants is probable. In the event the Company elects to terminate the contract, the Company must provide a twelve-month notice of its intent to terminate the contract.

### 6. Information Certified by the Trustee

Plan asset information disclosed in the accompanying financial statements and supplemental schedule relating to investments, related net appreciation in fair value of investments, participant loans, interest on participant loans, participant loan transactions, interest and dividends, and related investment transactions, was certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, the Plan's trustee, as of December 31, 2024 and 2023 and for the years ended December 31, 2024 and 2023. The Plan has determined that Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company meets the requirements of a qualified institution as defined by the United States Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Therefore, in accordance with the request of the Plan's Administrator and as allowed under ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, this information was not subjected to auditing procedures generally accepted in the United States of America by the Plan's independent auditors except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplemental schedule.

### 7. **Party-in-Interest Transactions**

Plan investments include pooled separate accounts and a guaranteed investment account managed by PLIC, an affiliated company of the Trustee. Therefore, these transactions qualify as exempt party-in-interest transactions.

PLIC provides certain administrative services to the Plan pursuant to a Service and Expense Agreement (Service Agreement). Investment fund related revenue received by PLIC typically includes Rule 12b-1 fees paid by the fund or the fund's affiliates. This revenue is used to offset certain amounts owed to PLIC for its administrative services to the Plan. If the revenue received by PLIC exceeds the amount owed under the Service Agreement, the excess is allocated to Plan participants as a fee adjustment. If the revenue received by PLIC is less than the amount owed under the Service Agreement, the excess expense is allocated to Plan participants as a fee adjustment. During the years ended December 31, 2024 and 2023, the Plan recorded \$32,591 and \$60,489, respectively, in revenue pursuant to the Service Agreement, which is reported as other income on the statement of changes in net assets available for benefits, and was applied towards certain administrative expenses. The remaining expenses totaling \$284,988 and \$158,406 for the years ended December 31, 2024 and 2023, respectively, were allocated to participant accounts. Fees paid directly by the Plan to PLIC for other administrative services totaled \$28,307 and \$15,365 for the years ended December 31, 2024 and 2023, respectively.

Notes receivable from participants also qualify as exempt party-in-interest transactions as defined by ERISA.

### 8. **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

### 9. **Reconciliation of Financial Statements to Form 5500**
