INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Burbank Housing Management Corporation Tax Deferred Annuity (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024, and the related statement of changes in net assets available for benefits (modified cash basis) for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section —

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with modified cash basis of accounting, as described in Note 2 to the financial statements.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Burbank Housing Management Corporation Tax Deferred Annuity and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with modified cash basis of accounting described in Note 2 and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibility for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter

Supplemental Schedules Required by ERISA

NOTE 1 – DESCRIPTION OF PLAN

The following description of Burbank Housing Management Corporation (Burbank) Tax Deferred Annuity (the Plan) provides only general information. Participants should refer to the Plan agreement or Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Burbank. The Plan, adopted in 2013 and amended in 2024, is designed to comply with the applicable sections of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

As defined in the Plan, participants under the age of 50 may contribute, as of their date of hire, up to \$23,000 for 2024. Participants who have reached the age of 50 and over before the end of the Plan year are eligible to make catch-up contributions of \$7,500 for 2024. These limits are set forth by the Internal Revenue Service and may vary to reflect changes in the Consumer Price Index. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Plan also allows participants to make designated Roth contributions on an after-tax basis.

The Plan provides that Burbank may contribute a discretionary matching contribution, on a per payroll period basis, for eligible employees. Burbank elected to contribute up to 4% of a participant's eligible compensation, determined based on years of participation as follows: 2% during the first year, 3% during the second year, and 4% during the third and subsequent years of participation. Effective August 2024, Burbank elected to provide a matching contribution equal to 50% of participant contributions, up to a maximum of 4% of eligible compensation, as defined in the Plan. Burbank contributed matching contributions totaling \$263,239 to the Plan in 2024.

Vesting

Participant and Burbank contributions, and related earnings thereon, are immediately vested.

Participant Accounts

Each participant account is credited with the participant's contributions, Burbank's contributions, and earnings thereon, and charged with an allocation of administrative expense, if any, that are charged to the Plan and not paid directly by Burbank. Expense allocations are based on participant account balances or charged in an equal amount to all participant accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

The Plan's investments were held by Charles Schwab Trust Bank (Charles Schwab) and Voya Retirement Insurance and Annuity Company (Voya) at December 31, 2024. However, Voya is no longer offered as an investment platform under the Plan.

Upon enrollment, participants may direct their accounts to be invested among the investment options currently offered through Charles Schwab, as approved by Burbank. Participants may also change their investment elections for future contributions or transfer existing balances between funds in accordance with procedures established by Charles Schwab.

Benefit Payments

On termination of service due to retirement, separation of service, disability, or death, a participant may elect to receive either a lump-sum amount or installments equal to the value of the participant's vested interest in his or her account. The Plan also provides for hardship distributions to current employees under certain circumstances.

Forfeitures

Any forfeiture of employer contributions and earnings thereon are applied to pay Plan administrative expenses, if any, and then to reduce future employer discretionary non-elective and matching contributions that would otherwise be made to the Plan.

Administrative Expenses

The Plan paid administrative fees to Charles Schwab and Voya in the amount of \$45,042 for the year ended December 31, 2024.

Plan Termination

Although it has not expressed any intent to do so, Burbank has the right under the Plan to discontinue contributions and terminate the Plan at any time subject to the provisions of ERISA.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan prepares its financial statements under the modified cash basis of accounting. Contributions and investment income are generally recorded when received rather than when earned, and benefits and administrative expenses are recognized when paid rather than when the obligation is incurred.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for the fully benefit-responsive investment which is reported at contract value. Under generally accepted accounting principles, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Generally accepted accounting principles establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to observable inputs (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy based on inputs are as follows:

Level 1 – Valuations are based on unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access and therefore do not entail a significant degree of judgment.

Level 2 – Valuations are based on significant inputs that are observable, either directly or indirectly, or quoted prices in markets that are not active, that is, markets in which there are few transactions, the prices are not current or price quotations vary substantially over time or among market makers.

Level 3 – Valuations are based on inputs that are unobservable and significant to the overall fair value measurement and therefore require more judgment.

Following is a description of the valuation methodology used for investments measured at fair value:

Registered Investment Companies (Mutual Funds):

The fair value of mutual funds is based on the net asset value per share of each fund held by the Plan at year-end, as determined by Charles Schwab and Voya. Such investments are categorized as Level 1 of the fair value hierarchy.

Insurance Company General Account (Fixed Account):

The fair value of the fixed accounts offered by Voya and is determined based on the methodology as described in the annuity contracts. The calculations generally consider yields on comparable securities, the fixed account rates as internally set and approved by Voya, and the annuity contracts' issuance dates. Such investments are categorized as Level 2 of the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value could result in a different fair value measurement at the reporting date.

Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) from registered investment companies reflect earnings on the respective underlying funds, including dividends and realized and unrealized gains and losses during the year.

Net asset value and fair value were equal for all investments held by the Plan at December 31, 2024. Additionally, there were no unfunded commitments to purchase investments at December 31, 2024. There were no imposed redemption restrictions on participants.

Fully Benefit-Responsive Investment - Insurance Company General Account (Stable Asset Fund):

The Plan invests in the Standard Stable Asset Fund, which is a group annuity contract issued by Standard Insurance Company. The contract is backed by the general account of the insurer and is designed to provide a stable rate of return while preserving principal. The fair value of the investment is based on the contract value as reported by Standard Insurance Company, which represents contributions plus earnings credited, less participant withdrawals and administrative expenses. The Plan's investment is considered fully benefit-responsive. The crediting interest rate is set by the Standard Insurance Company on a quarterly basis using a process similar to that used by banks and other insurance companies for similar products. The issuer's ability to meet its contractual obligations is dependent on its financial strength and creditworthiness.

Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

Subsequent Events

Management has evaluated subsequent events through October 13, 2025, the date on which the financial statements were available to be issued.

As of December 31, 2024, investments consist of mutual funds, units of fixed accounts and stable asset funds in an insurance company general account. All investments are participant-directed.

NOTE 4 – INFORMATION CERTIFIED BY THE PLAN’S CUSTODIANS

The investments from participants included in the statements of net assets available for benefits (modified cash basis) at December 31, 2024, and the related investment income included in the statements of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, as well as the information provided in Note 3 and the supplemental Schedule of Assets (Held at End of Year), have been derived from information certified as complete and accurate by Charles Schwab and Voya, the custodians, in accordance with Section 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 5 – RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Charles Schwab, Voya, ABG Consultants (investment advisor), and PCS Retirement (recordkeeper) are parties-in-interest under ERISA, and as such, related transactions qualify as party-in-interest transactions. Fees paid by the Plan related to administrative services amounted to \$45,042 for the year ended December 31, 2024.

Burbank also paid for certain administrative expenses related to the Plan amounting to \$3,161.

NOTE 6 – TAX STATUS

The Plan is a participant in the CCH Incorporated DBA FTWilliam Com Volume Submitter 403(b) Plan which is acceptable under section 403(b) of the Internal Revenue Code (IRC) pursuant to an opinion letter dated March 2017. The plan administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC.

The plan administrator believes that it has appropriate support for any tax positions taken, and as such, does not have any uncertain tax positions that are material to the financial statements. The Plan’s federal Form 5500 is subject to examination by regulatory agencies generally for three years after filing.

NOTE 7 – RISKS AND UNCERTAINTIES

The Plan invests in mutual funds, units of fixed accounts and stable asset funds in an insurance company general account. Such investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated, it is at least reasonably possible that changes in the values of investments will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits (modified cash basis).
