To the Retirement Plan Committee and Participants of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of *Panoramic Health 401(k) Plan* ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

(1) Description of Plan

The following description of the *Panoramic Health 401(k) Plan* (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- A. **General** – The Plan is a defined contribution 401(k) profit sharing plan covering all employees, except part-time employees working less than 1,000 hours in the Plan year, of its participating employers, who are age 21 or older. Participants enter the Plan on the first of the month coinciding with or following completion of such requirements. Participants must have six months of service to be eligible for employer contributions. The Plan was established on March 1, 1997 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan is a profit-sharing plan, which qualifies under Section 401(k) of the Internal Revenue Code of 1986. The Plan provides for retirement, disability, and death benefits for eligible employees.

Effective April 8, 2024, the Plan was amended to add participating employers including Kidney Specialists of South Texas, Nephrology, Dialysis and Transplantation Assoc. PA, Permian Basin Kidney Center, Inc., San Antonio Kidney Disease Center Physicians Group, LLC, and Southwest Nephrology Associates LLP.

- B. **Contributions** – Each year, participants may contribute up to 75% of their compensation on a pre-tax or Roth basis, as defined in the Plan, subject to certain Internal Revenue Code ("IRC") limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, common collective trusts and self-directed brokerage accounts as investment options for participants. The self-directed brokerage accounts are participant directed investment accounts which provide participants options to invest in various stocks, exchange-traded fund or mutual fund securities.

The Plan has a qualified automatic contribution arrangement (QACA) where participants are automatically enrolled in the Plan following eligibility at a pre-tax contribution rate of 6%, unless an election is made to contribute a different percentage or unless the participant declines participation in the Plan. These participants' investments will default to one of the Fidelity Freedom funds, based upon each participant's projected retirement date, unless otherwise directed by the participants.

The Employers make safe harbor non-elective QACA contributions of 3% of compensation for each eligible participant. The Employers may also make discretionary matching, discretionary non-elective, and discretionary qualified non-elective contributions each year to the Plan. No employers made a discretionary contribution for 2024.

- C. **Participant accounts** – Each participant's account is credited with the participant's contributions and an allocation of (a) Employer contributions and (b) Plan earnings. Allocations are based on participant compensation, contributions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(1) Description of Plan (continued)

- D. **Vesting** – Participants are immediately vested in their voluntary and rollover contributions plus actual earnings thereon. Participants are also immediately vested in the Employer qualified non-elective contributions plus actual earnings thereon. Vesting in the Employer safe harbor non-elective QACA contributions and discretionary contributions is based on years of continuous service. A participant is 20% vested after two years of service and vests an additional 20% each year thereafter until fully vested. See the plan document for additional vesting schedules for specific circumstances. If a participant reaches normal retirement age (age 65), dies, or becomes totally disabled, the participant becomes fully vested in the Plan, irrespective of years of service.
- E. **Notes receivable from participants** – A participant may borrow from his or her account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of his or her vested account balance. A participant may have up to two notes outstanding at a time. Note terms range from one to five years, except that the note term may be as long as ten years if the purpose is for the purchase of a primary residence. The note is secured by the balance in the participant's account and bears interest at the prime rate plus 2%, which is fixed at the time the note is made. Interest rates on participant notes receivable outstanding at December 31, 2024 ranged from 3.25% to 10.5%. Principal and interest is paid ratably through payroll deductions. Upon termination from employment, the note receivable is considered to be in default and the entire amount outstanding is due and payable by the participant.
- F. **Payment of benefits** – Payment of benefits is only available upon retirement, death, total and permanent disability, or termination. Participants who have reached age 59½ may also request payment of benefits. Benefits may be paid in one lump-sum payment or as an annuity. Upon termination of service, distribution of balances in excess of \$1,000 may be deferred until normal retirement age and then paid. Participants may withdraw or borrow from their account as set forth in the provisions of the Plan document for hardship or loans.
- G. **Forfeitures** – Forfeited Employer contributions are used to reduce future Employer contributions and pay administrative expenses. Forfeited non-vested accounts totaled approximately \$823,000 and \$398,000 at December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, forfeited non-vested accounts totaling \$7,797 and \$88,701 were utilized to reduce Employer contributions and pay administrative expenses, respectively.
- H. **Administrative expenses** – Substantially all administrative expenses of the Plan are paid by the Employers and are not reimbursed by the Plan.
- I. **Termination of the Plan** – Although it has not expressed an intention to do so, the Employers have the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event the Plan is terminated, participants shall become 100% vested in their account balances.

(2) Significant accounting policies

The significant accounting policies followed by the Plan are as follows:

Basis of accounting – The financial statements of the Plan are prepared on the accrual method of accounting. Accordingly, income and contributions are recognized when earned and expenses are recorded when incurred.

Management's use of estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of net assets and the reported amounts of additions to and deductions from net assets. Actual results may differ from those estimates.

Investment valuation and income recognition – Investments in shares of mutual funds are stated at net asset value, which are readily determinable fair values of those shares as they are published daily and are the basis for current transactions. The self-directed brokerage account investments in mutual funds are also stated at net asset value, which are readily determinable fair values of those shares as they are published daily and are the basis for current transactions. Common stock, limited partnerships, options, a money market fund, exchange-traded notes and exchange-traded funds in the self-directed brokerage accounts are valued at the closing price reported on the active market on which the securities are traded. Common collective trusts are valued based upon the current fair value of the underlying assets of the funds, or the equivalent of net asset value, which is a practical expedient for estimating fair value. These investments have no unfunded commitments as of December 31, 2024 and 2023, and can be redeemed daily with no redemption notice period or other redemption restrictions.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and uncertainties – The Plan provides for various investment options. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Notes receivable from participants – Notes receivable from participants are measured at their unpaid principal balance plus accrued interest.

Payment of benefits – Payment of benefits are recorded when paid.

Subsequent events – Plan management has evaluated subsequent events through October 14, 2025, which is the date the financial statements of the Plan were available to be issued.

(3) Fair value measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

These methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair value. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4) **Information certified by the Plan's trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company ("FMTC"), the Plan's trustee, has certified that the following information included in the accompanying financial statements and supplemental schedules is complete and accurate:

- Investments, at fair value
- Notes receivable from participants
- Interest income on notes receivable from participants
- Interest and dividends
- Net appreciation in fair value of investments
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

(5) **Party-in-interest transactions**

Certain Plan investments are shares of mutual funds, common collective trusts, and self-directed brokerage accounts, managed by FMTC. FMTC is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to parties-in-interest amounted to \$60,709 for the year ended December 31, 2024.

(6) **Income tax status**

The Prototype Plan received an opinion letter from the IRS dated June 30, 2020, stating that the Prototype Plan was designed in accordance with applicable sections of the IRC. Management has not obtained an individual determination letter for the Plan. The Prototype Plan has been amended since receipt of the opinion letter consisting primarily of changes to ERISA. Management and the Plan Administrator believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC and that the Plan was qualified and the related trust remains tax-exempt at December 31, 2024. Accordingly, no provision for income taxes has been made in the accompanying financial statements.

(7) **Delinquent participant contributions**

The Employers remitted certain participants' contributions to the Plan later than required by the Department of Labor regulations during the Plan year ended December 31, 2024. The late contributions amounted to \$2,667,688 and Plan management is in the process of calculating lost earnings using the Department of Labor's Fiduciary Correction Program online calculator. The late contributions are in the process of being corrected outside of the Voluntary Fiduciary Correction Program during the 2025 Plan year. The Plan Administrator does not expect the correction to affect the Plan's tax-exempt status.

The late contributions are in the process of being corrected outside of the Voluntary Fiduciary Correction Program during the 2025 Plan year. The Plan Administrator does not expect the correction to affect the Plan's tax-exempt status.

The Employers remitted certain participants' contributions to the Plan later than required by the Department of Labor regulations during the Plan year ended December 31, 2021. The late contributions amounted to \$824,018 and Plan management is in the process of calculating lost earnings using the Department of Labor's Fiduciary Correction Program online calculator. The late contributions are in the process of being corrected outside of the Voluntary Fiduciary Correction Program during the 2025 Plan year. The Plan Administrator does not expect the correction to affect the Plan's tax-exempt status.

(8) **Subsequent events**

Effective January 1, 2025, the Plan was amended to remove the exclusion of part-time employees from eligibility. Part-time employees are now an eligible class of employees for participation in the Plan following the normal eligibility requirements.
