Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of KIOXIA America, Inc. 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF THE PLAN

The KIOXIA America, Inc. 401(k) Savings Plan (the “Plan”) is a defined contribution plan that covers employees of KIOXIA America, Inc. (the “Company”). The Plan was formed on January 1, 2018 as a result of the spin-off of accounts from the Toshiba America, Inc. 401(k) Savings Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The assets of the Plan are held in a trust by T. Rowe Price Trust Company.

THE PLAN DOCUMENT INCLUDES DETAILED RULES FOR EACH SITUATION. PARTICIPANTS AND OTHER INTERESTED PARTIES SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

A. Participation

Company employees are generally eligible to participate in the Plan as soon as administratively practicable after their recruitment and attaining age 21. Enrollment is automatic for newly hired employees once eligibility requirements are satisfied.

B. Benefits

Benefits under the Plan may commence when a participant retires, becomes disabled, dies or ceases to be an employee. Normal retirement age is 65. Financial hardship and age 59½ withdrawals are permitted.

C. Vesting

A participant is fully vested immediately as to voluntary contributions, rollover contributions, company contributions and related earnings.

D. Contributions

Participants may elect to defer up to 75% of pre-tax or after-tax Roth annual compensation, as defined in the Plan, subject to Internal Revenue Code (IRC) limitations. Catch-up contributions and rollovers from qualified plans are allowed. The Company made safe harbor matching contributions of 100% of participant’s elective deferrals in each pay period, up to 4% of compensation. The Company may elect to make discretionary contributions, but elected to make no such contributions for 2024.

E. Notes Receivable from Participants

Participants may borrow from their accounts up to the lesser of \$50,000 or 50% of the vested account balance. The minimum loan is \$1,000. Only one loan may be outstanding at any one time. Loans must be repaid within five years, except that loans for the purchase of a principal residence may be repaid over a period not to exceed ten years. Interest on loans is charged at a reasonable rate. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants at December 31, 2024 carry interest rates ranging from 4.25% to 9.50%.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Investment Valuation and Income Recognition

Participants select how their share of plan assets will be invested among those investment vehicles made available.

Accounting guidance establishes a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market.

Level 1 – Inputs are quoted prices in an active market.

Level 2 – Inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

D. Risks and Uncertainties

The Plan invests in various investments, which are exposed to various risks and such as interest rate, market, and credit risk. Due to the level of risk associated with investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

NOTE 3 - INCOME TAX STATUS

The Internal Revenue Service issued its latest determination letter dated May 1, 2019, stating that the Plan was designed in accordance with applicable IRC requirements as of that date. The Plan has since been amended, however, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions.

NOTE 4 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The accounts of the participants affected by a partial or complete termination of the Plan are nonforfeitable and will be determined as of the termination date, which will be treated as the valuation date.

NOTE 5 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023 and investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by T. Rowe Price Trust Company, the trustee of the Plan.

NOTE 6 - RELATED PARTY TRANSACTIONS

Certain investments held by the Plan are managed by T. Rowe Price, an affiliate of the trustee. Transactions related to these investments qualify as party in interest transactions; however, they are exempt from the prohibitions under ERISA.

NOTE 7 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 1, 2025, the date the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.
