Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**1. Description of Plan**

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of its provisions.

***General***

The Plan is sponsored by Atlantic Plumbing Supply Corp. (the “Company” or “Plan Sponsor”) with an effective date of January 1, 2017. The Plan is a defined contribution plan covering all eligible employees of the Company. Employees are eligible to begin salary deferrals after one year of service and attainment of age twenty-one, as defined by the Plan. The Plan is subject to the provisions of ERISA and has been updated to the Setting Every Community Up for Retirement Enhancement Act (“SECURE Act”) of 2019.

In March 2020, the Coronavirus Aid, Relief, and Economic Security Act (“CARES Act”) was signed into law. The CARES Act includes numerous employee benefit plan provisions to assist plan sponsors and participants. The Plan has implemented certain CARES Act provisions.

***Contributions***

Eligible employees may contribute up to 100% of their eligible compensation on a pretax basis to the Plan, subject to eligible compensation limits as determined annually by the Internal Revenue Service (“IRS”). The Company matches 100% of the first 3% and 50% of the next 2%, up to 4% maximum of the employee’s compensation contributed as elective deferrals. The Company may also elect to make an additional discretionary contribution to the Plan. For the years ended December 31, 2024 and 2023, the employer did not make a discretionary contribution. Participants may contribute amounts representing rollover distributions from other qualified retirement plans. For the years ended December 31, 2024 and 2023, the maximum total for both employer and employee contributions could not exceed \$69,000 and \$66,000, respectively, for participants age 49 or younger, or \$76,500 and \$73,500, respectively, for participants age 50 or above.

***Vesting***

Upon enrollment into the Plan, participants are immediately vested in their own contributions and the Company’s matching contributions, plus actual earnings thereon. Vesting in employer discretionary contributions plus earnings thereon is based upon years of credited service. The vesting schedule reflects 20% vesting per year of employment after two years of credited service; all employees are fully vested after six years of credited service. Balances related to frozen safe harbor profit sharing contributions made under a prior version of the Plan, plus actual earnings thereon, were immediately vested at the time of those prior-year contributions.

**1. Description of Plan (Continued)**

***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's contribution, allocations of plan earnings (losses) and an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit which can be provided from the participant's vested account.

***Investment Options***

Participant accounts are invested, in accordance with investment directions provided by the participant, allocating his/her account among a variety of investment options offered by the Plan. Participants may change their investment options at any time.

***Loans***

Participants may borrow amounts from their vested account balance up to a maximum equal to the lesser of \$50,000 or 50% of the value of their vested account balance, less any outstanding loans. No more than two loans may be outstanding at any given time. The loans have terms of up to five years, unless for the purchase of a primary residence, in which case the term is ten years, and are interest bearing and secured by the participant's account balance. All loans bear a fixed rate of interest, generally prime plus 1%, as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

***Payment of Benefits***

Upon reaching 59-1/2 years of age, a participant may withdraw all or a portion of their vested account balance at any time and for any reason. Upon termination of service due to death, disability or retirement, the participant or beneficiary will be entitled to a distribution of the vested account balance. The normal form of payment with respect to the vested account balance is a single lump-sum payment in cash or in-kind. An optional form of payment with respect to the vested account balance is installments payable in cash or in-kind over a period not to exceed the participant's expected future lifetime, or the joint expected future lifetime of the participant and his/her spouse. In addition, participants are eligible for distributions due to financial hardship under certain conditions, as defined.

***Forfeitures***

If a participant terminates employment with the Company and is less than 100% vested in the employer contribution, the participant will forfeit the non-vested portion. Forfeitures of non-vested employer contributions are used to reduce employer contributions under the Plans and to offset Plan administration expenses. For the years ended December 31, 2024 and 2023, the Company made all their employer contributions to the plan in March of 2025 and 2024, respectively. In 2024, the Company did not use forfeitures to offset employer contributions to the Plan. At December 31, 2024 and 2023, the forfeited non-vested accounts totaled \$585 and \$70, respectively.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (“GAAP”).

***Valuation of Investments and Income Recognition***

The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly fashion between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date and interest income is recorded on the accrual basis. Net appreciation/depreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year and net of any advisory fees.

***Use of Estimates***

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Notes Receivable from Participants***

Participant loans are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis, if material. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

***Payment of Benefits***

Benefits are recorded when paid.

***Administrative Expenses***

Certain administrative expenses, such as participant loan origination fees and recordkeeping fees, are paid out of participants’ accounts. Other expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation/depreciation of fair value of investments and are not readily determinable.

***Risk and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

**3. Fair Value Measurements**

FASB ASC Topic 820 “*Fair Value Measurements and Disclosures*” establishes a framework for measuring fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Values are based on unadjusted quoted prices for identical assets or liabilities in an active market that can be accessed at the measurement date (e.g. actively traded securities).

Level 2 – Values are based on quoted prices in markets where trading occurs infrequently or based on quoted prices of instruments with similar attributes in active markets, or based on inputs other than quoted prices that are observable for the asset or liability (e.g. corporate and municipal bonds which trade infrequently).

Level 3 – Values are based on prices or valuation techniques that require inputs that are both unobservable and significant to the overall fair value measurement.

The asset’s or liability’s fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. All of the Plan’s assets that are valued within the fair value hierarchy are Level 1 assets.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Registered Investment Companies:* These are mutual funds held by the Plan that are investments registered with the Securities and Exchange Commission and are valued at the registered investment company’s Net Asset Value (“NAV”) as reported by the fund. These funds are required to publish their NAV and to transact at that price. The NAV is based on the value of the underlying assets owned by the fund minus its liabilities and then divided by the number of shares outstanding calculated at the close of business on the New York Stock Exchange. The mutual funds held by the Plan are deemed to be actively traded.

*Money Market Fund:* This money market fund held by the Plan invests in short term securities that are guaranteed or issued by the US Government or a US Government Agency and valued at Fair Value at a point in time.

*Common/Collective Trusts (“CCT”):* The Plan has investments in CCT funds. CCT fund fair values are determined by the respective fund managers using NAV as a practical expedient. The NAV is based on the value of the underlying assets owned by the fund minus its liabilities and then divided by the number of shares (units) outstanding. There were no significant unfunded commitments or restrictions on redemptions at December 31, 2024 and 2023.

**3. Fair Value Measurements (Continued)**

The CCT in the Plan is The Putnam Stable Value Fund which calculates its fair market value primarily based on its "book value" or "contract value," which is essentially the initial principal deposited, plus accumulated interest, minus withdrawals and expenses, rather than directly reflecting the market value of its underlying investments; the fund's crediting rate is adjusted periodically to maintain this stability, taking into account market fluctuations and aligning the book value with the market value over time.

This Fund invests in high-quality guaranteed investment contracts ("GICs") and similar contracts issued by insurance companies, banks and other financial institutions. The Fund also invests up to 75% of its assets in security-backed investment contracts ("SBICs"), including separate account products of insurance companies. The foregoing instruments are collectively referred to herein as "Investment Contracts". The Fund invests at least 5% of its assets in high-quality money market instruments, cash, cash equivalents and stable value funds (including fixed income funds underlying SBICs) with investment policies and other provisions similar to those of the Fund, and may invest without limit in these investments.

The valuation methods as described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Tax Status**

The Plan adopted a volume submitter defined contribution plan sponsored by Fidelity Management & Research Company, which obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has since been amended; however, the

**5. Tax Status (Continued)**

Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires the plan administrator to evaluate tax positions taken by the Plan, and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or DOL. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of an asset or a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. In addition, there are no tax related interest or penalties reflected on these financial statements.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in all of their account balances.

**7. Party-In-Interest Transactions**

Certain Plan investments are managed by Fidelity Management Trust Company, the trustee, or its affiliates, and therefore these transactions qualify as party-in-interest transactions. The Company provides certain accounting, administrative and investment management services to the Plan for which no fees are charged and pays directly certain other fees related to the Plan's operations.

In addition, certain participants borrowed from the Plan. As of December 31, 2024 and 2023, notes receivable from participants totaled \$397,260 and \$360,934, respectively. The rates of interest charged on the notes ranged from 4.25% to 9.50% as of December 31, 2024, and the notes mature at various dates through 2042. Each participant is a party-in-interest to the Plan and these notes were exempt party-in-interest transactions pursuant to Section 408(b)(1) of ERISA.

**8. Subsequent Events**

***Date of Management's Review***

The Plan has evaluated subsequent events through October 15, 2025, which is the date the financial statements were available to be issued. Based on this evaluation, the Plan has determined that no subsequent events have occurred which require disclosure in or adjustment to financial statements.

There were two large withdrawals totaling \$2.5 million in March of 2025, representing lump sum retirement distributions to two long-standing employees. These two transactions represented just under 20% of the total net assets available for benefits at December 31, 2024.
