Management is also responsible for maintaining a current plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on these financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of KerberRose S.C. 401(K) Profit Sharing Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about KerberRose S.C. 401(K) Profit Sharing Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matters – Supplemental Schedules Required by ERISA**

The supplemental schedules of Schedule H, Line 4a - Schedule of Delinquent Participant Contributions and Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**NOTE 1 - Description of Plan**

The following brief description of the KerberRose S.C. 401(K) Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General** - The Plan is a defined contribution plan, as adopted effective January 1, 2001, and restated June 1, 2022, covering substantially all employees of KerberRose S.C., KerberRose Wealth Management, LLC and Retirement Plan Partners, LLC (collectively referred to as the “Company”), who have attained the age of 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions** - Participants may elect to contribute a portion of their compensation to the Plan, not to exceed the amount allowed by the Internal Revenue Service (IRS). Participants may also contribute amounts representing distributions from other qualified retirement plans. Participants may direct their contributions to various investment options offered by the Plan. If eligible participants do not make an election to participate in the Plan, they are auto-enrolled at a contribution percentage of 6%. All investments are participant-directed. Each year, the Company will make a safe harbor matching contribution and can make a discretionary employer contribution to the Plan. To be eligible for the discretionary employer contribution, the individual must have completed one year of service.

During 2024 and 2023, the Plan sponsor made a safe harbor matching contribution equal to 100% on the first 4% of employee salary deferrals and an additional 2% discretionary employer contribution.

**Participant Accounts** - Each participant's account is credited with the participant's contribution and an allocation of (a) the Company’s safe harbor matching contribution, (b) the Company’s discretionary employer contributions and (c) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are immediately vested in their voluntary contributions and rollover contributions, if any, plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service, as defined by the Plan document. Participants are 100% vested in the Company’s discretionary employer contributions after six years of credited service and two years of service for the Company’s safe harbor matching contribution.

**Participant Loans** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants are only allowed to have two loans outstanding at one time. Loan terms generally range from one to five years, but may be longer if for the purchase of a primary residence. The loans are secured by the vested balance in the participant’s account and bear a reasonable rate of interest as based on the prime interest rate at the time the loan is taken out. Interest on loans ranges from 3.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits** - Upon a participant’s attainment of normal retirement age (62), disability, termination of service or death, the participant or their beneficiary is entitled to receive the value of his or her vested account balance in the form of a lump-sum distribution. If the vested benefit is less than \$1,000, a lump sum distribution will be made regardless of whether or not the participant has consented to a distribution. Hardship distributions from participants’ voluntary contributions are permitted if certain criteria are met. The Plan also provides for in-service distributions upon the attainment of age 59 1/2.

**NOTE 1 - Description of Plan - Continued**

**Administrative Expenses** - All administrative expenses may be paid out of the Plan unless paid by the Plan sponsor. During 2024 and 2023, expenses were paid by both the Plan and the Plan sponsor.

**Forfeited Accounts** - Nonvested portions of participants' accounts will be forfeited upon termination of employment. These accounts may be used to reduce plan expenses, may be allocated to as additional employer contributions or may be used to reduce other employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$16,825 and \$23,136, respectively. During 2024 and 2023, the Plan sponsor reduced their profit-sharing contribution to the Plan by \$10,174 and \$30,198 from forfeited nonvested accounts, respectively. Additionally, during 2024, the Plan sponsor reduced plan expenses by \$10,300 from forfeited nonvested accounts.

**NOTE 2 - Summary of Significant Accounting Policies**

A summary of the significant accounting policies applied in the preparation of the accompanying financial statements and supplemental schedule is as follows:

**Basis of Accounting and Presentation** - The financial statements of the Plan are prepared using the accrual method of accounting and are presented in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) as codified by the Financial Accounting Standards Board.

**Notes Receivable from Participants** - Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

**Investment Valuation and Income Recognition** - Investments are reported at fair value (except for the fully benefit-responsive contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Contributions** - Contributions from Plan participants and the matching contributions from the Plan sponsor are recorded in the year in which the employee contributions are withheld from compensation.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Payment of Benefits** - Benefits are recorded when paid.

**Reclassifications** - Certain items in the prior year comparative information have been reclassified, with no effect on net assets available for benefits, to conform with the presentation in the current year financial statements.

**Subsequent Events** - The Plan has evaluated subsequent events through October 14, 2025, the date which the financial statements were available to be issued.

**NOTE 3 - Fair Value Measurements**

The Plan has determined the fair value of certain assets in accordance with the provisions of U.S. GAAP, which provides a framework for measuring fair value under generally accepted accounting principles.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under U.S. GAAP are described as follows:

---

**Level 1**      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

---

**Level 2**      Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

---

**Level 3**      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

**Common Collective Trust Funds:** Valued at the daily closing price as reported by the fund. These funds publish their daily net asset value (NAV) and to transact at that price. The common collective trust funds held by the Plan are deemed to be actively traded.

**Pooled Separate Accounts:** Valued at the daily closing price as reported by the fund. These funds publish their daily net asset value (NAV) and to transact at that price. The pooled separate accounts held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 - Fully Benefit-Responsive Investment Contract**

The Plan has entered into fully benefit-responsive investment contracts. These contracts meet the fully benefit-responsive investment contract criteria and, therefore, are reported at contract value. Contract value is the relevant measure for the fully benefit-responsive investment contract because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. As of December 31, 2024 and 2023, the contract value of the fully benefit-responsive investment contracts was \$1,598,681 and \$3,455,195, respectively.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specific rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer and may not be less than the guaranteed minimum interest rate set forth in the contract of 1.0%. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

**NOTE 4 - Fully Benefit-Responsive Investment Contract - Continued**

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Those events may be different under the contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

**NOTE 5 - Information Certified by the Plan Custodians**

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends for the years ended December 31, 2024 and 2023, was obtained or derived from the information furnished to the Plan administrator and certified as complete and accurate by VOYA Retirement Insurance and Annuity Company (November 16, 2023 to December 31, 2024) and Lincoln Financial Group Trust Company, Inc. (January 1, 2023 to November 15, 2023), the custodians of the Plan. Notes receivable from participants have not been certified by VOYA Retirement Insurance and Annuity Company at December 31, 2024 or 2023.

**NOTE 6 - Tax Status**

The Plan sponsor became a participating employer in the Retirement Plan Partners, LLC Volume Submitter Plan and Trust with CODA effective January 1, 2001, most recently restated June 1, 2022, and is relying on its determination letter dated June 30, 2020. The Plan and the related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. The Plan Trustees and the Plan's tax counsel believe it is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan Trustees have analyzed the tax positions taken by the Plan, and have concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

**NOTE 7 - Transactions with Parties-in-Interest**

Certain Plan investments are managed by Lincoln Financial Group Trust Company, Inc (January 1, 2023 to November 15, 2023) or VOYA Retirement Insurance and Annuity Company (November 16, 2023 to December 31, 2024). Lincoln Financial Group Trust Company, Inc. and VOYA Retirement Insurance and Annuity Company ("VOYA") are the custodians for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

VOYA provides certain administrative services and receives revenue from investment fund service providers for services VOYA provides to the funds. This revenue is used to offset certain amounts owed to VOYA for its administrative services to the Plan.

If the revenue received by VOYA from such investment fund service providers exceeds the amount owed, VOYA remits the excess to the Plan's trust. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024 and 2023, VOYA remitted \$30,496 and \$0 to the Plan, respectively. These amounts have been net against administrative expenses on the statements of changes in net assets available for benefits.

Fees for legal and professional services rendered to the Plan may be paid for by the Company at its discretion. The Plan allows participants to take out loans against their account balances. These transactions are considered party-in-interest transactions.

The above transactions are not considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.

**NOTE 8 - Amounts Owed to Participants Withdrawing from the Plan**

There were no amounts owed to participants who had elected to withdraw from the Plan, but had not been paid as of December 31, 2024 and 2023.

**NOTE 9 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 10 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

**NOTE 11 - Reconciliation of Financial Statements to Form 5500**
