Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

1. DESCRIPTION OF THE PLAN

The following brief description of the EdenRoc Sciences, LLC 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan qualifying under Section 401(a) of the Internal Revenue Code (“IRC”) and is subject to the provisions of Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was established for the purpose of providing eligible employees of EdenRoc Sciences, LLC (the “Company” or “Employer”) and their beneficiaries funds for retirement.

Eligibility

All employees are eligible to participate in the Plan immediately after the attainment of 18 years of age.

Employee Contributions

An employee participating in the Plan may annually contribute through payroll deductions up to the limits determined by the Internal Revenue Service (“IRS”). Participants may contribute amounts representing distributions from other qualified plans. Any participant, age 50 or over, may make an additional “catch-up” contribution as determined by the IRS. Participants direct the investment of their contributions into various investment options offered by the Plan.

Employer Contributions

The Company elected to have a safe harbor plan and makes qualified matching contributions of 100% of the participant's contribution up to a maximum of 3% of compensation per calendar year, plus 50% of the participant's contribution over 3%, but not over 5% of compensation per calendar year.

Participant Accounts

Individual accounts are established for each participant. The Plan offers a variety of mutual funds and a money market fund as investment options. Each participant's account is credited with the participant's contributions, the Company contributions, and the proportionate share of dividends, interest, and investment gains since the preceding valuation date. The participant's account is reduced by withdrawals, an allocation of expenses, losses on investments, and any forfeitures. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested in all contributions made to their account immediately.

Distributions and Withdrawals

Prior to age 59-1/2, distributions and withdrawals are not permitted from the Plan except in the instances of hardship, death, disability, or termination of employment. Hardship withdrawals may be taken. After attaining age 59-1/2, participants may elect to withdraw an amount equal to any whole percentage not to exceed 100% of the participant's vested account for any reason. In the event of termination of employment, a participant shall receive, as a lump-sum distribution, their participant contributions, and earnings thereon and vested Company contributions and earnings thereon.

Notes Receivable from Participants

The Plan allows for participants to have one outstanding loan at any given time for financial hardship or financial needs. All loans are considered a direct investment of the participant, and payments of principal and interest are credited to the participant's account. The minimum a participant may borrow is \$1,000, and the maximum is 50% of their vested account balance, not to exceed \$50,000. Principal and interest are paid ratably through payroll deductions.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accounting records of the Plan are maintained on the accrual basis of accounting.

Valuation of Investments and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Interest and dividend income recorded are on the accrual basis. Fair value measurements are discussed in Note 3.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year. In addition, certain investment related expenses have been included with net appreciation in the fair value of investments.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Administrative Expenses

The expenses necessary to administer the Plan are either paid by the Company or allocated to each participant at the Company's option. They include, but are not limited to, retaining necessary professional assistance from an attorney, an accountant, an actuary, or an investment advisor.

Participants are charged service fees for any loan and distribution transactions they request. For the year ended December 31, 2024, the Plan paid administrator fees of **\$780**.

Payment of Benefits

Benefits are recorded when paid.

Forfeited Accounts

Forfeitures of non-vested Employer contributions will first be applied to pay administrative expenses of the Plan, with any excess used to reduce the Employer's contributions during the current Plan year or future Plan years. The balance in the forfeiture account at December 31, 2024 and 2023 was **\$1,160 and \$1,019**, respectively. During the year ended 2024, no forfeiture account funds were utilized.

Risks and Uncertainties

The Plan invests in investment securities. Investment securities are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024, or 2023. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

3. FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - Unobservable inputs that are supported by little or no market activity and that are financial instruments whose values are determined using pricing models, discounted cash flow methodologies, or similar techniques, as well as instruments for which the determination of fair value requires significant judgment or estimation.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for the Plan's assets measured at fair value. There have been no changes in the methodologies used for the periods presented in these financial statements.

Money Market Fund and Mutual Funds: Shares of mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. PLAN TERMINATION

The Company intends to continue the Plan indefinitely for the benefit of its employees but reserves the right to modify, amend, or terminate the Plan at any time by resolution of its Trustees. In the event of termination of the Plan, all amounts credited to participants' accounts shall be 100% vested and non-forfeitable. All participants shall receive a total distribution of their accounts as described in the Plan. Any amount in the forfeiture account upon termination, which has not been applied to reduce the Company contribution, shall be allocated on a pro rata basis to the participant's account.

5. INFORMATION CERTIFIED BY TRUSTEE (UNAUDITED)

No auditing procedures were performed by the independent auditor as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA with respect to information certified as complete and accurate by the trustee, Ascensus Trust Company, except for comparing such information with information reported in the financial statements. Based on information provided and certified by the trustee, there are no fixed income obligations, leases, or debt instruments in default or deemed uncollectible, as defined by ERISA, for the year ended December 31, 2024.

6. INCOME TAX STATUS

The Plan adopted a prototype standardized profit sharing with Cash or Deferred Arrangement (“CODA”) plan. By letter dated January 1, 2018, the IRS has determined that the prototype plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. The Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRS. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress. In addition, there are no tax related interest or penalties for the periods presented in these financial statements.

7. RELATED-PARTY TRANSACTIONS

Certain Plan investments are shares of mutual funds and a money market fund managed by Vanguard. Fees paid by the Plan for account maintenance amounted to **\$780** for the year ended December 31, 2024.

8. DELINQUENT PARTICIPANT CONTRIBUTIONS

For the year ended December 31, 2024, the Company did not remit certain participant contributions to the Plan on a timely basis as defined by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Untimely remittances identified on the Schedule of Delinquent Participant Contributions, totaled \$129,237, in 2024. Additionally, the Company will be compensating participants for lost earnings resulting from the delay in contributions.

9. RECONCILIATION OF INFORMATION CONTAINED IN THE FINANCIAL STATEMENTS AND INFORMATION CONTAINED IN FORM 5500

The Plan’s financial statements are on the accrual basis of accounting which includes recording contributions receivable. However, the IRS Form 5500 does not require the use of the accrual basis of accounting, and as such, the Plan sponsor prepares the IRS Form 5500 on the cash basis of accounting. Accordingly, the IRS Form 5500 does not report contributions receivable.
