**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

**NOTE A - DESCRIPTION OF PLAN**

The following description of the Bobcat Enterprises, Inc. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan is a defined contribution plan covering employees of the Company who as of any entry date have completed six months of eligibility service and who have attained eighteen years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

2. Contributions

Each year, the Company will contribute the amount of the total salary reduction elections of all participants, which may range to one hundred percent of each participant's compensation, subject to certain limitations. Effective April 1, 2021, all new plan participants will automatically have 5% of eligible compensation withheld and contributed to the plan, unless an affirmative election not to contribute is made. These contributions are fully vested at all times. A discretionary matching amount, as determined each year by the Company, may be contributed out of current or accumulated profits. Additional profit sharing amounts may be contributed at the option of the Company's board of directors. The intention of the Plan is that the Company shall meet the minimum benefit and contribution requirements of applicable sections of the Internal Revenue Code.

3. Participant Accounts

The Plan provides that the interest of each participant in plan assets shall be in the form of individual accounts for each participant, former participant and beneficiary. Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings or loss. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

4. Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution and earnings thereon is based on years of continuous service. A participant is 100 percent vested after six years of service.

5. Death Benefits

The death benefits with respect to each participant shall be paid to the participant's designated beneficiary. The value of benefits will equal the amount credited to the participant's account, regardless of the number of years worked.

6. Retirement Benefits

Upon the attainment of "normal retirement date", the participant's 65th birthday, the full value of the participant's account will become fully vested and available for distribution. The value of a participant's account will be paid in a lump sum. A participant may request postponement of payment of the retirement benefit, but not beyond April 1 of the calendar year following the year the participant attains age seventy and one-half.

7. Forfeitures

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeitures can be used to pay administrative expenses of the Plan or to offset employer contributions. Excess forfeitures are allocated among participant accounts according to the Plan provisions. However, if a participant is re-employed and fulfills certain requirements, as defined in the Plan, that participant's account will be reinstated. No forfeitures were used to offset administrative expenses or employer contributions in 2024 or 2023. Unallocated forfeitures were \$44,430 and \$19,526 on December 31, 2024 and 2023, respectively.

8. Participant Loans

Plan participants may apply for a loan. The loan may not exceed 50% of the participant's vested account balance and the maximum dollar amount of the loan outstanding to any participant may not exceed \$50,000. Plan provisions require that loans must be evidenced by a signed promissory note and bear interest at 1% over the prime rate. The term of the loan may not exceed five years, except loans used to acquire a principal residence may not exceed 30 years. Loan payment of principal and interest must be made through payroll deductions, provided that the Plan Administrator may allow payment by other means for prepayment in full. Participants on authorized leave of absence, as determined by the Plan Administrator, can request suspension of loan repayments.

9. Subsequent Events

Subsequent events have been evaluated through October 10, 2025, which is the date the financial statements were available to be issued.

**NOTE B - SUMMARY OF ACCOUNTING POLICIES**

The financial statements have been prepared in conformity with generally accepted accounting principles as applied to pension and profit sharing plans. The following are the significant accounting policies followed by the Plan:

1. Method of Accounting

The Plan uses the accrual basis of accounting.

2. Investment Valuation and Income Recognition

Assets which will be used to satisfy liabilities to Plan participants are stated at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Pooled separate accounts are stated at fair value as determined by the issuer of the account based on the net asset value of the underlying investments, as a practical expedient. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

3. Estimates and Assumptions

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

4. Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

5. Payment of Benefits

Benefits are recorded when paid.

**NOTE C - FUNDING POLICY**

All contributions to the Plan are deposited in the Trust Fund. All assets of the Trust Fund, including investment income, are retained for the exclusive benefit of participants, former participants, and beneficiaries, and are used to pay benefits to such persons or to pay administrative expenses of the Plan and Trust Fund, to the extent not paid by the Company. Contributions do not revert to or inure to the benefit of the Company.

**NOTE D - TAX STATUS**

The Trust established under the Plan is qualified pursuant to the appropriate section of the Internal Revenue Code, and accordingly, the Trust's net investment income is exempt from income taxes. The Plan was most recently amended and restated effective April 1, 2021. The Plan has been provided an opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the prototype plan adopted by the Plan sponsor, as then designed, complied with the applicable requirements of the Internal Revenue Code. The Plan administrator and the Plan's tax counsel believe

that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related Trust was tax-exempt as of the financial statement date.

**NOTE E - PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan. In the event of the dissolution, merger, consolidation, or reorganization of the Company, the Plan will terminate subject to the provisions of ERISA.

**NOTE F – ADMINISTRATION OF PLAN ASSETS**

Voya Retirement Insurance and Annuity Company (Voya) holds the Plan's assets, which consist principally of units of pooled separate accounts and a group pension investment contract. Employee and Company contributions are held and managed by Voya, which invests contributions received and interest and dividend income, and makes distributions to participants, and administers payments of interest and principal on participant loans. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses are paid by the Company or by deductions from fund balances.

**NOTE G – INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan has a benefit-responsive investment contract with Voya Retirement Insurance and Annuity Company (Voya). Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. The contract is included in the financial statements at contract values of \$546,007 and \$531,905 as reported to the Plan by Voya as of December 31, 2024 and 2023, respectively. The fair values of the investment contract on December 31, 2024 and 2023 were \$494,269 and \$483,275, respectively.

Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Certain events limit the Plan's ability to transact at contract value with Voya. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption for federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with Plan participants or Voya, is probable.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on an agreed-upon formula with the issuer, but it may not be less than 1%. Such interest rates are reviewed on an annual basis for resetting.

**NOTE H - PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of pooled separate accounts and an investment contract managed by Voya Retirement Insurance and Annuity Company. Voya Retirement Insurance and Annuity Company is the asset custodian, as defined by the Plan, and, therefore, transactions with these funds qualify as party-in-interest transactions.

**NOTE I – INFORMATION CERTIFIED BY THE ASSET CUSTODIAN**

All information disclosed in the accompanying financial statements, notes and supplemental schedule related to the Plan's investment assets at December 31, 2024 and 2023, and the related net dividend, interest and other income, and the related net appreciation in fair value of investments for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Voya Retirement Insurance and Annuity Company.

**NOTE J – FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits, except for fully benefit-responsive investment contracts, which are recorded at contract value. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The following is a description of the valuation methods used for assets measured at fair value:

Pooled Separate Accounts – Pooled separate accounts (“PSAs”) are privately managed through investment companies and are not publicly quoted. PSAs are comprised, primarily, of shares of registered investment companies held through sub-accounts of an insurance company. The PSAs are valued using net asset value (“NAV”) as a practical expedient to estimated fair value where NAV is based on the value of the underlying investment assets held through sub-accounts of a separate account of an insurance company. This practical expedient is not used when it is determined to be probable that the account will sell the investment for an amount different than the reported NAV. The Plan has

concluded that the NAVs reported by the investment companies approximate the fair value of the investments. There are currently no redemption restrictions or unfunded commitments on these investments.

**NOTE K – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and amounts reported in the statement of net assets available for benefits.
