## Independent Auditor's Report

To the Plan Administrator and Participants

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Belco Community Credit Union Cash Balance Defined Benefit Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. - Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Other Matter - Supplemental Schedule Required by ERISA**

The supplemental schedules of Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements, but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from, and relates directly to, the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to, or derived from, the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to, or is derived from, the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in accordance with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## **Note 1 - Description of Plan**

The following description of the Belco Community Credit Union Cash Balance Defined Benefit Plan and Trust (the Plan) provides only general information. Participants should refer to the plan agreement for more complete information.

### **General**

The Plan is a non-contributory defined benefit cash balance pension plan covering substantially all employees of Belco Community Credit Union (the Credit Union). Employees become eligible after the completion of six months of service and enter the Plan on the first day of the plan year after meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### **Funding Policy**

The Credit Union's policy is to contribute funds to the Plan in such amounts as are required on an actuarial basis to provide the Plan with assets sufficient to meet the benefits to be paid to plan participants. To the extent that these requirements are fully covered by assets in the Plan, the Credit Union may elect not to make a contribution in a particular year. The Credit Union's contributions for the years ended December 31, 2024 and 2023, met or exceeded the minimum funding requirements of ERISA.

Although it has not expressed any intent to do so, the Credit Union has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### **Vesting**

A participant is 100% vested in their accrued benefit upon attainment of normal retirement age (65) while employed by the Credit Union, or upon completion of three years of credited service, based on the following vesting schedule:

#### **Pension Benefits**

Grandfathered participants (employees whose continuous employment with Belco Community Credit Union began prior to July 1, 2008 and who are not rehired after July 1, 2008) with three or more years of service are entitled to annual pension benefits beginning at normal retirement age (65) equal to the product of 60% of their average annual compensation up to the Social Security integration level, plus a benefit equal to 12.50% of their average annual compensation in excess of the Social Security integration level, reduced proportionately for each year of service less than 25 at the normal retirement date.

Participants that were hired by Cornerstone Federal Credit Union on or before December 31, 2011 with three or more years of service are entitled to annual pension benefits beginning at normal retirement age (65) equal to the sum of 40% of their average annual compensation plus 10% of such average annual compensation in excess of \$9,996, reduced proportionately for each year of service less than 20 at the normal retirement date.

Participants that were hired by Cornerstone Federal Credit Union after December 31, 2011 with three or more years of service are entitled to annual pension benefits beginning at normal retirement age (65) equal to the accrued benefit determined as of June 30, 2017, if any, plus the actuarial equivalent of the hypothetical account (as defined in the following paragraph).

Employees with three or more years of service, other than grandfathered participants and former employees of Cornerstone Federal Credit Union, are entitled to pension benefits beginning at normal retirement age (65) equal to the accrued benefit determined as of December 31, 2009, if any, plus the actuarial equivalent of the hypothetical account. A participant's hypothetical account is the sum of the participant's hypothetical allocations equal to 4.00% of the participant's compensation for such plan years and interest credits as of the date of determination, as defined in the plan agreement. Interest credits are tied to the annual rate of interest on 30-year Treasury securities as of the second calendar month preceding the first day of the plan year containing the determination date. As of December 31, 2024 and 2023, the interest rate was 4.54% and 4.66%, respectively.

The Plan permits early retirement at ages 55 - 64 with five years of service as a participant in the Plan, however, under this election the accrued benefit may be reduced as defined in the plan agreement. The normal form of benefit payment is a joint and 50% survivor annuity for married participants and a lifetime annuity for participants who are not married. Participants may elect to receive their vested benefit in the form of a single lump sum payment, joint and survivor annuity, life annuity, or life annuity with term certain.

Participants are eligible for death and disability benefits. In the event of any active employee's death, the spouse will receive a death benefit. Effective May 1, 2019, if the employee was unmarried, the named beneficiary will receive a death benefit. Prior to May 1, 2019, no death benefits were paid to unmarried participants. A death benefit equal to the "minimum spouse's death benefit" is to be paid. This amount is equal to the amount that would have been paid under a joint and 50% survivor annuity. Active employees who become totally and permanently disabled will be entitled to receive benefits pursuant to the early retirement benefit section of the plan agreement without regard to the age and service requirements.

### **Note 2 - Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities, and the actuarial present value of accumulated plan benefits at the date of the financial statements. Actual results could differ from those estimates. The Plan uses an actuary to determine the actuarial present value of accumulated plan benefits. A change in the actuarial assumptions used could significantly change the amount of the actuarial present value of accumulated plan benefits reported in the accompanying notes to the financial statements.

#### **Investment Valuation and Income Recognition**

Except for the guaranteed investment contract, investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan's guaranteed investment contract is a deposit administration account with CMFG Life Insurance Company and is valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less funds used to purchase annuities and pay administrative expenses charged by CMFG Life Insurance Company.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

The Plan's expenses are paid either by the Plan or the Credit Union, as provided by the plan document. Expenses that are paid by the Credit Union are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

#### **Actuarial Present Value of Accumulated Plan Benefits**

Accumulated plan benefits are those future periodic payments, including lump-sum distributions, that are attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to: (a) retired or terminated participants or their beneficiaries, (b) beneficiaries of participants who have died, and (c) present participants or their beneficiaries. Benefits under the Plan are based on employees' compensation for the highest five consecutive years. Benefits payable under all circumstances (retirement, death, disability, and termination of employment) are included to the extent they are deemed attributable to employee service rendered to the valuation date. Benefits to be provided via annuity contracts excluded from plan assets are excluded from accumulated plan benefits.

The actuarial present value of accumulated plan benefits is determined by an independent actuary and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The significant actuarial assumptions used in the valuations as of December 31, 2024 and 2023, are as follows:

- Asset valuation - Plan assets are valued at market value
- Discount rate - 6.50% compounded annually
- Mortality - The RP 2014 Mortality Table Projected to 2025 by Scale MP 2021 (the RP 2014 Mortality Table Projected to 2024 by Scale MP 2021 was used for 2023)
- Retirement age - Normal retirement age (age 65)
- Salary increases - 4.50%

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. If the Plan were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated plan benefits. The computations of the actuarial present value of accumulated plan benefits were made as of January 1, 2025 and 2024. Had the valuations been performed as of December 31, 2024 and 2023, there would be no material differences.

### **Note 3 - Information Certified and Provided by Matrix Trust Company**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Matrix Trust Company, the custodian of the Plan.

### **Note 4 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;

- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

Registered investment companies are valued at the net asset value of shares held by the Plan at year-end.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **Note 5 - Investment Contract with Insurance Company**

The Plan has a deposit administration contract with CMFG Life Insurance Company (CMFG), which is a general account insurance contract under which the Plan makes contributions into as required by the provisions of the Plan. CMFG maintains the contributions in an unallocated fund to which it added interest at the initial guaranteed rate of 1.70% through the initial guaranteed interest rate expiration date of June 30, 2014. Thereafter, there is no minimum guaranteed rate of interest. Interest is credited at the then-current effective annual interest rate declared by CMFG. Interest rates are reviewed quarterly and were 1.65% and 2.05% at December 31, 2024 and 2023, respectively. Interest credited to the Plan for the years ended December 31, 2024 and 2023 totaled \$127,435 and \$133,302, respectively. At the direction of the Plan Administrator, a single premium to buy an annuity for a retiring employee is withdrawn by CMFG from the unallocated fund. Purchased annuities are contracts under which CMFG is obligated to pay benefits to named employees or their beneficiaries. The premium rates for such annuities to be purchased in the future are also guaranteed by CMFG. Funds under the guaranteed investment contract that have been allocated and applied to purchase annuities (that is, CMFG is obligated to pay the related pension benefits) are excluded from the Plan's assets.

In accordance with FASB ASC *Plan-Accounting-Defined Benefit Pension Plans* topic, insurance contracts should be presented in the same manner as the Form 5500. The Form 5500 permits unallocated insurance contracts for defined benefit plans to be reported at either current value or as determined on the Schedule A of Form 5500, at contract value. This is an exception to the general rule requirement of the *Plan-Accounting-Defined Benefit Pension Plans* topic that plan investments be presented at fair value.

### **Note 6 - Tax Status**

The Credit Union has adopted a pre-approved plan document that was sponsored by CMFG Life Insurance Company. The pre-approved document has received an opinion letter from the IRS, dated February 28, 2023, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the Plan Administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and; therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the U.S. Federal, state, or local tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 7 - Plan Termination**

In the event of Plan termination, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

- A. Annuity benefits that former employees or their beneficiaries have been receiving for at least three years, or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under plan provisions in effect at any time during the five years preceding Plan termination.
- B. Other vested benefits insured by the Pension Benefit Guaranty Corporation (PBGC) (a U.S. Government agency) up to the applicable limitations.
- C. All other vested benefits (that is, vested benefits not insured by the PBGC).
- D. All nonvested benefits.

Certain benefits under the Plan are insured by the PBGC if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations, and may also depend on the financial condition of the plan sponsor and the level of benefits guaranteed by the PBGC.

### **Note 8 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Plan contributions are made and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

### **Note 9 - Related Party Transactions and Party-In-Interest Transactions**

Certain plan investments include a guaranteed investment contract issued by CMFG Life Insurance Company. CMFG Life Insurance Company is the recordkeeper and actuary for the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to CMFG Life Insurance Company for contract administrator fees and recordkeeping fees amounted to \$83,484 and \$73,168 for the years ended December 31, 2024 and 2023, respectively.

### **Note 10 - Subsequent Events**

Plan management has evaluated subsequent events through October 8, 2025. This date is the date the financial statements were available to be issued. No material events subsequent to December 31, 2024 were noted.


