## INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Analytical Services & Materials, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### **NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Analytical Services & Materials, Inc. 401(k) Profit Sharing Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan covering all eligible employees of the Company who have at least three months of service and are age twenty-one or older. Plan entry is the quarter following satisfaction of eligibility. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### ***Contributions***

Each year, participants may contribute up to 100% of their pretax annual compensation as defined in the Plan. Contributions are subject to certain limitations. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers eleven mutual funds, nine pooled separate accounts, and fourteen collective investment trust as investment options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Participants may also rollover amounts from other qualified plans. Participants over the age of 50 are eligible for catch-up contributions. Once a participant obtains 1,000 or more hours of service in the Plan year, the Company may make matching contributions equal to a discretionary percentage of the participant's eligible wages.

#### ***Participant Accounts***

Each participant's combined account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) plan earnings including net appreciation and net depreciation of the fund, and charged with an allocation of administrative expenses. Allocations of fund earnings are based upon the proportion that each participant's fund account bears to the total of all participants' accounts in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

#### ***Vesting***

Employees become 100% vested in employer contributions upon being eligible to enter the Plan. Participants are immediately vested in their voluntary contributions, rollovers, and Plan earnings; thus, the Plan has no forfeitures.

#### ***Payment of Benefits***

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or monthly installments. Furthermore, upon approval of the Plan Administrator, participants may be entitled to take hardship distributions. In-service distributions are allowed for participants who have reached the age of 59 ½ or normal retirement age. For termination of service due to other reasons, a participant may receive the value of the interest in his or her account as a lump-sum distribution.

#### ***Payment of Benefits (Continued)***

Participants that have terminated employment and have a balance of less than \$5,000 will receive a distribution as soon as administratively feasible.

In March 2020, Congress passed the Coronavirus Aid, Relief, and Economic Security Act (CARES Act), in response to the global outbreak of the novel coronavirus (COVID-19). The CARES Act included several relief provisions available to tax qualified retirement plans and their participants. In 2020, the Plan opted out of adopting any of the CARES Act provisions.

#### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. Note terms range from 1 to 5 years or up to 25 years for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at a fixed rate commensurate with prevailing interest rates charged on similar commercial loans. Interest rates ranged from 3.50% to 8.50% on loans outstanding at December 31, 2024 and 3.25% to 8.50% at December 31, 2023. Principal and interest are paid ratably through payroll deductions.

### **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

#### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investment bought and sold as well as held during the year.

#### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting. Investments held by a defined contribution plan are required to be reported at fair value, except for fully-benefit responsible investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

### **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

#### *Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

#### *Payment of Benefits*

Benefits are recorded when paid.

#### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

### **NOTE 3 – INFORMATION PREPARED AND CERTIFIED BY CONTRACT ADMINISTRATOR**

The following information included in the accompanying financial statements and supplemental schedule as of December 31, 2024 and 2023, and for the year ended December 31, 2024, was obtained from data that has been prepared and certified to as complete and accurate by Principal Life Insurance Company (Principal), the trustee. The Plan's investments are held in a trust fund administered by Principal. All investments are participant directed. The following table presents investments at December 31, 2024 and 2023.

### **NOTE 5 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### **NOTE 6 – TAX STATUS**

In 2014, the Plan adopted a non-standardized pre-approved 401(k) Plan, which has received a favorable opinion letter from the Internal Revenue Service (IRS) dated March 31, 2014. The Plan has been amended and that amendment has received a favorable opinion letter from the IRS dated June 30, 2020. The advisory letter has been relied upon by the Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely or not would be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **NOTE 7 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### **NOTE 8 – PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by Principal Life Insurance Company. Principal Life Insurance Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$92,657 and \$84,942 for the years ended December 31, 2024 and 2023, respectively.

### **NOTE 9 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1 – Inputs to the valuation methodology are quoted (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly such as, - Quoted prices for similar assets or liabilities in active markets; - Quoted prices for identical or similar assets or liabilities in inactive markets; - Inputs other than quoted prices that are observable for the asset or liability; - Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs that are unobservable inputs for the asset or liability.

The asset or liability's fair measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds* are valued at the daily closing price as reported by the fund. The mutual funds held by the Plan have quoted market prices available on an active market.

*Pooled separate accounts (PSA)* consist of various investment options (i.e. common stock, mutual funds, fixed securities, and real estate). For 2024 and 2023, the underlying securities have observable level 1 quoted pricing inputs. The NAV of the pooled separate account is not publicly quoted but is available to current investors via the Employer website or when plan participants access their account values. The NAV is the basis for current transactions and the PSA can be redeemed at NAV as of the measurement date. Therefore, the Plan believes that this investment has a "readily determinable fair value." The NAV is calculated in a manner consistent with GAAP for investment companies and valued similarly to mutual funds, the PSAs are level 1 assets to allow for consistent disclosure.

*Stable Value Fund* is a stable value collective investment trust (CIT) for which the (NAV) is based on the contract value. Investments held by a CIT are required to be reported at fair value, however, contract value is the relevant measurement characteristic for the portion of the net assets of a CIT attributable to fully benefit-responsive investment contracts. This is because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the underlying defined-contribution plans. The NAV of the CIT is not publicly quoted but is available to current investors via the Employer website or when Plan participants access their account values. The NAV is the basis for current transactions and the CIT can be redeemed at NAV as of the measurement date. Therefore, the Plan believes this investment has a "readily determinable fair value". The NAV is calculated in a manner consistent with GAAP for investment companies and valued similarly to mutual funds, the CIT is a level 1 asset to allow for consistent disclosure.

*Lifetime Hybrid* accounts are collective investment trusts (CIT) that invest in collective trust funds as well as a variety of separate accounts and mutual funds. The fair value of the collective investment trusts and the separate accounts are not publicly quoted pricing inputs. The fair value of mutual funds are publicly quoted pricing inputs (level 1). The fair value of all these investments are used in determining the net asset value ("NAV") of the CIT, which is not publicly quoted but is available to current investors via the Employer website or when plan participants access their account values. The CITs' Annual Report with underlying asset information is available. The NAV is the basis for current transactions and the CITs can be redeemed at NAV as of the measurement date. Therefore, we believe that these investments have a "Readily Determinable Fair Value". The NAV is calculated in a manner consistent with GAAP for investment companies and valued similarly to mutual funds, these CIT are a level 1 asset to allow for consistent disclosure.
