Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Daniels Tire Service, Inc. Cash or Deferred Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit) to the extent allowable. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Daniels Tire Service, Inc. Cash or Deferred Profit Sharing Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from John Hancock and US Bank, both of whom are qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note A of the accompanying financial statements, is complete and accurate.

Management has also determined that a portion of the audits were not eligible under ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, because a portion of the Plan's investments were held by Charles Schwab, which is not a qualified institution, because it is not a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information provided by John Hancock and US Bank referenced in Note A to the accompanying financial statements, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions (John Hancock and US Bank) agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Daniels Tire Service, Inc. Note A - Description of Plan

The following description of the Daniels Tire Service, Inc. Cash or Deferred Profit Sharing Plan and Trust (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of Daniels Tire Service, Inc. (Company) who have one year of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA). The Board of Trustees oversees governance of the Plan and determines the appropriateness of the Plan's investments and monitors investment performance.

DOL Limited Scope Audit

As permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, and as instructed by the Plan administrator, we did not perform any auditing procedures with respect to investment and related information prepared and certified to by John Hancock and US Bank, respectively, in accordance with 29 CFR 2520.103-5, other than comparing the information with the related information included in the financial statements and supplemental schedules. The certifications provided by John Hancock and US Bank specifically apply to: 1) investments, 2) investment income, including dividends, interest (excluding interest received on participant notes receivable), and realized and unrealized gains and losses, and 3) the information contained in the supplemental schedules.

Under ERISA, the Plan administrator is generally responsible to the Plan participants for the financial information and the ability of the certifying entity to issue such ERISA certification.

DOL Full Scope Audit

During 2024, the Plan transferred certain investments to Charles Schwab, which is a non-qualifying institution under 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Consequently, these investments and the related investment income and expenses have been subjected to full audit procedures.

Contributions

Each year, the Company contributes 50 percent of the employee's contribution for those participants who contribute up to 4 percent of their compensation, and 2 percent of the employee's eligible compensation for those participants who contribute more than 4 percent.

Participants may contribute pretax annual compensation, as defined in the Plan, up to the amount prescribed by the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan contains an auto-enrollment provision whereby for all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate.

Note A - Description of Plan (continued)

Participant Accounts

Each participant's account is credited with the participant's contribution, Company matching contributions, and allocations of Plan earnings and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 100 percent vested after 6 years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined at the time the loan is executed, is the prime rate as published by the Wall Street Journal plus 1%. Principal and interest is paid ratably through bi-weekly payroll deductions for a term not to exceed 5 years.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or in annual installments over a ten year period. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited Accounts

Forfeited non-vested accounts used to fund employer contributions totaled \$0 and \$4,830 at December 31, 2024 and 2023, respectively.

Note B - Summary of Accounting Policies

Date of Management's Review

Subsequent events were evaluated through October 10, 2025, which is the date the financial statements were available to be issued.

Use of Estimates

The preparation of financial statements in conformity with special purpose framework accounting principles used in the preparation of the attached financial statements requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Basis of Accounting

The financial statements of the Plan are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Under the modified cash basis of accounting: 1) contributions and interest are recorded when received, 2) expenses are recorded when paid, 3) dividend income is recorded when earned, and 4) investments are presented at fair value.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for fully benefit-responsive contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are recorded when received. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Note C - Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. The Plan's Trustees determine the Plan's valuation policies. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 and Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair values of common stocks are based on the closing price reported in the active market where the individual securities are traded, when available. The fair value of mutual funds are based on the net asset value closing price. The fair value of loans to participants is based on the amount of money borrowed.

Note D – Investments

As of December 31, 2024, and 2023, the vast majority of the Plan’s investment assets are held in a major insurance company.

Note E - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in the company contributions portion of their account. Any unallocated assets of the Plan should be allocated to participant accounts and distributed in such a manner as the Plan sponsor may determine.

Note F - Tax Status

The IRS has determined and informed the Plan by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan’s administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles under the modified cash basis of accounting in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

Note G - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant’s account balances and the amount reported in the statement of net assets available for benefits.

The Plan’s cash and investments are insured by the SIPC (“Securities Investor Protection Corporation”) up to a maximum of \$100,000 for cash balances, and \$400,000 for investments. At December 31, 2024, and 2023, the Plan had cash and investments in excess of the coverage provided by the SIPC in the amount of \$11,618,396 and \$10,910,978, respectively.

Note H - Related Parties Transactions

Party-in interest fees comprised of commissions and related charges incurred for the purchase, sale, and management of securities have been paid by the Plan to its Investment Custodians, John Hancock and US Bank.

The Plan's sponsor provides office space and equipment, as well as management services to the Plan, at no charge. The Plan does not record the receipt of these transactions. In addition, since the plan document allows for the sponsor to pay for various operating expenses of the Plan, professional fees for audit services have been paid for by the Plan's sponsor.
