Note 1 – Description of Plan

The following description of the Safran Cabin Inc. 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering all employees of Safran Cabin, Inc. (the Company or Safran Cabin), except some union members, leased employees, and non-resident aliens. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is the Plan's Sponsor and serves as Plan Administrator. The Plan Administrative Committee is responsible for oversight of the Plan, including determining the appropriateness of the Plan's investment offerings, monitoring investment performance, and reporting to the Company's board of directors.

Eligibility – Employees of the Company are eligible to participate in the Plan and receive any employer matching contributions upon reaching age 18 and after completing one month of service. Eligible employees enter the Plan at the beginning of the next month.

Contributions – Each year, participants may contribute up to the maximum amount allowed by law. Participants may also elect to make Roth contributions utilizing after-tax contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated fund until elected otherwise by the participant. Unless elected otherwise, participant deferral rates will automatically increase by 1% each subsequent Plan Year up to 6%. The Company makes Qualified Automatic Contribution Arrangement (QACA) safe harbor matching contributions equal to 100% of the first 4% of participant's eligible compensation contributed to the Plan. The Company may also make additional discretionary contributions, but there is no requirement. During 2024, the Company made QACA safe harbor matching contributions totaling \$4,822,228. The matching Company contribution is invested as directed by the participants. Contributions are subject to certain IRS limitations.

Participant accounts – Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are immediately vested in their contributions, and the earnings thereon. Vesting in the Company's QACA safe harbor matching contribution or additional discretionary contribution portions of their accounts is based on years of continuous service. Participant's vest in the Company's contributions based on the following schedule:

Participants are fully vested upon death or permanent disability.

Notes receivable from participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant’s account and bear interest at reasonable rates determined by the Plan Administrator reviewing the interest rates charged for similar types of loans by other lenders. Interest rates range from 4.25% to 9.5% at December 31, 2024.

Loan terms range up to five years, unless for the purchase of a principal residence, in which case the loan term may not exceed thirty years. Principal and interest are paid ratably through monthly payroll deductions.

Payment of benefits – Upon death, disability, retirement, or termination, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account, installments, or an annuity.

Mergers into Plan – On May 14, 2024, the Safran Cabin Galleys US, Inc. Retirement Savings Plan (Galleys Plan) was merged into the Plan. The transferred net assets totaling \$17,756,234 have been recognized in the accounts of the Plan as of May 14, 2024, at their balances as previously carried in the accounts of the Galleys Plan. Subsequent to May 14, 2024, additional net assets totaling \$1,417,568 were transferred to the Plan.

Additionally, on May 23, 2024, the Safran Cabin Bellingham Retirement Plan (Bellingham Plan) was merged into the Plan. The transferred net assets totaling \$16,013,563 have been recognized in the accounts of the Plan as of May 23, 2024, at their balances as previously carried in the accounts of the Bellingham Plan.

Forfeited amounts – At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$73,555 and \$172,221, respectively. Forfeitures may be used to offset employer contributions to the Plan or to pay any administrative expenses of the Plan. The Plan used \$705,692 to offset employer contributions and pay plan expenses during the year ended December 31, 2024.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements of the Plan are prepared using the accrual basis of accounting.

Note 2 – Summary of Significant Accounting Policies – (Continued)

Investment valuation and income recognition – The Plan provides for investments in mutual funds and a collective trust. The Plan’s investments in mutual funds are reported at fair value. The collective trust is valued at net asset value as a practical expedient to estimate fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company’s Plan Administrator determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of benefits – Benefits are recorded when paid.

Administrative expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Use of estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent events – In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 13, 2025, the date the financial statements were available to be issued.

Note 3 – Information Certified by Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations and Disclosure under ERISA. Accordingly, Matrix Trust Company, the previous custodian of the plan, certified to the completeness and accuracy of non-interest bearing cash totaling \$63,972 presented on the 2023 Statement of Net Assets Available for Benefits. In addition, T. Rowe Price Trust Company (T. Rowe Price), the current custodian of the Plan, has certified to the completeness and accuracy of the following information as of and for the year ended December 31:

Note 4 – Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

- Level 1: Observable inputs to the valuation methodology that are quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Observable inputs to the valuation methodology other than quoted market prices (unadjusted) for identical assets or liabilities in active markets. Level 2 inputs include quoted prices for similar assets and liabilities in active markets, quoted prices for identical assets in markets that are not active and inputs other than quoted prices that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology that are unobservable for the asset or liability and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trusts:

Valued at the net asset value (NAV) of units held by the Plan at year-end. The NAV is determined by the custodians of the funds and is based upon the fair value of the underlying assets held by the funds. NAV is used as a practical expedient to estimate fair value. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values.

Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023.

To assess the appropriate classification of investments with the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

The Plan evaluated the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers in or out of Level 3.

Note 5 – Party-In-Interest Transactions

Certain Plan investments are managed by T. Rowe Price, the custodian of the Plan. As such, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to various service providers for legal, accounting, recordkeeping, and advisory services totaled \$233,611 for the year ended December 31, 2024.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

Note 7 – Tax Status

The Plan obtained its latest opinion letter on August 19, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 7 – Tax Status – (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Tax returns for the prior three fiscal years remain subject to examination by major tax jurisdictions.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 9 – Reconciliation to Form 5500

The Form 5500 has certain items that differ from the amounts shown on the accompanying financial statements. These differences related to classification only and have no effect upon net assets available for benefits for either period.
