Opinion

Notes to Financial Statements

Note 1 – Description of the Plan and Trust

The Arizona Technology Council Employee Benefit Trust Plan (the Plan) was established on September 1, 2019, and began operations on January 1, 2020. The Plan was established to provide programs of health and welfare benefits for participating employers under the employee benefit plans they maintain for their employees and dependents. The following description of the Plan provides only general information. Participants should refer to the Plan documents, summaries, and other descriptive plan literature for a more complete description of the Plan's provisions.

This Plan is considered a "multiple employer welfare arrangement" as defined by the regulations promulgated under the Employee Retirement Income Security Act of 1974 (ERISA). ERISA defines a "multiple employer welfare arrangement" as an employee welfare benefit plan or any other arrangement, which is established or maintained for the purpose of offering or providing any welfare benefits to the employees of two or more employers, or to their beneficiaries. The types of benefits currently available under the Plan through December 31, 2024, are described as follows: medical, hospital, surgical, prescription drug, dental, vision, basic life, accidental death and dismemberment, supplemental life, short-term and long-term disability, and employee assistance benefits. During the years ended December 31, 2024 and 2023, the Plan included coverage for basic life and accidental dismemberment, supplemental life and accidental death and dismemberment, short-term disability, and long-term disability benefits through an arrangement with the Washington Technology Industry Association Employee Benefit Trust

Participation in the Plan is limited to the Arizona Technology Council (AZTC) itself as an employer and associated, eligible employers. Eligible employers have two or more common-law employees and are members of the AZTC (as defined in the bylaws of the AZTC) in either the Industry Membership category or the Associate Membership category that is included in certain industry classifications. A participating employer is one who has executed a Participation Agreement with the Board of Trustees. The only individuals who are entitled to participate in and to receive benefits from the Plan are those employees, dependents, and/or retirees identified by participating employers.

Each participating employer agrees to provide information to the related trust regarding the employer's participants and employees of any ERISA affiliate of such participating employer, as will be determined by the Board of Trustees to be necessary for administration of the trust and Plan. Each participating employer also agrees to promptly remit contributions to the related trust in the amount required to maintain welfare benefits coverage for each employer's participants in the amounts and at times described in the Participation Agreement.

Employer and participant contributions are received and held by the related trust pending payment of approved insurance premiums and welfare benefits. Such contributions are determined via a rate schedule based upon the type of coverage for employees and their dependents.

The endorsing sponsor of the Plan is the AZTC. The President/Chief Executive Officer of the AZTC is the Chairman of the Board of Trustees.

During the years ended December 31, 2024 and 2023, the Plan and related trust were administered by the Board of Trustees, with the assistance of Vimly Benefit Solutions, Inc., a contract administration organization; Brown and Brown Insurance Services, Inc. dba DiMartino Associates, a benefits consulting services firm; and ERISA Benefits Law, PLLC, a legal services firm.

Note 1 – Description of the Plan and Trust (Continued)

Effective January 1, 2025, ERISA Benefits Law, PLLC was reorganized as ERISA Benefits Law Group, PLLC. Financial statement accounting and auditing services were provided by Anastasi, Moore & Martin, PLLC, and Schoedel & Schoedel, PLLC, for the years ended December 31, 2024 and 2023, respectively. The Plan is marketed to employers by various insurance brokers.

Note 2 – Summary of Significant Accounting Policies

The summary of significant accounting policies of the Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are the representations of the Board of Trustees, who is responsible for the integrity and objectivity of the financial statements.

These accounting policies conform to accounting principles generally accepted in the United States of America and have been consistently applied in the preparation of the financial statements.

- a. **Basis of accounting** – The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.
- b. **Use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Board of Trustees to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.
- c. **Contributions recognition** – Employer and participant contributions are recognized as the Plan becomes obligated for the payment of insurance premiums. Therefore, contributions received after December 31 for benefits provided before the beginning of the subsequent year are recognized as contributions receivable. On the other hand, contributions received before December 31 for benefits provided in the subsequent year are recognized as unearned.
- d. **Payment of insurance premiums** – Insurance premiums are recognized when paid.
- e. **Subsequent events** – Subsequent events have been evaluated through October 10, 2025, which is the date the financial statements were available to be issued.

Note 3 – Income Tax Status

The trust established under the Plan to hold the assets of the Plan is qualified as a tax-exempt organization under Section 501(c)(9) of the Internal Revenue Code (IRC) and, accordingly, any net investment income of the trust is exempt from income taxes. The trust obtained its latest tax determination letter from the Internal Revenue Services (IRS) with an effective date of exemption of September 1, 2019. In the letter, the IRS stated that the trust, as then designed, was in compliance with the applicable requirements of the IRC.

Note 3 – Income Tax Status (Continued)

The Board of Trustees and legal counsel believe the trust and related Plan are designed and have been operated through December 31, 2024, in accordance with applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be substantiated upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions, and the Plan could be subject to income tax if certain issues were found by the IRS that could result in the disqualification of the tax-exempt status; however, there are currently no audits for any tax periods in progress.

Note 4 – Priorities Upon Termination

The Plan may be terminated by action of the AZTC. In addition, the Plan may be amended or terminated by written resolution adopted by a majority of the Board of Trustees, or by a writing delivered to the Board of Trustees and signed by participating employers whose contributions during the preceding 12 months have totaled more than 50% of all contributions. No such amendment or termination, however, will divert the assets of the related trust or any part thereof to a purpose other than as set forth in the Trust Agreement, cause the trust to lose its status as a tax-exempt voluntary employees' beneficiary association under Section 501(c)(9) of the IRC, relieve the Board of Trustees from liability for acts in violation of the standard of care imposed, or modify the section of the Trust Agreement relating to limitation of rights to the trust fund. Notice of any amendment or modification will be promptly forwarded by the Board of Trustees to the AZTC, each participating employer, and to any insurer, and upon request, a copy will be furnished to any such person. Upon the dissolution or termination of the Plan, all assets remaining in the Plan, after the payment of expenses incidental to the dissolution or termination, will be used to provide benefits for which the Plan was established. This arrangement will continue until all funds in the trust are exhausted. In no event will any of the remaining monies or assets be paid to or be recoverable by any participating employer, or paid in cash to participating employees, unless such disposition is required by applicable laws.

Note 5 – Risks and Uncertainties

The Plan maintains an account with a financial institution which, as of December 31, 2024, is insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. At times, the Plan's cash balance may exceed the FDIC insurance limit.

Currently, the Plan operates as a fully insured arrangement and, therefore, is contracted with particular insurance carriers. In the Plan's service area, there are limited qualified insurance carriers willing and capable of meeting the Plan's insured benefit needs.

Note 5 – Risks and Uncertainties (Continued)

The Plan and related insurance carriers face an increasingly challenging regulatory environment. Certain interpretations of laws, rules, and regulations could potentially result in adverse effects to the Plan. However, it is not expected that the Plan will significantly change operations or terminate prior to December 31, 2025.

Note 6 – Related-party Transactions

During the years ended December 31, 2024 and 2023, employer contributions from the AZTC, the endorsing sponsor of the Plan, totaled \$56,275 and \$92,681, respectively.

Additionally, the Plan pays the AZTC administrative fees, which are based on the contributions received by the Plan. For the years ended December 31, 2024 and 2023, the Plan recognized expenses totaling \$183,505 and \$148,889, respectively, for such fees. As of December 31, 2024 and 2023, amounts due to the AZTC for administrative fees totaled \$862 and \$2,314, respectively.
