**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audit of the accompanying financial statements of ABC Legal Services Puerto Rico Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of ABC Legal Services Puerto Rico Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and for the year then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

**Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of ABC Legal Services Puerto Rico Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

#### **NOTE 1 - DESCRIPTION OF PLAN**

The following description of the ABC Legal Services Puerto Rico Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### ***General***

The Plan is a defined contribution plan covering all Puerto Rico employees of ABC Legal Services, LLC, (the Company and Plan Sponsor) that have completed the Plan eligibility requirements. Employees that have attained age 18 and completed one month of service are eligible for the Plan. The age and service requirements are waived for employees who were employed on January 1, 2024, the effective date of the plan.

The Plan has an automatic enrollment feature which includes a default deferral rate set at 5% of compensation, unless the employee affirmatively elects not to participate.

##### ***Contributions***

Each year, participants may contribute up to 100% of eligible earnings as defined in the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain Puerto Rico Department of the Treasury ("Hacienda") limitations.

The Company may elect to make a discretionary matching contribution. For the year ended December 31, 2024, the Company made a matching contribution to each eligible participant's account equal to 50% of the participant salary deferrals not to exceed 5% of the participant's payroll compensation. Employees must make an elective deferral in order to receive the employer matching contribution. The matching contributions are invested in the same investment option allocation selected by each participant for their elective deferral.

The Company may also elect to make a discretionary profit sharing contribution to the Plan. Any profit sharing contributions would be allocated to all employees eligible to participate in the Plan based on a percentage of the participant's compensation for the respective plan year. Participants must be employed on the last day of the Plan year and must have completed at least 1,000 hours of service during the Plan year. These allocation conditions are waived for participants who have terminated due to death, disability, or Normal Retirement Age. No profit sharing contributions have been made to the Plan for the year ended December 31, 2024.

##### ***Participant Accounts***

Each participant's account is credited with the participant's elected deferrals, the Company's contributions and the earnings (losses) from the investment funds selected by the participant. A specified fee is charged to the accounts of individual participants who have initiated a note receivable or other allowable Plan disbursement during the year. Participant accounts are charged monthly administrative fees to cover Plan expenses which include custodial, recordkeeping, trustee, and other administrative services. Each participant is entitled to the benefits that become available as their individual account vests.

#### **NOTE 1 - DESCRIPTION OF PLAN (Continued)**

##### ***Vesting***

Participants are vested in their profit sharing contributions after they have completed six years of service. Participants are immediately vested in the Company's matching contribution and their contributions plus earnings thereon.

##### ***Notes Receivable from Participants***

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes receivable are secured by the balance in the participant's account and bear interest at the rate in effect in the month each note receivable becomes effective. Interest is equal to one percentage point above the prime rate as most recently published by the "Wall Street Journal." Principal and interest are paid directly to the Plan from the participant on a monthly basis over a term not to exceed five years, unless the loan was used to purchase a primary residence in which case the loan may be repaid within period of up to twenty-five years.

##### ***Payment of Benefits***

A participant's vested account balance is payable to the participant or the participant's beneficiaries in full according to the terms of the Plan upon death, permanent disability, or termination of employment. Under the terms of the Plan, distributions upon termination of employment or disability may be made in the form of a lump-sum payment or in installments over a period of at least five years. A participant's account with a vested balance of \$5,000 or less may be distributed as an involuntary lump-sum cash payment with the participant's consent.

##### ***Forfeitures***

The non-vested portion of the Company matching contribution for a participant who has terminated employment is forfeited as of the date on which he or she has a five year break-in-service or, if earlier, upon distribution of the vested portion of the participant's employer contribution account. Forfeitures may be used, at the Company's discretion, to pay Plan expenses, reduce the employer's contribution, or be reallocated to the participant's accounts.

#### **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

##### ***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting.

#### **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

##### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

##### ***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### ***Payment of Benefits***

Benefits are recorded when paid.

##### ***Plan Expenses***

The Plan Sponsor pays the expenses associated with the administration of the Plan, except for certain investment management fees and loan fees that are directly deducted from the participant's account.

##### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

##### ***Evaluation of Subsequent Events***

Management has reviewed subsequent events through October 14, 2025, which is the date that the financial statements were available to be issued.

#### **NOTE 3 - FAIR VALUE MEASUREMENTS**

The Fair Value Measurements Topic 820 of the FASB Accounting Standards Codification (ASC) establishes a fair value hierarchy for reporting that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable units other than quoted prices for identical assets; and Level 3 inputs have the lowest priority.

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

##### **Mutual Funds**

The investments in mutual funds are valued utilizing a market approach wherein the Plan uses the quoted prices in the active market for identical assets. All of these investments are traded in active markets.

##### **Common Collective Trust Fund**

The common collective trust fund is a stable value fund which is composed primarily of guaranteed investment contracts, synthetic investment contracts, wrapper contracts and short-term investments which are valued at the net asset value of the fund's underlying net assets. The net asset value is used as a practical expedient to estimate fair value and therefore the fund has not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the Statement of Net Assets Available for Benefits.

This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that the securities liquidations will be carried out in an orderly business manner.

#### NOTE 4 - INFORMATION CERTIFIED BY BPAS TRUST COMPANY OF PUERTO RICO

As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan administrator instructed the auditors not to perform any auditing procedures with respect to information which was certified as complete and accurate by BPAS Trust Company of Puerto Rico, the trustee. The information certified by BPAS Trust Company of Puerto Rico includes investments, the related investment activity, and notes receivable from participants that are described in the accompanying financial statements.

#### **NOTE 5 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their profit sharing contributions. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in accordance with the Plan provisions.

#### **NOTE 6 - TAX STATUS**

The Plan obtained an opinion letter dated October 15, 2024, based on a Master Prototype Defined Contribution Plan, in with the Department of the Treasury of the Government of Puerto Rico stated the Plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC) as of January 1, 2024. Therefore, no provision for federal income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or Department of Labor. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Company intends to file its Form 5500 return timely with the Department of Labor.

#### **NOTE 7 - RELATED PARTIES AND PARTY IN INTEREST TRANSACTIONS**

The Plan currently invests in various investment options issued by BPAS Trust Company of Puerto Rico, who serves as the trustee, as defined by the Plan, for the year ended December 31, 2024. Therefore, these transactions are recognized as party-in-interest transactions. In addition, the Plan paid certain expenses to various service providers. These expenses are exempt party-in-interest transactions under ERISA.

#### **NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
