Basis for Opinion

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year), as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1. Description of the Plan

The following brief description of the Dayton-Phoenix Group, Inc. Hourly Employees 401(k) Retirement Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all hourly employees of the Dayton-Phoenix Group, Inc. (the Company, Employer and Plan Sponsor) who are included in the collective bargaining agreement with IUE-CWA Local 755, except nonresident aliens. Employees are eligible to participate on monthly entry dates following the completion of one year of service and attaining the age of 18, age of 21 prior to January 1, 2015. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: The Plan allows for pre-tax and after-tax elective deferral contributions, employer matching contributions, and if applicable, employer discretionary profit-sharing contributions. Participants direct the investment of all contributions into various investment options offered by the Plan.

Participant's voluntary salary reduction: Participants may contribute up to the maximum amount permitted by law. Eligible participants may begin elective deferrals on the first day of the month coinciding with or next following the date requirements were satisfied. In addition, deferrals from payroll are automatically started for eligible employees after one year of service, at 6% of eligible compensation, unless the employee elects to not contribute or to change the deferral percentage.

Participant rollover contributions: The Plan allows all eligible participants to contribute to their account amounts representing distributions from other qualified plans after approval from the Plan Sponsor. Participants are fully vested in these amounts.

Employer matching contributions: The employer may make matching contributions equal to a discretionary percentage of participant's elective deferrals. During 2024, the matching contribution was equal to 100% of the participant's elective deferral up to 6% of the participant's eligible compensation.

Employer discretionary profit-sharing contributions: The employer, at its discretion, may also make an annual profit-sharing contribution equal to a percentage, determined by the employer, of each participant's salary. There were no discretionary profit-sharing contributions for the year ended December 31, 2024.

Transfers to and from another plan: Upon change in hourly versus salary employment status, participants may transfer their balance between plans sponsored by the Company, specifically between the Plan and the Dayton-Phoenix Group, Inc. Salaried Employees 401(k) Retirement Plan and Trust, which are related parties. Total transfers for the plan year ended December 31, 2024 were \$59,076.

Participant accounts: Each participant's account is credited with the participant's contribution and allocations of the employer's contributions and the Plan's earnings. Allocations are based on participant earnings or account balances, as defined by the Plan document. The benefit to which a participant is entitled is the amount that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants will be 100% vested after six years of credited service.

Note 1. Description of the Plan (Continued)

Payment of benefits: Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over the participant's assumed life expectancy. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Notes receivable from participants: Participants may borrow from their fund accounts at a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's account balance. All loans must be repaid within five years unless the loan is obtained to acquire or construct the participant's primary residence, in which case the term of the loan may extend up to 10 years. The loans are collateralized by the balance in the participant's account and bear interest at a fixed rate between 3.25% to 9.25% as of December 31, 2024 and 2023, which is commensurate with local prevailing rates as determined monthly by the Plan Administrator. Payments of principal and interest are credited to the participant's account.

Forfeitures: The Plan provides for forfeitures to be applied to reduce employer contributions. There was no forfeited, non-vested account balance at December 31, 2024 and 2023. Forfeited amounts of \$1,532 were used to reduce employer contributions during 2024.

Note 2. Summary of Significant Accounting Policies

Basis of presentation: The accompanying financial statements have been prepared on the accrual basis in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) in accordance with the Financial Accounting Standards Board Accounting Standards Codification.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment valuation and income recognition: Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Capital gain distributions are recorded in dividend income.

Use of estimates: The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect certain amounts and disclosures reported in the financial statements and accompanying notes. Actual results may differ from those estimates.

Contributions: Participant elective deferral contributions are recognized when earned. Employer matching contributions are recognized concurrently with participant contributions. Employer discretionary profit-sharing contributions are recognized annually, as applicable.

Payment of benefits: Benefits are recorded upon distribution.

Notes receivable from participants: Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are paid by the participants. Delinquent loans are treated as distributions based upon the terms of the Plan document.

Administrative expenses: Certain administrative functions are performed by officers or employees of the employer. No such officer or employee receives compensation from the Plan. Certain costs associated with Plan administration for services provided by unrelated companies are deducted from plan assets.

Subsequent events: The Plan has evaluated subsequent events for potential recognition and/or disclosure through October 13, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified by Reliance Trust Company, the Plan's Custodian

The information related to investments that is included throughout the Plan's financial statements and supplemental schedule as of December 31, 2024 and 2023, and for the year ended December 31, 2024, was prepared by or derived from information provided by the custodian and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the custodian that information provided to the Plan Administrator by the custodian related to these Plan investments is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information in Note 4 and the supplemental schedule related to the Plan's investments.

The custodian of the Plan also certified to the completeness and accuracy of \$1,207,577 of net appreciation in fair value of investments and \$484,661 of dividends related to the investments for the year ended December 31, 2024.

Note 4. Fair Value Measurements

The Plan has determined the fair value of certain assets through application of accounting guidance that establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lower priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under this standard are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

Note 4. Fair Value Measurements (Continued)

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the closing price reported on the active market on which the individual securities are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Assets measured at fair value on a recurring basis: The following tables summarize assets measured at fair value on a recurring basis as of December 31, 2024 and 2023, segregated by the level of the valuation inputs within the fair value hierarchy utilized to measure fair value.

Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to the total net assets available for benefits.

Note 5. Investment Contract with Insurance Company

The Plan has a traditional investment contract with Standard Insurance Company. This contract meets the fully benefit-responsive investment contract criteria and is therefore reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Note 5. Investment Contract with Insurance Company (Continued)

Standard Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specific rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on Standard Insurance Company's ability to meet its financial obligations. Standard Insurance Company's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total Plan termination, retirement incentive programs and the liberalization of Plan withdrawal or transfer rules. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value, is probable. Either the Plan or the insurance company may terminate the contract at any time with 30 days advance written notice.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include the following: contract owner's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, Plan disqualification and failure to adopt the Plan in a reasonable period of time. Upon termination, a market value adjustment or other withdrawal restrictions may apply.

Note 6. Related-Party and Party-in-Interest Transactions

Certain Plan investments are insurance company general accounts managed by Standard Insurance Company. Standard Insurance Company is the current recordkeeper as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Standard Insurance Company for Plan administrative functions amounted to \$39,151 for the year ended December 31, 2024.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 8. Income Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

Note 8. Income Tax Status (Continued)

The Plan Administrator evaluated the Plan's tax positions and concluded that there are no uncertain tax positions that require recognition or disclosure in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by tax authorities for years before 2021.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.
