NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

1. Plan Description

The following description of the East Georgia HealthCare Center Employee Benefit Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established effective January 1, 2022, and is a self-insured health benefit plan that provides benefits to all eligible employees of East Georgia HealthCare Center (Sponsor), as well as former employees electing coverage under the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA) provisions. In order to be eligible for medical benefits, a full-time employee must be working at least 30 hours a week. Employees are eligible after they have been employed for 30 days. Benefits are also provided to dependents of these individuals who elect coverage on their behalf. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is a member of Veris Benefits Consortium, LLC, which operates as a health insurance consortium under which the members negotiate and establish welfare benefit plans for their employees. Some expenses of the health plan are paid through the Veris Benefits Trust. The employees are required to pay for a portion of the cost of the benefit.

Contributions

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. The Sponsor makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Sponsor on a pay-as-you-go basis.

The Sponsor provides for stop loss insurance over a specified amount as per agreement with the reinsurance carrier, with the premiums being paid by funds deposited in the Plan.

Benefits

The Plan provides health (medical, hospital, surgical, and major medical) and prescription drug benefits to substantially all employees of the Sponsor who meet the service requirement of the Plan and to their covered dependents. The Plan also provides continuation of certain benefits upon termination of employment through COBRA as defined in the Plan document.

Current health claims are processed through Meritain Health, Inc.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

2. Summary of Accounting Policies, Continued

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, claims incurred but not reported (IBNR), claims payable, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Premiums paid by the Sponsor or trust are recorded as premium payments in the accompanying statements of changes in net assets available for benefits. Claim payments are recorded when paid by the third-party claims administrator. Amounts due to claims processors that have not been reimbursed by the Plan are recorded as payable to claims administrators in the accompanying statements of net assets available for benefits.

Stop Loss Insurance

The Plan has a stop loss insurance arrangement whereby the stop loss insurance will cover the Plan's obligations for any eligible plan participant's claims in excess of a fixed dollar amount (self-insured retention). The self-insured retention for the Sponsor was \$50,000 per covered person for the years ended December 31, 2024 and 2023. In addition, the Plan has an aggregate stop loss insurance arrangement whereby the aggregate stop loss insurance will cover the Plan's obligations if all claims exceed a fixed dollar amount. The aggregate stop loss insurance coverage for the Sponsor was approximately \$1,000,000 for the years ended December 31, 2024 and 2023. If the Plan is in a deficit for the stop loss policy year, then the stop loss provider will fund the deficit. Premiums for stop loss insurance are included in insurance premiums in the accompanying statement of changes in net assets available for benefits. Stop loss refunds of \$1,551,081 and \$765,941 have been netted with claims paid in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively.

2. Summary of Accounting Policies, Continued

Plan Benefit Obligations

Plan benefit obligations at December 31, 2024 and 2023 for health claims incurred by active participants, but not reported at that date are estimated by the Plan's third-party administrator in accordance with generally accepted actuarial principles based on claims data provided by the Plan. These amounts are paid by the Plan only if claims are submitted and approved for payment. Such estimated amounts are reported in the accompanying statements of benefit obligations. Due to the short-term nature of the reserve liability, time value of money was not used to discount future payments.

Administrative Expenses

The Plan pays administrative expenses that consist primarily of administrative fees paid to the third-party claims administrator, the custodian, and the actuary. These expenses are reported on the statements of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Sponsor on behalf of the Plan.

Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

- *Cash account:* Valued at amortized cost, which approximates fair value.

As of December 31, 2024 and 2023, the cash account is measured at fair value using Level 2 inputs according to FASB ASC 820.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Tax Status

The Plan is funded through a non-qualified trust under Internal Revenue Code (IRC) 419(a). The trust files Form 1041 U.S. Income Tax Return for Estates and Trusts. Plan management believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the relevant taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to possible examination by the taxing authorities. For federal income tax purposes, the tax returns essentially remain open for possible examination for a period of three years after the respective filing deadlines of those returns. As 2022 was the initial year for filing, the Plan is not subject to income tax examinations by the U.S. Federal, state, or local tax authorities prior to that date.

5. Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to modify the benefits provided to active employees, discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert back to the Sponsor or be used for purposes other than for the exclusive benefit of the Plan's participants.

6. Risks and Uncertainties

The Plan invests in a cash account. The cash account is exposed to various risks such as interest rate, market, and credit risks. Due to the minimal level of risk associated with cash accounts, it is unlikely, but remotely possible, that changes in the value of the cash account will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The present value of benefit obligations is reported based on certain assumptions, applied to historical claim information, which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

7. Related Party Transactions and Party-In-Interest Transactions

Certain Plan investments are managed by Univest Bank, the custodian of the Plan, and, therefore, these transactions qualify as party-in-interest transactions.

As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA.
