We have performed audits of the financial statements of Wolters Kluwer 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE A - DESCRIPTION OF THE PLAN

The following brief description of the Wolters Kluwer 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

The Plan is a defined contribution plan that covers substantially all employees of Wolters Kluwer United States, Inc. (the Employer) and its affiliates. The Retirement Committee of the Employer controls and manages the operation and administration of the Plan. Fidelity Management Trust Company (Fidelity) serves as the trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions

Each year, participants may contribute, on a pretax basis, a designated whole percentage between 1% and 50% of their base annual compensation, as defined in the Plan, subject to certain Internal Revenue Code (IRC) limitations. Participants over age 50 are able to contribute catch-up contributions of an additional 25% of base compensation to the Plan, subject to certain IRC limitations.

Eligible employees are automatically enrolled at a rate of 3% of their compensation unless they opt out or elect another contribution rate. On each April 1st thereafter, the employee's contribution percentage will be automatically increased by 1% up to 10%, unless the participant is already contributing at least 10% or opts out of the automatic increase.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Such contributions are shown as rollovers in the statement of changes in net assets available for benefits.

The Employer contribution is comprised of two components: an Employer matching contribution and an annual Employer discretionary contribution. The Employer will match dollar for dollar of employee contributions up to 3% of eligible pay (subject to IRC limitations). The annual Employer discretionary contribution was 3% in 2024, of the aggregate base compensation (overtime and bonus not included) of all employees who were participants in the Plan during the year.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, allocations of Employer matching and Employer discretionary contributions and Plan earnings and charged with withdrawals and an allocation of Plan losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments

Participants direct the investment of their account balance and future contributions and Employer contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and collective trusts.

Vesting

All participants are vested immediately in their contributions. Participants with a hire date before January 1, 2016, are fully vested in Employer and Discretionary contributions. Participants with a hire date on or after January 1, 2016, will vest in Employer matching and Employer discretionary contributions after three years.

Forfeitures

Any forfeited participant amounts are used to reduce future Employer matching or Employer discretionary contributions or to pay for reasonable administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited accounts totaled \$1,448,516 and \$2,434,649, respectively. During 2024, \$1,056,456 was used to pay administrative expenses of the Plan and \$2,975,751 was used to offset Employer contributions to the Plan.

Notes Receivable from Participants

Participants may borrow from their fund accounts from \$500 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Loan terms range from one to five years, or up to 10 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate at the time of the loan, generally 1% above prime. Principal and interest are paid ratably through payroll deductions. Participants may have only two loans outstanding from the Plan at any time.

Benefit Payments

Upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. If a terminated employee eligible for a distribution does not complete an election form, the Plan allows for automatic distribution of accounts up to \$7,000.

In-service withdrawals are limited to certain types of monies and only in certain circumstances while a participant remains employed. Participants can withdraw all or a portion of their account if they have reached age 59½ or become disabled (as defined for purposes of Social Security benefits). Both the Plan and federal law currently allow hardship withdrawals under specific circumstances for expenses that qualify as necessary to satisfy immediate and heavy financial needs. Participants can withdraw money from their rollover account at any time.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income (loss) is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Investment management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Administrative Expenses

Administrative expenses of the Plan are paid by the Plan or the Plan sponsor as provided in the Plan document. As of December 31, 2024 and 2023, the Plan held \$395,290 and \$175,158, respectively, in an unallocated account from which Plan expenses can be paid.

Notes Receivables from Participants

Notes receivables from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution. There were no amounts allocated to accounts of persons who have elected to withdraw from the Plan but have not yet been paid at December 31, 2024 and 2023.

NOTE C - FAIR VALUE MEASUREMENTS

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. A fair value measurement assumes that the transaction to sell the asset or transfer the liability occurs in the principal market for the asset or liability or, in the absence of a principal market, the most advantageous market. Valuation techniques that are consistent with the market, income or cost approach are used to measure fair value.

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value into three broad levels as follows:

- Level 1 - Inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Employer has the ability to access.
- Level 2 - Inputs (other than quoted prices included within Level 1) that are observable for the asset or liability, either directly or indirectly.
- Level 3 - Inputs are unobservable inputs for the asset or liability and rely on management's own assumptions about the assumptions that market participants would use in pricing the asset or liability. (The unobservable inputs should be developed based on the best information available in the circumstances and may include the Employer's own data.)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

However, the determination of what constitutes observable requires judgment by the Plan's management. Plan management considers observable data to be market data that is readily available, regularly distributed or updated, reliable and verifiable, not proprietary, and provided by multiple independent sources that are actively involved in the relevant market. The categorization of an investment within the fair value

hierarchy is based on the pricing transparency of the investment and does not necessarily correspond to Plan management's perceived risk of that investment.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds - Valued at the quoted net asset value (NAV) of shares held by the Plan at year end.

Common stock - Valued at the closing price reported on the active market on which the individual securities are traded.

Collective trusts - Valued at the NAV of shares held by the Plan at year end based on information reported by the trustee. The NAV, as provided by the trustee, is used as the practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The collective trusts do not have a readily determinable fair value and are valued at their December 31, 2024 and 2023 NAV per share as provided by the funds' administrators. Redemption from these collective trusts is generally available on a daily basis; however, certain funds may require advance notice ranging from five to thirty days prior to redemption. NOTE D - RELATED-PARTY TRANSACTIONS

Certain Plan investments are shares of mutual funds and collective trusts managed by Fidelity Investments, an affiliate of Fidelity. Fidelity Investments is a related party of the trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Notes receivable from participants also qualify as party-in-interest transactions.

NOTE E - PLAN TERMINATION

Although they have not expressed any intent to do so, the participating corporations have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE F - TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Employer by a letter dated May 26, 2020, that the Plan was designed in accordance with applicable IRC requirements. The Plan has been amended since receiving the determination letter; however, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that the Plan continues to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The Plan administrator has analyzed the tax positions taken or expected to be taken that would require recognition of a liability or disclosure in

the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any periods in progress.

NOTE G - INFORMATION CERTIFIED BY THE TRUSTEE

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value, and notes receivables from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

NOTE H - RISKS AND UNCERTAINTIES

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE I - SUBSEQUENT EVENTS

The Plan evaluated its December 31, 2024 financial statements for subsequent events through October 10, 2025, the date the financial statements were available to be issued. The Plan is not aware of any subsequent events that would require recognition or disclosure in the financial statements.
