### Report on the Audit of the Financial Statements

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Micron Technology Inc. Retirement at Micron (“RAM”) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Micron Technology Inc. Retirement at Micron (“RAM”) Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

#### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section:

Notes to Financial Statements

December 31, 2024 and 2023

**(1) Description of the Plan**

The following is a brief description of the Micron Technology Inc. (the Employer) Retirement at Micron (“RAM”) Plan (the Plan) and provides general information only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**(a) General**

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Effective January 1, 2011, the Plan adopted a Qualified Automatic Contribution Arrangement (QACA) and is intended to satisfy the requirements of Code Section 401(k) and constitute a safe harbor 401(k) plan. All eligible employees can participate in the Plan as of their date of hire (Participants).

The Plan was restated effective January 1, 2022 using an Internal Revenue Service pre-approved plan.

**(b) Contributions**

- **Employee** – Participants are automatically enrolled at 6% (unless they choose to opt-out), but may elect to defer up to 75% of their eligible compensation through payroll deductions subject to Internal Revenue Code (IRC) limitations. The employee contribution for any active participant who was automatically enrolled will increase 1% each year until the contribution is 15% of the participant’s eligible compensation or a different election is made by the participant. Contributions can be made on a pre-tax, Roth, or after-tax basis. Such contributions are remitted by the Employer to the Plan. Employees who were age 50 or more during the Plan year were allowed to make additional catch-up contributions subject to IRC limitations.
- **Rollover** – Participants may transfer balances from other qualified plans and certain eligible retirement plans and accounts to the Plan.
- **Employer Matching** – Consistent with the QACA, the Employer makes matching contributions to the Plan. For the year ended December 31, 2024, employer matching contributions were equal to 100% of the Participants’ contributions up to 5% of eligible compensation.

Matching contributions are allocated to the Participants’ account when received from the Employer.

Contributions are subject to regulatory limitations.

**(c) Participant Accounts**

The Plan provides for two separate accounts for each participant:

- An employee account in which Participant contributions and rollover contributions, and earnings thereon are accumulated and allocated among the investment funds selected by the Participant, and

- An employer account in which the Employer’s contributions and earnings thereon are accumulated and allocated among the investment funds selected by the Participant.

**(d) Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the Participant’s account and are included in administrative expenses. These include loan initiation and administration fees. Investment related expenses are included in net appreciation of fair value of investments.

**(e) Vesting**

Participants are, at all times, fully vested in their employee account balance.

Participants become fully vested in their Employer account balance after a two-year period based upon their years of service with the Employer as follows:

<u>Years of service</u>	<u>Vesting percentage</u>
1	0%
2	100%

In the event a Participant, that is a current employee of the Employer, reaches age 65, becomes disabled, or dies while participating in the Plan, his or her employer account becomes fully vested.

**(f) Notes Receivable from Participants**

The Plan allows participants to borrow against their vested account balances. The minimum amount that may be borrowed is \$1,000. Loans are limited to 50% of the vested Participant’s account balance, with a maximum outstanding loan balance of \$50,000. The Participant loans are collateralized by the balance in the Participant account and the interest rate is equal to the prime rate plus 1% on the date the loan is requested. Interest rates ranged from 4.25% to 9.50% at December 31, 2024, for loans maturing through December 2044. The maximum term of a general loan is five years and the maximum term of a primary residence loan is 20 years.

**(g) Payment of Benefits**

A Participant’s vested benefits are generally payable upon reaching retirement age, separation from service with the Employer, disability, or death. Participants may apply for an in-service withdrawal of their vested participant account if they are over 59-½ years of age. Participants younger than 59-½ may withdraw a portion of their account if they show an immediate financial hardship. All benefits are payable in a lump sum distribution. Timing of distributions due to separation from service with the Employer is at the election of the Participant if the vested account balance is in excess of \$1,000. Vested balances that are less than \$1,000 are issued in a lump sum as soon as practical.

**(h) Plan Termination**

The Employer has the right under the Plan, subject to the provisions of ERISA, to discontinue contributions to the Plan and to terminate the Plan. In the event of Plan termination, all Participants will become fully vested in all accounts maintained for their benefit. There is no current intent to terminate the Plan.

**(i) Forfeitures**

Participants who separate from service with the Employer prior to becoming fully vested in their Employer account, are entitled to a distribution of their vested Participant account balance. The Participant nonvested Employer account balance is forfeited. Under certain circumstances, the forfeited amount will be restored to a Participant account if the Participant is later reemployed. As allowed by the Plan, forfeitures of approximately \$2,000,000 were used in 2024 to reduce Employer contributions. At December 31, 2024 and 2023, the Plan had approximately \$740,000 and \$1,860,000 respectively, of forfeitures available to reduce Employer contributions and to pay Plan administrative expenses in future periods.

**(2) Summary of Significant Accounting Policies**

**(a) Basis of Accounting**

The financial statements are prepared in accordance with accounting principles generally accepted in the United States of America using the accrual basis of accounting. Benefits are recorded when paid.

**(b) Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make significant estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

**(c) Risks and Uncertainties**

The Plan provides for various investment options in investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in interest rates, market conditions, and credit in the near term would materially affect the values of such investments.

**(d) Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 3 for discussion of fair value measurements.

The Plan presents in the statement of changes in net assets available for benefits the net appreciation in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation and depreciation on those investments. Purchases and sales of securities are recorded on a trade date basis and interest income is recorded on the accrual basis of accounting. Dividends are accrued on the ex-dividend date.

*(e) Notes Receivable from Participants*

Loans made to Plan Participants are secured by the underlying assets in the Participants’ account. The loans are recorded at principal balance plus accrued interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan Agreement.

**(3) Fair Value Measurements**

U.S. GAAP establishes a framework for measuring fair value, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for the Plan’s assets measured at fair value.

*Mutual Funds:* Valued at the net asset value (NAV) of shares held by the Plan at year-end, based on quoted market prices.

*Individually Directed Accounts:* Accounts primarily consist of mutual funds, interest bearing cash, common stock, corporate bonds, and exchange traded funds that are valued on the basis of readily determinable market prices.

*Collective Trusts:* Units held in collective trusts (CTs) are valued using NAV practical expedient of the CTs as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CTs, minus its liabilities, and then divided by the number of units outstanding.

CTs may be redeemed at NAV daily without restriction or notice requirements.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**(4) Tax Status**

The Plan is set forth using an Internal Revenue Services (IRS) pre-approved plan document. The pre-approved plan document obtained its latest opinion letter from the IRS on June 30, 2020. The Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions.

**(5) Information Certified by the Plan’s Trustee**
