We have performed an audit of the accompanying financial statements of Mail Services, LLC 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS**

NOTE 1 PLAN DESCRIPTION

The following description of Mail Services, LLC 401(k) Retirement Plan (the Plan) is provided for general purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all full time employees, exclusive of union employees, of Mail Services, LLC (the Company) and the participating employers to the Plan. The Plan covers eligible employees age nineteen or older after one month of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Investment Options

Upon enrollment in the Plan, a participant may direct the investment of employee and employer contributions into various investment options. The Plan currently offers several group annuity contracts with varying long-term investment objectives. Participants may change their investment options at any time.

Contributions

Participants may elect to contribute a portion of their compensation up to the maximum percentage allowable, not to exceed the limitations of Code Section 401(k), and eligible catch-up deferrals. Participants may contribute on either a pretax or post-tax basis through Roth 401(k) contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Plan provides for discretionary employer matching contributions equal to 50% of the participant's elective deferrals, limited to 3% of a participant's compensation plus an additional discretionary percentage to be determined by the Company.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching contributions plus earnings thereon are based on continuous years of service. A participant is 0% vested for the first 3 years of service. After three years of service participants are fully vested in the Company's matching contributions plus earnings thereon.

Forfeitures

Forfeitures of a participant's nonvested accounts are first used to pay administrative expenses. Any remaining forfeitures will be held in a cash account for future administrative expenses and any future discretionary employer contributions. During the years ended December 31, 2024 and 2023 no forfeited nonvested balances were used to reduce administrative expenses. Unapplied forfeited nonvested account balances totaled \$10,955 and \$4,353 at December 31, 2024 and 2023, respectively.

NOTE 1 PLAN DESCRIPTION (continued)

Payment of Benefits

Participants or their beneficiaries are eligible for benefits upon retirement, termination, death or disability. Benefits shall be distributed in one lump sum payment and are recorded when paid. There were no amounts allocated to accounts of persons who had elected to withdraw from the Plan but had not yet been paid at December 31, 2024 and 2023.

The Plan allows for hardship withdrawals to participants who meet an immediate and severe financial need, and are limited to a participant's vested account balance.

NOTE 2 SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America using the accrual method of accounting.

Investment Valuation and Income Recognition

The Plan's group annuity contracts are stated at net asset value. Net asset value is the practical expedient (method used to determine) of fair value and represents the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

The Plan has investments in Empower Annuity Insurance Company of America's (Empower) general account, referred to as the EI Fixed Account. The interest rate credited to investments in the fund is based on a current rate and is not dependent upon the length of time the assets are invested with Empower. Requests for withdrawal can be made at any time and are processed on the day that they are received by Empower, and are not dependent on the liquidation of securities in order to generate payment. The value of the fund investment reported by Empower is the redeemable value of the fund, and there are no changes or other adjustments that would affect liquidity and investment value as the result of a withdrawal request.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Uncertain Tax Positions

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Plan management has evaluated their material tax positions and determined there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 3 ADMINISTRATIVE EXPENSES

Certain administrative functions are performed by officers or employees of the Company. The costs of such services have not been determined. No such officer or employee receives compensation from the Plan. Certain other administrative expenses are paid directly by the Plan. During 2024 and 2023, fees totaling \$57,509 and \$45,979, respectively, paid to the Plan's 401(k) advisors and recordkeeper were charged equally to each participant's account on a quarterly basis.

NOTE 4 FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB Accounting Standards Codification (ASC) 820 are described as follows:

Level 1—Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets with a readily determinable fair value that the Plan has the ability to access.

Level 2—Inputs other than quoted prices included within Level 1 that are observable for the asset, either directly or indirectly, such as:

- quoted prices for similar assets in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

Level 3—Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value.

Registered investment companies—Registered investment companies are valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

El Fixed Account—The Plan has investment contracts with Empower Annuity Insurance Company (Empower). Deposits are invested in Empower's general account to which interest is added at the contractual rate. Deposits into these accounts are guaranteed the contract rate of return. The investment contract is stated at fair value.

Common/Collective trust funds - The common/collective trust funds are invested in a variety of investments intended to seek the preservation of principal and provide interest income reasonably obtained under prevailing market conditions while maintaining liquidity. The funds invest in marketable securities but are not publicly traded instruments. The fair value of funds are measured at the net asset value of units of the issuer's collective trust.

NOTE 8 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, all amounts credited to the accounts of each participant will be distributed in accordance with the terms of the Plan.

NOTE 9 FEDERAL INCOME TAX STATUS

The Plan uses a prototype plan document sponsored by The Finway Group LLC. The Finway Group LLC has received an opinion letter issued by the Internal Revenue Service, dated June 30, 2020, that the Plan is qualified under Internal Revenue Code (IRC) Section 401. Although the Plan has been amended since receiving the determination letter, the prototype sponsor and the Plan administrator believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

NOTE 10 RISKS AND UNCERTAINTIES

Participants invest their account balances in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 11 SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through September 15, 2025, the date which the financial statements were available to be issued. There were no subsequent events which required accrual or disclosure.



