Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Medical Specialties, Inc. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Medical Specialties, Inc. Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Medical Specialties, Inc. Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. 1. DESCRIPTION OF PLAN

The following description of the *Medical Specialties, Inc. (Company) Retirement Plan* (Plan), as amended, provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General. The Plan is a defined contribution plan covering all full-time employees of the Company who have completed 500 hours of service within the first six months of employment and are age 20 ½ or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions. Each year, participants may contribute up to 100% of pretax compensation, as defined in the Plan, subject to the maximum allowed under the Internal Revenue Code. Participants may also contribute amounts representing distributions from other defined benefit or contribution plans. The Company makes a "safe harbor" matching contribution of 100% of the first 3% of base compensation that a participant contributes plus 50% of the next 2% of the participant's deferral. The Company may also make a discretionary profit-sharing contribution each year.

Participant Accounts. Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting. Participants are immediately vested in their contributions plus actual earnings thereon and the Company's matching contribution. There is no vesting in the Company's discretionary contribution plus earnings thereon for the first two years of credited service. However, a participant is 100% vested after six years of credited service. Participants are vested 20% each year in the Company's matching contribution from years two through six.

Investment Options. All investments are participant directed. Participants can choose from various investment options. These options consist of pooled separate accounts and unallocated contracts held by Minnesota Life Insurance Company as custodian under a Master Annuity contract.

Pooled separate accounts invest primarily in publicly traded mutual funds with low to moderate risk and the unallocated contract (General Account) invests in the general assets of Minnesota Life Insurance Company.

Participants may change their investment options at any time.

Payment of Benefits. On termination of service due to death, disability or retirement, a participant with an account balance of \$1,000 or less will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. These are several payment options for participants with account balances in excess of \$1,000.

Forfeited Accounts. Benefit payments to terminated employees partially vested in the Plan include their vested portion of the Employer's discretionary contributions. The nonvested portion of terminated participants' account balances is used to reduce the Employer's future contributions or to pay the Plan's administrative expenses, as determined by the Employer at its sole discretion. As of December 31, 2024 and 2023, there were \$240 and \$229 of nonvested accounts available for future use. For the year ended December 31, 2024, \$0 of forfeited nonvested accounts were used to decrease employer contributions.

Administrative Expenses. All expenses of maintaining the Plan are paid by the Plan Sponsor. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included as adjustments to the investment rate that is credited to the specific investment.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's pooled separate account investments are stated at fair value as certified by Minnesota Life Insurance Company. Unallocated contracts are stated at contract value. In the management's opinion, contract value approximates fair value due to terms of the contract. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

Notes Receivable - Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Notes fund. Loan terms range from 1-5 years except for the purchase of a primary residence, in which case the administrator may permit a longer repayment period. The loans are secured by the balance in the participant's account and bear interest at prime + 1%. Principal and interest is paid ratably through payroll deductions.

Notes receivable are measured at their unpaid principal balance plus accrued interest. Delinquent participant loans are treated as distributions based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

3. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

4. TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's attorney believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

4. TAX STATUS, CONCLUDED

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if it has taken a significant uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator feels the Plan had no such positions at December 31, 2024. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN

The Plan's investments were held in trust and administered by the custodian, Minnesota Life Insurance Company for the years ended December 31, 2024 and 2023. All investment and notes receivable information disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the custodian.

6. FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Current accounting standards require the identification of inputs or assumptions that are used to value assets and liabilities. Following is a description of the valuation inputs –

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – observable inputs other than quoted prices such as market-based prices for similar assets and liabilities

Level 3 – unobservable inputs

Pooled separate accounts are reported at fair value as certified by Minnesota Life Insurance Company. Unallocated contracts are stated at contract value, which in management's opinion approximates fair value.

7. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has a group annuity contract with an insurance company that is not considered fully responsive. The insurance company maintains the contributions in a general account, which is credited with earnings and charged for participant withdrawals and administrative expenses.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Since the group annuity contract is a non-fully benefit-responsive, market value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. The group annuity contract is presented on the face of the statements of net assets available for benefits at fair value which approximates contract value. The contract value, which approximates fair value, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with the insurance company. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (5) premature termination of the contract.

Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. The insurance company may not terminate the contract at any amount less than the contract value, which approximates fair value.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value, which approximates fair value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

7. INVESTMENT CONTRACT WITH INSURANCE COMPANY, CONCLUDED

The insurance company is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the insurance company. Such interest rates are reviewed on a quarterly basis for resetting. The crediting rate of the product will be established based on the earnings of the underlying assets in the entire medium-long term portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The average yield earned by the Plan for the group annuity contract is derived by averaging the quarterly gross interest rates for the fund over the year.

The average for 2024 was 1.92%. The actual average yield earned by the Plan for the group annuity contract is derived by averaging the Plan's quarterly interest rates. The average yield for 2023 was 1.94%.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS/EXPENSES

Minnesota Life Insurance Company (Minnesota) is the custodian of the Plan and manages certain investments held by the Plan. Fees charged by Minnesota are netted against investment income. Securian Financial Group performs record keeping services for the Plan and the fees for the year ended December 31, 2024, were \$9,951. Transactions with Minnesota Life Insurance Company and Securian Financial Group qualify as party-in-interest.

The Plan sponsor provides the Plan with certain accounting and administrative services for which no fees are charged. The Plan sponsor also pays for some audit and administrative expenses for the Plan for which no reimbursement is received from the Plan.

10. SUBSEQUENT EVENTS

Management has evaluated subsequent events through the date of the Auditor's report, the date the financial statements were available to be issued.
