Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Medical Care Development, Inc. 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). 1. Description of Plan

The following description of the Medical Care Development, Inc. 403(b) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Medical Care Development, Inc. d/b/a MCD Global Health (the Company). The Plan is available to substantially all Company employees. Employees are eligible to make salary deferrals to the Plan immediately if expected to work at least 20 hours per week. To receive employer contributions, an employee must have completed one year, including 1,000 hours, of service during the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Employees can elect to contribute up to 100% of their compensation on a pre-tax basis during each Plan year, up to a maximum allowable amount, as determined by the Internal Revenue Code (the Code). Participants direct the investment of their contributions into various investment options offered by the Plan. Employees must contribute to the Plan for that plan year to receive an employer match. As a safe harbor plan, the Company will match 100% of the employee's contribution up to a maximum of 5%. Employees will immediately vest in all safe harbor contributions. Additional discretionary contributions may be made and are subject to a three-year cliff vesting.

For eligible employees who have three years of service, but less than five years of service, the Company will contribute an additional match of 1%. For eligible employees who have five years of service or more, the Company will contribute an additional match of 2%. This discretionary match is contingent on the employee deferring at least 5% of their salary as employee contributions.

Investment Options

Participants may elect to invest contributions made on their behalf in any of the Plan's investment options, which are comprised of mutual funds and a money market fund offered by the trustee. The prospectus for each fund should be reviewed to determine the fund's investment objectives.

Benefits

The Plan provides benefits to participants upon death, disability, retirement, or termination of employment. Benefits will be paid to the participant in a lump-sum payment if the balance of the account is less than or equal to \$1,000. If the balance exceeds this amount, the participant may elect to receive the benefit in a lump-sum payment, an annuity, in installment payments, or by transfer to another qualifying plan. A participant may also elect to leave the monies in the Plan until they are required to begin receiving minimum annual distributions starting at age 73.

Forfeitures

The non-vested portion of accounts attributable to participants who terminate employment is applied to either offset future Company contributions or to pay allowable Plan expenses. For the years ended December 31, 2024 and 2023, no forfeitures were used to offset employer contributions or reduce Plan expenses. As of December 31, 2024 and 2023, forfeitures available for use totaled \$12,600 and \$0, respectively.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses to the extent that they are not paid by the Company. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

The Plan document includes provisions authorizing loans from the Plan to active eligible participants. Participants are allowed to have no more than one loan outstanding at any time. The minimum amount of a loan shall be \$1,000. Loans made to a participant cannot exceed the lesser of (a) \$50,000, or (b) 50% of the participant's account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of principal residence). For loans originating in any given month, interest will be based on the reasonable rates charged by persons in the business of lending money for loans under similar circumstances, currently the prime rate, plus 1%.

Termination of Plan

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination, participants will become fully vested in all employer contributions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting and are presented in conformity with U.S. generally accepted accounting principles (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are recorded at fair value as calculated by the Plan's trustee. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments are recorded on a trade date basis. Net appreciation in fair value of investments includes both realized and unrealized gains and losses.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses are charged against the accounts of the participants to the extent they are not paid by the Company. Expenses paid by the Plan are described in Note 4.

Subsequent Events

Management has evaluated subsequent events through September 25, 2025, the date the financial statements were available for issuance.

3. Tax Status

The Plan utilizes a volume submitter plan (VSP) through a service provider. The Internal Revenue Service has informed the service provider by letter dated March 31, 2017, that the VSP is designed in accordance with Section 403(b) of the Code and the regulations issued thereunder. The plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

4. Party-In-Interest Transactions

Ascensus Trust Company (ATC) was the Plan's trustee as of December 31, 2024 and 2023. Transactions with ATC qualify as party-in-interest. Administrative expenses paid to ATC by the Plan were \$22,750 and \$21,471 for the years ended December 31, 2024 and 2023, respectively. Kestra Advisory Service (KAS) was the Plan's advisor as of December 31, 2024 and 2023, respectively. Transactions with KAS qualify as party-in-interest. Administrative expenses paid to KAS by the Plan were \$28,945 and \$22,445 for the years ended December 31, 2024 and 2023, respectively.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023.

Mutual funds and money market fund: Valued at the quoted market price of the net asset shares held by the Plan at year-end.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
