INDEPENDENT AUDITOR'S REPORT

To the Trustees of Leith Group Health Trust

Opinion

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule of reportable transactions for the year ended December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

1. DESCRIPTION OF PLAN

General—The following description of the Leith Group Health Trust (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a complete description of the Plan’s provisions.

The Plan is a health and welfare benefit plan that provides health benefits to eligible employees of Leith, Inc. (the “Company”) and affiliates (i.e., active participants), qualified dependents and spouses, and beneficiaries. At each annual enrollment period, provisions, such as participant contribution rates, coverage, deductibles, co-pays, and out-of-pocket maximums, may change. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits—The Plan provides health (major medical and dental) and drug benefits coverage to substantially all full-time employees under specifications of the Plan. Medical benefits are subject to individual and family deductibles, as well as co-payment of expenses up to a defined limit. Utilization reviews are performed and benefit payments are processed by a third-party administrator. Utilization review is a program that reviews the setting, necessity, and quality of health care.

Contributions—The Plan document provides that the Company will, from time to time, evaluate the costs of the Plan and determine an amount to be contributed by the Company and the amount to be contributed by each participant. A participant may contribute specified amounts to extend coverage to eligible dependents. The Company makes discretionary contributions to fund any medical and dental costs in excess of amounts contributed by participants.

Benefit Obligation—The benefit obligation consists of estimated amounts required to settle both claims for which notice has been received (reported) and claims that have been incurred but not reported (IBNR). The estimate was made by the Company based on relevant information provided by the Plan’s third-party administrator.

Premiums—Health benefits provided pursuant to the Plan were self-funded through the Leith, Inc. Voluntary Employee’s Beneficiary Trust (the “Trust”) until its depletion and automatic termination in November 2024, and through the general assets of Holman Automotive Group, Inc. (HAGI), holding entity of the Company, for the remainder of the plan year. The Plan purchases stop-loss insurance coverage on both specific and aggregate levels.

Deposits with Holding Entity – Beginning July 2024, all contributions and rebates are now sent to the Company’s holding entity, HAGI. HAGI began paying all benefit obligations, plan administrative expenses, insurance premiums, tax expenses on behalf of the Plan upon the depletion of the Trust.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting—The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates—The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein; claims IBNR; and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Claims IBNR—Plan liabilities for health claims IBNR are based on claims experience provided by the Plan's third-party administrator, and estimates are based on historical experience.

Claims Paid—Claims are recorded when the Plan paid the claims administrator.

Risks and Uncertainties—The Plan utilized a money market account until its closure in August 2024. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

As of December 31, 2024 and 2023, the concentration of risk associated with Wells Fargo Business High Performance Money Market Account was 0% and 100%, respectively.

Investment Valuation and Income Recognition—The Plan's sole investment consisted of the Wells Fargo Business High Performance Money Market Account until its closure in August 2024 and was valued at cost, plus accrued interest, which approximates fair value. Interest income is recorded on the accrual basis.

Administrative Expenses—Expenses incurred in the administration of the Plan are paid by the Plan.

Rebates—Rebates due from a Plan's pharmacy benefits manager are recorded when earned. Rebates due as of the financial statement date are reported as receivable, with the offset being netted against claims paid. Pharmacy rebates totaling \$926,741 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

Unrelated Business Income Taxes—The Plan accounts for income taxes under the liability method as prescribed by Accounting Standards Codification (ASC) 740, *Income Taxes*. Under the liability method, deferred income taxes are derived on the differences between the book and tax basis of assets and liabilities.

3. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

The Plan's sole investment was in the Wells Fargo Business High Performance Money Market Account. Wells Fargo is the custodian as defined by the Plan, and, therefore, these transactions qualify as exempt party-in-interest transactions. The account was liquidated and closed in August 2024. There were no fees paid by the Plan for investment management or administrative services for the year ended December 31, 2024.

4. FEDERAL INCOME TAX STATUS

The Trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code (IRC), and accordingly, the Trust's net investment income is exempt from income taxes. The Trust has obtained an exemption letter dated February 6,

1990, from the Internal Revenue Service (IRS), and the Company believes that the Trust, as amended, continues to qualify and to operate in accordance with the applicable requirements of the IRC. The Plan and related trust continue to be tax exempt. However, the Plan expects to be subject to unrelated business income tax (UBIT) expense under the IRC for the 2024 plan year.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to amend and terminate the Plan subject to the provisions set forth in ERISA. In the event of termination, the Company will contribute the necessary amounts to fund all claims incurred prior to the date of termination.

6. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

A reconciliation of amounts reported in the Plan's financial statements to amounts reported in the Form 5500 is required by ERISA. The following is a reconciliation of net assets available for benefits per the financial statements to the Form 5500 for the years ended December 31, 2024 and 2023.

7. FAIR VALUE MEASUREMENTS

ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy, which prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Asset Valuation Techniques—Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market Account—Valued at cost, plus accrued interest, which approximates fair value and is categorized as Level 1. Account was closed in August 2024.

A summary of the Plan’s investments measured at fair value on a recurring basis set forth by level within the fair value hierarchy at December 31, 2024 and 2023, is as follows:
