Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform audits of the financial statements of 403(b) Thrift Plan of Cooke School and Institute (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate to the best of their knowledge.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

Responsibilities of Management

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matter described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental schedules listed in the table of contents are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section it is inappropriate to and we do not express an opinion on these supplemental schedules.

Note 1. Description of the Plan

The following description of 403(b) Thrift Plan of Cooke School and Institute (the Plan) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

On March 27, 2023, Board of Trustees passed a resolution to cancel annuity contract rights and consents with Mutual of America Life Insurance Company (MOA) and transfer balances to Transamerica Financial Life Insurance Company (TFLIC) and State Street Bank and Trust Company (State Street). The plan assets of approximately \$17,290,000 were transferred from MOA to TFLIC and State Street and remaining balance of \$13,403 and \$12,817 was maintained at MOA as of December 31, 2024 and 2023, respectively.

Effective May 1, 2023, the Plan was amended and Transamerica Retirement Solutions, LLC (Transamerica) became the Plan's record-keeper and TFLIC and State Street became the plan trustees (together known as the Trustee). The change initiated a "Black Out" period beginning May 1, 2023, and continued through May 19, 2023. During this period, funds could not be applied to the employee-selected funds with the Trustee or withdrawn from the Plan until the Trustee had time to accurately complete the conversion. During this period, employee contributions continued to be made through payroll deductions and the contributions were deposited into replacement investment options provided by Transamerica. At the end of the Black Out period, participants were able to review their options and make changes.

General

The Plan is a contributory defined contribution plan covering all employees of Cooke School and Institute (the Employer) (the Sponsor) not covered by a collective bargaining agreement. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Contributions

The Plan is a contributory defined contribution plan covering all eligible employees. There is no minimum age requirement and no minimum service requirement for participant contributions. The total contribution to the Plan may not exceed the dollar limit for tax-deferred contributions set by the Internal Revenue Code. Participants age 50 or more may make additional "catch-up" contributions. The Plan also allows for special code Section 403(b) catch-up contributions for those participants with 15 years of service. Contributions are subject to certain limitations.

Employer discretionary contributions were permitted under this Plan. Employees become eligible to receive employer discretionary contributions after completing one year of service and reaching age 21. A year of service, for eligibility purposes, is defined as follows:

- A participant will have completed a year of service if, at the end of his or her first 12 consecutive months of employment with the Employer, a participant has been credited with 1,000 hours of service.
- If a participant has not been credited with 1,000 hours of service by the end of his or her first 12 consecutive months of employment, the participant will have completed a year of service at the end of the following plan year during which a participant was credited with 1,000 hours of service.

The Plan provides for the employer matching contribution of 1.5% of compensation for all employees with one to five years of service and 3% of compensation for all employees with six or more years of service.

The Plan provides for the nonelective contribution of 3% of compensation for all employees with one to 10 years service and 4.5% of compensation for all employees with 10 or more years of service.

The Plan has elected 3% of an employee's salary as the Plan's default automatic deferral percentage.

The Plan allows employees to make Roth contributions and for the special code Section 403(b) catch-up contributions for those participants with 15 years of service.

The Plan does accept rollovers and transfers from other qualified plans, but only for those employees eligible to participate in the Plan.

Contributions to the Plan on behalf of a participant are invested at the direction of the participant in selections of mutual funds and a guaranteed investment contract account.

Effective August 1, 2024, Plan was amended to change the service period requirement for 3% employer matching contributions from six to five years. Additionally, the employer elected to annualize employer matching contributions.

Participant Investment Account Options

Investment account options available include mutual funds and a guaranteed investment account. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment options at any time.

Participant Accounts

Each participant's account is credited with the allocations of (a) the Employer's contribution, (b) the participant's contribution, and (c) the participant's share of plan earnings. Plan income and expenses are credited or debited to participant accounts based on the pro rata share of the participant's individual account balance to total plan assets. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

A participant shall at all times be 100% vested in the amounts in his or her employee contribution accounts. The amounts in a participant's employer contribution accounts shall be 100% vested upon the attainment of 65 years of age or, if earlier, upon meeting the applicable vesting requirements below:

Payment of Benefits

A participant's vested account is payable upon termination, retirement, disability hardship, or death. The participant, or designated beneficiary upon the participant's death, may choose to receive a lump-sum payment or installment payments.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of 50% of the value of the individual's vested account balance or \$50,000. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) directly through the employees. The loans are secured by the balances in the participants' accounts and bear interest at a rate of prime rate plus 1% effective May 1, 2023 and reasonable rate prior to May 1, 2023. Interest rates range from 4.6% to

9.5% as of December 31, 2024 and 2023. Participant loans that go into default or otherwise violate the provisions of the plan documents are deemed to be distributed.

Forfeited Accounts

Forfeitures from terminated nonvested plan participants are used to pay all open charges under the contract for the terminated participant. There were no forfeitures applied during the year ended December 31, 2024. As of December 31, 2024 and 2023, there were \$13,158 and \$10,079, respectively, of unapplied forfeitures.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan's investment in the Mutual of America general account is recorded at fair value. This account is not fully benefit-responsive.

The Plan's investment in the TFLIC guaranteed investment contract is recorded at contract value. Contract value represents contributions made under the contract, plus a minimum rate of interest earned, at a rate determined by the contract issuer, less withdrawals, and transfers to other accounts. This account does not have any liquidity restrictions and is fully benefit-responsive (see Note 5 for a further discussion of this fully benefit-responsive investment contract).

Purchases and sales of securities are recorded on a trade-date basis. As applicable, interest income is recorded on the accrual basis, and dividend income is accrued on the ex-dividend date. The income or loss of each investment option, including the change in market value of investments, is allocated to participant accounts based on each participant's proportionate interest in the investment option. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan documents.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Expenses of administering the Plan are paid by either the plan sponsor, the participants, or by the Plan, as provided in the plan document. During 2024, the Plan incurred certain administrative fees. Fees paid to trustee for investment management are paid by the Plan as a reduction of the net depreciation in fair value (see Note 6).

Note 3. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets

In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, investments are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of investments with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sources market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such investments are classified in Level 2 of the valuation hierarchy. Level 2 securities include general account and pooled separate accounts. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Note 4. Certification of Plan Custodians

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, MOA, TFLIC and State Street, qualified institutions, have certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate to the best of their knowledge:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 5. Investment Contract with Insurance Company

The Plan entered into a fully benefit-responsive investment contract with TFLIC. TFLIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

This investment contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligation. The issuer's ability to meet its contractual obligation may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuers. These events may be different under each contract. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the Code or the failure of the trust to be tax-exempt under Section 501(a) of the Code
- Premature termination of the contracts
- Plan termination or merger
- Changes to the Plan's prohibition on competing investment options
- Bankruptcy of the plan sponsor or other plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations

In addition, certain events allow the issuers to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines
- A breach of material obligation under the contract
- A material misrepresentation
- A material amendment to the agreements without the consent of the issuer

The plan administrator does not believe the occurrence of any such event, which would limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

Note 6. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain plan investments are insurance products that are managed by the custodians. In addition, certain participants of the Plan paid the custodian for participant administrative fee of \$54,367 and investment advisor fees of \$38,393 during the year ended December 31, 2024. The Sponsor directly pays any other fees related to the Plan's operations. These transactions qualify as party-in-interest transactions, which are deemed to be "exempt" from Prohibited Transaction Rules as defined by Department of Labor regulations.

The Sponsor provides certain administrative services at no cost to the Plan.

Note 7. Tax Status

The Plan operates under a volume submitter agreement in connection with a volume submitter prototype plan documents sponsored by Transamerica Retirement Solutions LLC, effective May 1, 2023, and Mutual of America Life Insurance Company, prior to May 1, 2023. These volume submitter plan documents have obtained an advisory letter from the Internal Revenue Service stating that the volume submitter satisfies the requirements under Section 403(b) of the Internal Revenue Code. The Plan has been amended since these prototypes received favorable letters. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and not subject to tax.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue their contributions at any time and to terminate the Plan, subject to the provisions of ERISA. Should this occur, participants are and will remain 100% vested in their deferral accounts and become 100% vested in their employer contribution accounts.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10. Nonexempt Transactions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. Although all contributions and loan repayments were remitted to the Plan, the Sponsor failed to timely remit participants' contributions and loan repayments for certain payroll periods during 2024 and 2023. In accordance to the DOL Regulations 2510.3-102, the Plan reported delinquent participant contributions and loan repayments of \$63,793 and \$40,353 as of December 31, 2024 and 2023, respectively. The 2024 late remittance amount includes \$3,809 from a September 2023 pay date deposited in March 2024. Lost earnings on the \$40,353 of 2023 late remittances have not yet been calculated and contributed to the Plan therefore continue to be reported as late remittances during 2024.
