INDEPENDENT AUDITOR'S REPORT

To the Trustee of Leith, Inc. 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Leith, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be

independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

1. DESCRIPTION OF PLAN

The following description of the Leith, Inc. 401(k) Profit Sharing Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General—The Plan is a defined contribution plan covering eligible employees of Leith, Inc. and affiliates (the “Company”), who are at least 18 years of age and have completed three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The purpose of the Plan is to provide for discretionary profit-sharing contributions, elective deferrals pursuant to Internal Revenue Code (IRC) Section 401(k), and discretionary-matching contributions for employees of the Company and its participating affiliates.

Matrix Trust Company and Milliman USA serve as the trustee and recordkeeper, respectively, of the Plan.

On March 18, 2024, the Company was acquired by Holman Enterprises. The acquisition has not affected the operations of the Plan.

Contributions—Each year, participants may contribute up to 50% of their pretax annual compensation, as defined by the Plan, subject to certain IRC limitations. Participants have the option to make Roth elective salary reduction contributions up to 50% of after tax annual compensation, as defined by the Plan, subject to certain IRC limitations. If an employee is eligible to participate in the Plan and has not declined to participate, pretax enrollment at a deferral rate of 5% is automatic after three months of service. Participants aged 50 and over are eligible to make catch-up contributions. The Company, at its discretion, may match participant contributions to the Plan. In 2024, the Company matched 25% of the first 5% of eligible compensation that a participant contributed to the Plan. The Company’s matching contribution for the year ended December 31, 2024, was \$1,395,230.

Additional amounts may be contributed at the discretion of the Company’s board of directors to those eligible employees who have completed one year of service and are employed on the last day of the Plan year. The Company made additional discretionary profit-sharing contributions of \$470,000 to the Plan for the 2024 plan year, allocated to participants proportionately based on eligible wages.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions are subject to certain IRC limitations.

Participant Accounts—Individual accounts are maintained for each participant of the Plan. Each participant's account is credited with the participant's contribution, and related matching and nonelective contributions and Plan earnings. Participant accounts are also charged with withdrawals, and an allocation of Plan losses and administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments—Participants direct the investment of their contributions into various investment options offered by the Plan. Currently, participants can choose among 16 mutual funds. Participants may allocate their contributions among these funds. In addition, they may transfer previously contributed amounts among these funds.

Vesting—Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service for the discretionary profit-sharing contributions. A participant is 100% vested ratably after six years of credited service for employer-matching contributions. Participants become fully vested at age 65, or upon death, disability, or retirement under the Company's retirement policy.

Participant Loans—The Plan does not allow participants to borrow from their accounts.

Payment of Benefits—On termination of service with the Company (including termination of service due to death, disability, or retirement), a participant will be eligible to receive all vested account balances. If the vested account balance is not greater than \$1,000, the participant will automatically receive a lump-sum payment, unless a direct rollover is requested. If the vested account balance is between \$1,001 and \$5,000, the balance will automatically be rolled over into an Individual Retirement Account (IRA) with Charles Schwab Trust Company, unless the participant requests a direct rollover to an account of their choice within 60 days of termination. If the vested account balance is greater than \$5,000, the participant may elect either a lump-sum payment or a direct rollover. If a participant has a vested balance over \$5,000 in their account, they may also take no action, and the balance will remain in the Plan. In addition, effective July 1, 2011, a participant who has reached age 65 may take an in-service withdrawal of vested amounts in the form of a lump-sum payment or a partial cash payment.

Hardship Distributions of Benefits—Participants may obtain hardship benefit distributions up to 100% of their elective deferral account balances in the event of immediate and heavy financial need, as defined in the Plan document. Hardship distributions are not in addition to the participants' other benefits and will, therefore, reduce the value of the benefits participants receive at normal retirement. Hardship distributions are subject to certain conditions of the Plan and the IRC.

Forfeitures—At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$80,191 and \$48,331, respectively. Forfeitures from terminated participants' nonvested accounts are used to reduce administrative expenses, and any excess is used to reduce the Company's matching contributions or future profit-sharing contributions to the Plan. During the year ended December 31, 2024, forfeitures of \$2,355 were used to offset employer match. Also, during 2024, the Company used \$135,000 of forfeitures to reduce profit sharing contributions.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting—The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates—The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties—The Plan provides various investment options to its participants. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the value of the participants' account balances and the amounts reported in the financial statements.

Investment Valuation and Income Recognition—Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investments in shares of mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions—Employee contributions and employer matching contributions are recorded when employee contributions are withheld.

Administrative Expenses—Certain administrative expenses of the Plan are paid by the Company as provided in the Plan document. Participant transaction fees are paid by Plan participants through a reduction in their account balances. Administrative expenses, including a monthly recordkeeping fee of \$5.50 per participant, are paid through credits provided by the recordkeeper for Plan investments. Participants pay administrative costs for qualified domestic relation orders. All investment management and transaction fees directly related to the Plan investments are paid by the Plan. Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, investment management fees and operating expenses are reflected as a reduction of investment return for such investments.

Excess Contributions Payable—The Plan is required to return contributions received during the Plan year in excess of the IRC limits. There were no excess contributions payable at December 31, 2024. Excess contributions payable at December 31, 2023 were \$32,983.

Payment of Benefits—Benefit payments to participants are recorded upon distribution. There were no amounts allocated to accounts of persons who have elected to withdraw from the Plan, but have not yet been paid at December 31, 2024 and 2023.

3. PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

4. FEDERAL INCOME TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust were designed in accordance with the applicable regulations of the IRC. The Company and Plan management believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC, and the Plan and related trust continue to be tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. CERTIFIED INVESTMENT INFORMATION

The following is a summary of the certified information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedule that was prepared by, or derived from, information prepared by Matrix Trust Company, the trustee of the Plan, and furnished to the Plan administrator. The Plan administrator has obtained certifications from Matrix Trust Company that such information is complete and accurate.

6. FAIR VALUE MEASUREMENTS

ASC 820 provides a framework for measuring fair value. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market, but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Asset Valuation Techniques—Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodology used for assets measured at fair value. The valuation method described below may produce a fair value calculation that may not be indicative of net realizable value of future fair values. Furthermore,

although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds—Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
