Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Slosburg Company 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Slosburg Company 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Slosburg Company 401(k) Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Slosburg Company 401(k) Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

NOTE A – DESCRIPTION OF PLAN

The following description of the Slosburg Company 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan is a defined contribution plan covering all eligible persons of Slosburg Company and affiliated entities (Company) who are 21 years of age or older and who have obtained one-fourth of one year of service. The Plan is subject to and complies with the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

2. Contributions

Each year the Company contributes to the Plan the total amount of the salary reduction the participant elects to defer and Company contributions as specified in the Plan. Participants may also make rollover contributions which are amounts distributed from other qualified defined benefit and defined contribution plans. For 2024 and 2023, the Company matched \$0.25 for every \$1.00 of employee deferrals up to five percent of their deferral.

Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions subject to the specific dollar limits determined by the Internal Revenue Service. Participants may modify the amount of their salary deferral contributions at any time, to be effective the first of the following month. Participants may direct the investment of their contributions (and the Company's contributions) into various investment options offered by the Plan.

3. Participant Accounts

Each participant's account is credited with the contributions of the participant and the Company. Participants may allocate their funds amongst an array of investment choices provided to them by the Plan Administrator. Investment earnings accumulate within each participant's account according to the allocation of funds selected by the participant and the rate of return, thereon. The benefit to which a participant is entitled is the vested portion of the accumulated balance of participant and Company contributions and investment earnings accumulated thereon.

4. Vesting

Participants are immediately vested in their elective contributions and rollovers, plus actual earnings thereon. Vesting for the employer matching contributions and related earnings is based on the number of the participant's years of continuous service until the participant reaches six years of service at which point the balance of those contributions and the related earnings are then fully vested.

NOTE A – DESCRIPTION OF PLAN – Continued

5. Notes Receivable from Participants

Participants are permitted to borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest rates between 4.25% to 9.50% during 2024 and 2023. The loan interest rate is set at one percent above prime rate. Notes receivable from participants are valued at unpaid principal balances. Interest income is recognized as principal and interest is paid through bi-weekly payroll deductions.

Fees related to the administration of notes receivable are charged directly to the participant's accounts. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

6. Payment of Benefits

Upon termination of employment, due to retirement, death, or disability, a participant may elect to receive either a lump-sum amount equal to the value of his or her account or annual installments as provided by the Plan. For termination of employment for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. If the account is over \$5,000, the participant may elect to keep the vested portion of his or her account in the Plan, without future matching benefits. If the account is between \$1,000 and \$5,000, the Company may elect to make a direct rollover of the vested interest into an independently or third-party managed IRA when the participant does not elect to receive a lump-sum distribution.

7. Forfeited Accounts

The non-vested portion of participant withdrawals is placed into a separate account by the Directed Trustee. This account may be used to pay Plan administrative fees or to reduce Company contributions. In 2024 and 2023, respectively, Company contributions were not reduced from payments made out of the forfeited non-vested account. Forfeitures were not used to pay administrative fees in 2024 and 2023. Additionally, forfeitures were used to reduce Sponsor contributions by \$0 and \$4,131, for the years ending December 31, 2024 and 2023, respectively. As of December 31, 2024 and 2023, unallocated forfeitures were \$28,272 and \$9,472, respectively.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Presentation

The financial statements of the Plan are prepared using the accrual method of accounting and in conformity with accounting principles generally accepted in the United States of America.

2. Administrative Expenses

Plan fees are recorded as administrative expenses and are expensed when they are incurred. Certain expenses of maintaining the Plan, such as the annual audit, are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

3. Income Tax Status

The Internal Revenue Service has determined and informed the Plan by a letter dated March 31, 2008, that the Plan and related trust are designed from a prototype which was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

The Plan Administrator does not believe that the Plan has any uncertain tax positions and therefore, no provisions have been made. The Plan could still be subject to Department of Labor or Internal Revenue Service audits for the years ending December 31, 2023, 2022 or 2021, respectively.

4. Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

5. Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note E for discussion of fair value measurements and Note F for further discussion of fully benefit-responsive guaranteed investment contracts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

6. Payments of Benefits

Benefits are recorded when paid.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE C – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions. Their accounts shall be distributed to participants in accordance with provisions of the Plan.

NOTE D – CERTIFIED FINANCIAL INFORMATION

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator has obtained certifications from United of Omaha Life Insurance Company covering January 1, 2023 through July 1, 2024, and from Matrix Trust Company, for the period of July 1, 2024 through December 31, 2024. The certifications that all information relating to the pooled separate accounts and guaranteed investment contracts are complete and accurate. Information as to the value of the investments in these funds, including their investment income and related information in the supplemental schedules, is presented in reliance solely upon this certification.

NOTE E – FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits, except for the Plan's contract with United of Omaha Life Insurance Company. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. The administrative committee determines the Plan's valuation policies. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 are used for investments for which Level 1 inputs were not available. Level 3 would be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented. The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund.

Level 1 Fair Value Measurements

The mutual funds held by the Plan are open-end mutual funds registered with the SEC. The funds must publish their daily net asset value and transact at that price. The money market and mutual funds held by the Plan are considered to be actively traded.

Level 2 Fair Value Measurements

The pooled separate accounts (PSA) contain a mix of mutual funds, collective trusts and managed accounts which are all valued daily. While some investments in the pooled separate accounts may have publicly quoted pricing inputs (Level 1), the account values of the separate accounts themselves are classified as Level 2 investments since they are not publicly quoted and the investments may be redeemed at their net asset values (NAV) as of the measurement date. The NAV is based on the value of the underlying assets owned by the PSA, minus any liabilities, divided by the number of shares outstanding in the account.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

NOTE F – GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

In 2003, the Plan entered into a fully benefit-responsive guaranteed investment contract with United of Omaha Life Insurance Company (Directed Trustee). The Directed Trustee maintains the contributions in a maturity account (which is held for a fixed period of time as part of the Directed Trustee’s general assets), to which it adds interest. The interest rate is declared at the beginning of each month for a five-year investment term and guaranteed for deposits received during that month. The interest rates that are declared are based on current market conditions and what quality assets the Directed Trustee can purchase to support the corresponding liability. The credited and actual weighted average interest rate yield for 2024 and 2023 was 3.11% and 2.86%, respectively. Administration expenses were charged against the contract at a rate of 0.40% of assets annually for 2024 and 2023.

The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The contract specifies certain events and conditions which may lead to the discontinuance of the contract. These could include premature termination of the contract, layoffs, Plan termination, mergers, etc. In the event the contract is discontinued, the Plan may be limited in transacting at contract value if its participants elect to receive lump-sum distributions for their portion of the contract balance. When this election is made the contract specifies the issuer may make fair value adjustments, as defined by the contract, prior to issuing the disbursements.

Effective July 1, 2024, all assets held under the GIC were transferred into a collective trust account guaranteed by United of Omaha Life Insurance Company. This transfer was initiated due to the transition of plan management from Mutual of Omaha to Ascensus.

NOTE G – PARTIES IN INTEREST

Several officers of the Company provide various services to the Plan including administrative functions. Services are provided by the Company at no cost to the Plan.

As described in Note F, participants of the Plan may elect to allocate a portion of their fund balance to an investment contract insured by United of Omaha Life Insurance Company (Directed Trustee), who also managed the Plan’s investments for the years ended December 31, 2024 and 2023. Several of the mutual funds offered to participants are also managed by the Directed Trustee. Therefore, Plan transactions with these particular investments are deemed party-in-interest transactions. Fees paid by the Plan to United of Omaha Life Insurance Company for investment management services were \$27,784 and \$5,950 for the years ended December 31, 2024 and 2023, respectively.
