Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Klehr Harrison Harvey Branzburg LLP (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

1. Description of the Plan

The following description of the Klehr Harrison Harvey Branzburg LLP 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan was established on January 1, 1984 as a contributory defined contribution plan covering all employees of Klehr Harrison Harvey Branzburg LLP (the Firm) on the date of hire with respect to the right to make elective deferrals. The Klehr Harrison Harvey Branzburg LLP 401(k) Committee and the plan administrator control and manage the operation and administration of the Plan. Employees are eligible for the Firm's matching and profit sharing contributions after one year of service and at least 1,000 hours of service during a one-year eligibility period, as defined by the plan document. Effective January 1, 2007, employees designated as nonpartner attorneys, legal assistants and paralegals are no longer eligible to participate in the Plan. These individuals are eligible to participate in the Klehr Harrison Harvey Branzburg LLP 401(k) Salary Deferral Plan for Associates and Paralegals (Associates and Paralegal Plan). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Periodically, participants in the Associates and Paralegal Plan are admitted to participate in the Plan. Consequently, these individuals become ineligible for the Associates and Paralegal Plan, and their accumulated balances formerly held in the Associates and Paralegal Plan are transferred in-kind to the Plan. Transfers into the Plan were \$113,454 and \$0 for the years ended December 31, 2024 and 2023, respectively.

Fidelity Management Trust Company (current Trustee) is the Trustee of the Plan effective December 2, 2024. Empower Trust Company, LLC (prior Trustee) was the Trustee prior to December 2, 2024.

The Plan was restated effective January 1, 2022, to incorporate previous amendments and reflect recent changes in the tax laws and regulations. Additionally, in connection with the restatement, the Plan received a new determination letter, dated June 30, 2020, from the Internal Revenue Service (IRS), that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC), and accordingly, is not subject to federal or local income taxes.

Contributions

Salary deferral - Participants may contribute a percentage of pretax annual compensation, including cash bonuses, as defined by the plan document, subject to IRS regulations. The Plan allows participants age 50 years by the end of the plan year and older to make additional salary deferrals (referred to as employee catch-up contributions), subject to IRC limitations, which was \$7,500 in 2024 and 2023, respectively.

Firm matching contribution - The Firm makes matching contributions equal to 50% of a participant's salary deferral contribution up to 5% of a participant's compensation.

Firm profit sharing and safe harbor contribution - The amount contributed each year is determined at the Firm's discretion, as defined by the plan document.

The Firm's aggregate matching, safe harbor, and profit sharing contributions net of forfeitures were \$2,195,674 and \$2,140,305 for 2024 and 2023, respectively, and are recorded as receivables on the accompanying Statements of Net Assets Available for Benefits. The employer contribution consisted of \$450,434 matching, \$682,685 safe harbor, and \$1,062,555 profit sharing in 2024. The employer contribution consisted of \$444,594 matching, \$651,689 safe harbor, and \$1,044,022 profit sharing in 2023.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Participants self-direct the investment of all contributions into various investment options available through the Trustee. All contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Firm's contributions and (b) the Plan's earnings and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances as defined by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully vested in their contributions plus actual earnings thereon and the Firm's matching and safe harbor contributions plus actual earnings thereon at all times. Vesting in the Firm's discretionary profit sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants become 20% vested after two years of service with vesting incrementally increased by 20% each year until 100% vested after six years of service.

Forfeiture Accounts

When certain terminations in the Plan occur, the nonvested portions of the participants' accounts, as defined, represent a forfeiture. Forfeitures from nonvested participant accounts are first used to restore account balances of any reemployed terminated participants and any remaining amounts may be used to reduce the Firm's contributions. During the years ended December 31, 2024 and 2023, forfeitures in the amount of \$851 and \$6,491, respectively, were used to reduce the Firm's contributions. Forfeited nonvested account balances were zero at December 31, 2024 and 2023.

Payment of Benefits

Upon termination of service for any reason, participants or their beneficiaries will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Additionally, under certain circumstances of financial hardship, the participant is permitted to withdraw funds from the Plan. The Plan also allows for in-service withdrawals.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may have up to two notes outstanding at any given time. Note terms range from 1 to 5 years or up to 30 years for the purchase of a primary residence. The notes are secured by the vested balance in the participant's account and bear interest at a rate commensurate with the rate charged by other lenders for similar loans as determined quarterly by the plan administrator at the inception of the note. Interest rates range from 3.25% to 8.50% on borrowings outstanding at December 31, 2024. Principal and interest is paid ratably through biweekly or semi-monthly payroll deductions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and Trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Firm. Expenses that are paid by the Firm are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Recent Regulatory Update

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

Subsequent Events

The Plan has evaluated subsequent events for recognition or disclosure through October 14, 2025, the date the financial statements were available to be issued.

3. Information Certified by Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Fidelity Management Trust Company, the current Trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statement of Net Assets Available for Benefits and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the period from December 2, 2024 through December 31, 2024. Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the previous Trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statement of Net Assets Available for Benefits as of December 31, 2023, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the period from January 1, 2024 through December 1, 2024 and for the year ended December 31, 2023. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage account consists of common stock and mutual funds which are valued at the closing price reported in the active market on which the securities are sold and on the daily published NAV on their deemed active markets, respectively.

The common collective trust fund is valued at the NAV of units of a bank collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Unit values of the common collective trust are based on the fair value of the underlying assets of the fund derived from inputs principally based on quoted market prices in an active market or corroborated by observable market data by correlation or other means.

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances in the amounts reported in the Statements of Net Assets Available for Benefits.

As of December 31, 2024 and 2023, the Plan had investments of \$23,240,742 and \$27,297,692, respectively, which were concentrated in two and three funds, respectively.

6. Related-Party and Party in Interest Transactions

One of the Plan's investments is managed by the Trustee, and therefore, the transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment manager services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. Additionally, the Plan issues notes to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Firm. No such officer or employee receives compensation from the Plan.

7. Plan Termination

Although it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their Firm contributions. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Firm may determine.

8. Tax Status

The IRS has determined and informed the Firm by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
