## **INDEPENDENT AUDITOR'S REPORT**

To the Administrator of the

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Destination 770 Auto, Inc. Savings & Security Plan DBA Destination Nissan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**NOTE 1 — DESCRIPTION OF PLAN**

Pamal Broadcasting, Ltd. established a defined contribution 401(k) retirement plan, currently known as the Destination 770 Auto, Inc. Savings & Security Plan DBA Destination Nissan (the “Plan”) effective April 1, 1990. Effective January 1, 2015, the Plan Administrator became Destination 770 Auto, Inc. DBA Destination Nissan (the Company). The Plan was established for the benefit of eligible employees, and the eligible employees of certain companies under common ownership, who have satisfied the Plan’s eligibility requirements. The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering all employees of the Company, and certain companies under common control. Employees are eligible to participate in the Plan if they are age twenty-one or older and have completed one year of entry service (which is defined as 1,000 or more hours of service). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Contributions**

Each year, participants may contribute pretax annual compensation as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). Participants direct the investment of their and Company matching contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Company will make a matching contribution equal to 33% of participant’s elective deferrals, up to 6% of compensation. The matching contribution will not exceed \$1,000 per participant per plan year. The Company may also make discretionary contributions each year based on an allocation of each eligible participant’s compensation to the total compensation of all the eligible participants for the year. Contributions are subject to certain limitations Internal Revenue Service (IRS) limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, Company matching contributions, and allocations of the Company discretionary non-elective contributions, as well as allocations of investment earnings and administrative expenses. Allocations of investment earnings and administrative expenses are based on a participant’s account balance relative to the total account balance of all participants in the same investment. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in matching contributions and discretionary contributions plus actual earnings or losses thereon is based on years of continuous service. A participant is one hundred percent vested after six years of credited service or on termination of service due to death, normal retirement, early retirement, disability, or plan termination.

**Notes Receivable from Participants**

Participants may borrow from their accounts, a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. All loans must be repaid in equal payments on at least a quarterly basis over a five-year period unless the loan is for the purchase of a principal residence in which case the loan may be repaid over the repayment period currently in effect for a commercial home loan. Loans are secured by the balance of a participant's vested account and bear interest at a rate commensurate with market rates.

**Payment of Benefits**

On termination of service due to retirement, death or disability, a participant may elect to receive one of the following: a lump-sum amount equal to the value of the participant's vested interest in his or her account, flexible income payments, or an annuity covering a five to fifteen year period over the life of the participant and/or the designated beneficiary. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. For terminated participants with a vested account balance less than \$5,000, the Plan administrator will make a distribution in a lump-sum amount. Participants with a vested account balance greater than \$5,000 may defer payment of benefits until a later date.

Withdrawals from a participant's salary deferral account (excluding earnings) may also be made in the event of a financial hardship, in accordance with the provisions specified in the Plan. Withdrawals from a participant's accounts may also be made upon reaching age 59½, in accordance with the provisions specified in the Plan.

**Forfeited Accounts**

At December 31, 2024 and 2023, unapplied forfeited non-vested balances were \$5,723 and \$565. These accounts may be used to fund future employer contributions or to reduce administrative expenses. During the year ended December 31, 2024, employer contributions were reduced by \$25,902 from forfeited non-vested accounts and forfeitures were used to reduce \$2 of administrative expenses.

**NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Presentation**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES** (Continued)

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and trustees.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to participant accounts and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Reclassification**

Certain prior year amounts have been reclassified to conform with the current year presentation.

**Subsequent Events**

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

**NOTE 3 — FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of fair value hierarchy are described as follows:

Level 1 inputs consist of unadjusted quoted prices in active markets, that the Plan has the ability to access, for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices of identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or 2 were not available.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**NOTE 3 — FAIR VALUE MEASUREMENTS (Continued)**

The following is a description of the valuation methodologies used for assets measured at fair value.

- **Mutual Funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- **Collective Investment Trusts (CIT):** Investment in collective trust funds as well as a variety of separate accounts and mutual funds. Unit value is calculated based on the NAV of the CIT. The NAV is not a publicly quoted price but is available to current investors on daily basis. The NAV is computed in accordance with investment company measurement principles based on the underlying assets.
- **Pooled Separate Account:** Represent an investment in participation units held in pooled separate accounts through sub accounts of an insurance company. The pooled separate account is primarily invested in mutual funds listed on the national securities exchanges and are valued daily at the unit value of shares held by the Plan in the separate investment account based on the underlying mutual funds and their quoted net asset value (NAV), which is an observable input. The Plan has concluded that the NAV as adjusted (for mutual fund dividends, mutual fund splits and administrative maintenance charges and other items) and reported by the insurance company, denotes readily determinable fair value.

**NOTE 4 — INFORMATION CERTIFIED BY THE TRUSTEES AND CUSTODIANS**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company, Principal Global Investors Trust Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the trustees and custodians of the Plan, has furnished certain financial information to the Plan administrator and certified as to its completeness and accuracy. These certifications are as of December 31, 2024 and 2023 and for the year ended December 31, 2024, and include investment information related to fair value of investments, notes receivable from participants, interest and dividend income, interest income on notes receivable from participants and net appreciation in fair value of investments that are included in the Plan's financial statements and supplemental schedule.

**NOTE 5 — RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The trustee of the Plan owns one hundred percent of the Companies participating in the Plan. Officers or employees of the Company perform certain administrative functions of the Plan.

Certain Plan investments are managed by Principal, Principal Global and Principal Trust. Principal, Principal Global and Principal Trust are the trustees, recordkeepers and custodians for the Plan and, therefore, these transactions qualify as party in interest transactions.

**NOTE 6 — PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become 100% vested in their employer contributions.

**NOTE 7 — TAX STATUS**

The Plan has been designed using a volume submitter prototype plan document designed by Principal. The Plan obtained its opinion determination letter dated June 30, 2020 in which the Internal Revenue Service stated that the Plan and the related trust established under the Plan are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 — RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 9 — DELINQUENT PARTICIPANT CONTRIBUTIONS**

The Company did not timely remit certain participant contributions totaling \$20,172 during the year ended December 31, 2024. This is deemed to be a prohibited transaction in accordance with ERISA and the IRC. The Company calculated lost earnings on these delinquent remittances and made the appropriate corrective contributions in October 2025.
