**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the **Employee Benefit Plan of Bid Group Holdings (US) Inc.** (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

#### **Note 1. Description of Plan**

The following description of the Employee Benefit Plan of Bid Group Holdings (US) Inc. (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

#### General

The Plan is a defined contribution plan that was adopted, effective July 1, 2018, covering all employees of Bid Group Holdings (US) Inc. and members of a controlled group of businesses under common control or ownership (collectively, the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA) of 1974.

#### Plan amendments

Effective July 1, 2024, the Plan was amended and restated to reflect the change in the Plan's trustee to Fidelity Management Trust Company.

Effective April 1, 2023, the Smith Sawmill Service (BID) US, Inc. 401(k) Plan merged with the Plan. The transfer of assets of \$1,437,952 is reported on the accompanying statements of changes in net assets available for benefits.

The Setting Every Community Up for Retirement Enhancement (SECURE) 2.0 Act of 2022 was enacted to enhance retirement savings opportunities and improve retirement plan administration in the United States. The Act provides a broad range of mandatory and optional provisions affecting retirement plans, including increasing participation, improving portability of retirement savings, and expanding penalty-free withdrawal options for certain circumstances. Plan sponsors may elect to adopt certain provisions voluntarily before their mandatory effective dates. For the year ended 2024, the Plan adopted the following voluntary provision under the SECURE 2.0 Act:

- **Mandatory distributions:** The automatic cash-out threshold for former participants' account balances was increased from \$5,000 to \$7,000, as permitted by the Act.

#### Eligibility and participation

An employee of the Company is eligible to participate in the Plan if he or she has completed 90 days of service, had attained age 18, is not covered by a collective bargaining agreement, is not a non-resident alien, and is not a leased employee.

Plan entry dates are the first day of January, April, July, and October of each year.

#### Administration

The Company is the Plan Administrator. Through June 30, 2024, the organizations involved in the administration of the Plan are as follows: Mutual of America Life Insurance Company served as recordkeeper and investment manager for the Plan; Mid Atlantic Trust Company served as the custodian and the Plan's directed trustee. Effective July 1, 2024, the Plan entered into an agreement with Fidelity Investments to serve as the Plan's recordkeeper and custodian. All plan assets were transferred from Mutual of America to Fidelity Investments on July 1, 2024.

#### **Note 1. Description of Plan (Continued)**

##### Contributions

Each year participants may contribute a percentage of their annual compensation as defined by the Plan, subject to the limitations as defined in the Internal Revenue Code (IRC). Eligible employees may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). The Company has adopted safe harbor matching provisions. Under these provisions, the Company contributes safe harbor matching contributions equal to 100% of contributions made by a participant that do not exceed 4% of the participant's compensation. The Company made safe harbor matching contributions of approximately \$1,084,000 and \$1,300,000 for the years ended December 31, 2024 and 2023, respectively.

The Company may also make discretionary qualified non-elective contributions to satisfy the nondiscrimination testing described in the IRC. Qualified non-elective contributions are allocated to all participants who are non-highly compensated employees. In order to receive an allocation of the qualified non-elective contribution for the Plan year, an employee must have completed at least 1,000 hours of service during the plan year and be employed on the last day of the plan year. The Company made no qualified non-elective contributions to the Plan for the years ended December 31, 2024 and 2023.

The Company may also make discretionary employer profit sharing contributions. In order to receive an allocation of the employer profit sharing contribution for a plan year, an employee must have completed at least 1,000 hours of service during the plan year and be employed on the last day of the plan year. The employer profit sharing contribution will be allocated based on the ratio that a participant's compensation bears to the total compensation of all eligible participants. The Company made no discretionary profit-sharing contributions to the Plan for the years ended December 31, 2024 and 2023.

##### Participant accounts

Individual accounts are maintained for each participant to reflect the participant's contributions, related Company matching contributions, the Company's additional qualified non-elective contributions, any Company additional discretionary profit-sharing contributions, plan earnings, and the allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Investment options

Upon enrollment in the Plan, participants may direct their contributions, the Company's safe harbor matching contributions, additional discretionary qualified non-elective contributions, and additional profit-sharing contributions, if any, into various investment options offered by the Plan. Participants may change their investment options at any time.

##### Participant notes receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in participant accounts and accrue interest at 4.25% to 9.5% which represents the rate similar to the rates charged for loans made under similar circumstances by persons in the business of lending money. Principal and interest are paid ratably through payroll deductions.

#### **Note 1. Description of Plan (Continued)**

##### Vesting

Each participant is always 100% vested in his or her elective deferrals account, qualified non-elective contribution account, and the safe-harbor employer matching contributions plus actual earning thereon. Vesting in the Company's discretionary employer profit sharing contributions is based on years of service. A participant is 20% vested after the second year of service and thereafter is vested on a graduated basis until the completion of six years of continuous service. A participant also becomes 100% vested in the employer discretionary profit-sharing contribution account and matching contribution account at normal retirement age, upon death, or in the case of total and permanent disability.

##### Forfeitures

Amounts treated as forfeitures under the Plan will first be used to pay administrative expenses. Any remaining amounts will be used to reduce future Employer contributions payable under the Plan.

At December 31, 2024 and 2023, forfeited balances of terminated participant's non-vested accounts and earnings thereon totaled \$92,104 and \$198,662, respectively. During the year ended December 31, 2024, \$266,881 of Company forfeited matching contributions were used to pay expenses and reduce employer matching contributions.

##### Withdrawal and payment of benefits

On termination of service, if a participant's vested account balance does not exceed \$1,000 (excluding rollover contributions and earnings thereon), the Plan will automatically distribute the participant's vested account balance in a lump sum. If his or her vested account balance exceeds \$1,000 but is less than \$7,000 (\$5,000 prior to 2024) (excluding rollover contributions and earnings thereon), a participant may elect to receive a single lump sum or roll over the vested balance into an individual retirement account (IRA) or another qualified plan. However, if no election is made by the participant, the Plan will automatically roll over the vested balance into an IRA as designated by plan management. If his or her balance exceeds \$7,000 (\$5,000 prior to 2024) (excluding rollover contributions and earnings thereon), a participant may leave his or her balance in the Plan or elect to receive the value of the participant's vested interest in his or her account in the form of a single lump sum, partial payments, or roll over the vested balance into an IRA or other qualified plan.

Prior to termination of employment, a participant's elective deferrals account and employer safe-harbor matching contribution account may be withdrawn upon attainment of age 59½. A participant's employer profit sharing contribution account, qualified non-elective contribution account, and matching contribution account may be withdrawn, if fully vested, upon attainment of age 59½.

Prior to termination of employment, a participant's elective deferrals account may be withdrawn upon the hardship of the participant as defined by the Plan, but not in excess of the amount necessary to meet the hardship.

#### **Note 2. Summary of Significant Accounting Policies**

##### Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could materially differ from those estimates.

Contributions

Employee contributions and Company matching contributions are recorded in the period during which the Company makes payroll deductions from the participant's earnings.

The Company's additional discretionary non-elective contributions are accrued and paid based on amounts to be funded for each year under the Plan provisions and the applicable requirements of the IRC.

The Company's additional discretionary profit-sharing contributions are accrued and paid based on amounts to be funded for each year under the Plan provisions and the applicable requirements of the IRC.

Investment valuation and income recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determined the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis; interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in registered investment companies are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reported as a reduction of investment returns for such investments.

Payment of benefits

Benefits are recorded when paid.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for doubtful accounts had been recorded as of December 31, 2024 and 2023. If a participant ceases to make repayments and the Plan Administrator deems the participant note receivable to be in default, the participant note receivable balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

##### Administrative expenses

Personnel within the Company perform many administrative duties of the Plan, including maintenance of personnel files and reconciliation of payroll records, at no charge to the Plan. Certain administrative expenses are paid by the Company; other administrative expenses are paid from the Plan and charged to the individual participant's accounts.

##### Reclassifications

Certain amounts reported in 2023 were reclassified to conform to the 2024 presentation. There was no change to net assets available for benefits or the change in those net assets as previously reported.

#### **Note 3. Information Prepared and Certified by Custodian and Recordkeeper**

Certain information disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at December 31, 2024, and net appreciation (depreciation) in fair value of investments, interest, and dividends for the period July 1, 2024, through December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company.

Certain information related to investments disclosed in the accompanying financial statements, including investments and notes receivable held at December 31, 2023, and net appreciation in fair value of investments, interest, and dividends for the year ended December 31, 2023, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Mid Atlantic Trust Company as custodian of the Plan.

#### **Note 4. Fair Value Measurements**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
  - If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

- *Shares of registered investment companies (mutual funds):* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- *Stable value common collective trust fund:* A collective trust fund that is composed primarily of fully benefit-responsive investment contracts that are valued at the net asset value of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner.
- *Money market funds:* Stated using amortized cost which approximates fair value.

**Note 5. Income Tax Status**

Beginning July 1, 2024, the Plan is a prototype plan of Fidelity Management and Research Company. A determination letter has been received from the Internal Revenue Service (IRS) indicating that the prototype plan is a qualified plan under Section 401 of the IRC and is exempt from federal income tax. Although the prototype plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax exempt.

Prior to July 1, 2024 the Plan adopted a pre-approved non-standardized profit-sharing plan. The provider, Mutual of America Life Insurance Company, received an opinion letter for its non-standardized profit-sharing plan from the Internal Revenue Service (IRS) dated April 2, 2012, stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code (the Code) and therefore is exempt from taxation. Once qualified, the Plan is required to operate in compliance with the Code to maintain its qualification. The Plan administrator believes that the Plan is being operated in compliance with applicable requirements of the Code and therefore believes that the Plan is qualified and is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6. Plan Termination**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note 7. Risks and Uncertainties**

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.

**Note 8. Party-In-Interest Transactions**

Beginning July 1, 2024, certain administrative expenses relating to the maintenance of participant eligibility records are paid by the Company and will not be reimbursed by the Plan. Fidelity Management Trust Company, the third-party administrator for the Plan, assists the Company with selecting investments and monitoring investment results. Therefore, investment transactions qualify as party-in-interest transactions. Recordkeeping and investment fees paid by the Plan to Fidelity Management Trust Company were \$34,005 in 2024.

Prior to July 1, 2024, the recordkeeper and investment advisor, Mutual of America, assisted the Company with selecting investments and monitoring investment results. Therefore, investment transactions qualify as party-in-interest transactions. The trustee may receive revenue shared by certain mutual companies based on the dollar amount of assets or number of participant accounts invested in the fund. These fees are included in the net appreciation in fair value of the investment as they were paid through revenue sharing rather than a direct payment. Therefore, investment transactions qualify as party-in-interest transactions. Investment fees and administrative fees paid by the Plan were \$58,519 for the year ended December 31, 2024, and \$187,230 for the year ended December 31, 2023.

All of these party-in-interest transactions are exempt from the prohibited transaction rules under ERISA.

**Note 9. Subsequent Events**

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued. There were no subsequent events requiring disclosure as of this date.
