## Independent Auditors' Report

### The Plan Administrator of Shed NYC, Inc. 403(b) Plan

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

***Auditors' Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentation, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgement made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

### **1. Description of Plan**

The following brief description of the Shed NYC, Inc. 403(b) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Summary Plan Description or the current Plan document for a complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan covering all eligible employees of Shed NYC, Inc. (the "Employer"). Employees are eligible to participate in the Plan if they normally work more than 20 hours a week. Employees (excluding union employees) are eligible to receive Employer contributions upon completion of 1 year of service and attainment of 18 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### ***Contributions***

Each year, eligible employees may contribute up to 100% of their eligible compensation on a pre-tax or Roth basis, as defined in the Plan, subject to certain Internal Revenue Code ("IRC") limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions (rollovers) from another qualified plan.

The Employer, at their discretion, may make matching contributions and/or discretionary non-elective profit sharing contributions to the Plan. For the 2024 Plan year, the Employer did not make any matching contributions or discretionary non-elective profit sharing contributions to the Plan.

#### ***Participants' Accounts***

Each participant's account is credited with the participant's contribution and allocations of (a) the Employer's contribution and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments are participant directed.

#### ***Vesting***

Participants are immediately vested in all contributions types at all times.

#### ***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum amount of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested balance. The loans are secured by the participant's vested account balance and bear interest at the prime rate plus 1%. A participant may only have 1 loan outstanding at any given time. Loan repayments must be made through payroll deductions over a term not to exceed 5 years unless the proceeds of the loan are used to purchase the participant's principal residence, in which case the term is not to exceed 15 years. Principal and interest is paid ratably through periodic payroll deductions.

### 1. Description of Plan *(continued)*

#### ***Payment of Benefits***

Upon termination of service due to death, disability, retirement or separation from service, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Withdrawals from the Plan may also be granted based upon circumstances of financial hardship or after attaining age 59 1/2, in accordance with provisions specified in the Plan.

#### ***Expenses***

Certain expenses of maintaining the Plan are paid by the Employer and are excluded from these financial statements. Investment related expenses are paid by the Plan and are included in net appreciation in fair value of investments.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Presentation and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. As of December 31, 2024 and 2023, all of the Plan assets were valued using level 1 inputs.

#### ***Investment Valuation and Income Recognition***

All of the Plan's investments were stated at fair value. The mutual funds were valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that are registered with the Securities and Exchange Commission and are deemed actively traded. These funds were required to publish their daily NAV and to transact at that price.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recognized on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **2. Summary of Significant Accounting Policies (*continued*)**

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus unpaid accrued interest. The Plan considers a note to be in default at the end of the quarter following the quarter when payments have not been received. Defaulted notes are deemed distributed and recorded as benefits paid to participants in the statements of changes in net assets available for benefits when a distributable event occurs.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 15, 2025.

### **3. Information Certified (Unaudited)**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and the net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus LLC, as agent for Ascensus Trust Company.

### **4. Tax Status**

The Plan is based on a Volume Submitter 403(b) Plan for Alliant Insurance Services, Inc, which received an opinion letter from the Internal Revenue Service (“IRS”) dated March 31, 2017 stating that the Volume Submitter 403(b) was designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

### **5. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

### **6. Party-in-Interest Transactions**

All investments of the Plan are managed by Vanguard Group, Inc. Vanguard Group, Inc. has entered into an agreement with Ascensus, LLC., to provide certain plan recordkeeping and administrative services on its behalf. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA.

Certain employees of the Employer, who may be participants in the Plan, perform administrative services to the Plan at no cost to the Plan.

### **7. Prohibited Transactions**

During 2023, the Employer failed to remit to the Plan certain participants' contributions and loan repayments totaling \$16,077 within the period prescribed by Department of Labor regulations. Although certain participants' contributions and loan repayments were determined to be delinquent, they were remitted to the Plan within 30 days of the payroll date. Lost earnings were calculated and allocated to the affected participants in the Plan by the Employer in November of 2024 for the 2023 contributions and loan repayments.

### **8. Risks and Uncertainties**

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
